

## 99TH GENERAL ASSEMBLY State of Illinois 2015 and 2016 SB2415

Introduced 2/9/2016, by Sen. William R. Haine

## SYNOPSIS AS INTRODUCED:

410 ILCS 535/25.5

Amends the Vital Records Act. Removes language denoting allocations to local county coroners and medical examiners or specified officials from the Death Certificate Surcharge Fund as grants. Provides that officials receiving distributions from the Death Certificate Surcharge Fund must submit letters of verification to the Department of Public Health indicating that funds received from the Fund were used as prescribed. Provides that officials failing to provide a letter of verification will be ineligible to receive distributions from the Death Certificate Surcharge Fund for the following 3 years unless a suitable letter of verification is submitted. Effective immediately.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Vital Records Act is amended by changing Section 25.5 as follows:
- 6 (410 ILCS 535/25.5)

7 25.5. Death Certificate Surcharge Fund. The 8 additional \$2 fee for certified copies of death certificates 9 and fetal death certificates must be deposited into the Death Certificate Surcharge Fund, a special fund created in the State 10 treasury. Beginning 30 days after the effective date of this 11 amendatory Act of the 92nd General Assembly and until January 12 1, 2003 and then beginning again on July 1, 2003 and until July 13 14 1, 2005, moneys in the Fund, subject to appropriation, may be used by the Department for the purpose of implementing an 15 16 electronic reporting system for death registrations provided in Section 18.5 of this Act. Before the effective date 17 of this amendatory Act of the 92nd General Assembly, on and 18 19 after January 1, 2003 and until July 1, 2003, and on and after July 1, 2005, moneys in the Fund, subject to appropriations, 20 21 may be used as follows: (i) 25% by the Coroner Training Board 22 for the purpose of training coroners, deputy coroners, forensic pathologists, and police officers for death investigations and 23

lodging and travel expenses relating to training, (ii) 25% for 1 2 grants by the Department of Public Health for distribution to all local county coroners and medical examiners or officials 3 charged with the duties set forth under Division 3-3 of the 4 5 Counties Code, who have a different title, for equipment and lab facilities, (iii) 25% by the Department of Public Health 6 7 for the purpose of setting up a statewide database of death certificates and implementing an electronic reporting system 8 9 for death registrations pursuant to Section 18.5, and (iv) 25% 10 for <u>distribution</u> a grant by the Department of Public Health to 11 local registrars. Officials receiving distributions from the 12 Department of Public Health shall submit a letter of 13 verification to the Department indicating that funds received 14 under this Section were used as prescribed in this Section. Officials receiving distributions from the Department of 15 16 Public Health that fail to provide the letter of verification 17 shall be ineligible for distributions for the following 3 consecutive years unless a suitable letter of verification is 18 19 provided to the Department.

21 Section 99. Effective date. This Act takes effect upon 22 becoming law.
