- 4 Section 15. The Director of Natural Resources shall obtain 5 a certified copy of the portions of this Act containing the title, the enacting clause, the effective date, the appropriate 6 7 Section or Sections containing the land descriptions of the 8 property to be conveyed, and this Section within 60 days after 9 its effective date and, upon receipt of the payment required by the Section or Sections, if any payment is required, shall 10 record the certified document in the Recorder's Office in the 11
- 13 Section 99. Effective date. This Act takes effect upon 14 becoming law.".
