SYNOPSIS AS INTRODUCED:

105 ILCS 5/3-15.12

from Ch. 122, par. 3-15.12

Amends the School Code. With respect to the High School Equivalency Testing Program, requires a regional superintendent of schools to waive required fees for an applicant who (i) qualifies as a homeless person, child, or youth as defined in the Education for Homeless Children Act, (ii) has not attained 25 years of age as of the date of the scheduled test, and (iii) can verify his or her status as a homeless person, child, or youth. Provides that a homeless services provider that is qualified to verify an individual's housing status, as determined by the Illinois Community College Board, and that has knowledge of the applicant's housing status may verify the applicant's status.

AN ACT concerning education.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The School Code is amended by changing Section
3-15.12 as follows:

6 (105 ILCS 5/3-15.12) (from Ch. 122, par. 3-15.12)

7 Sec. 3-15.12. High school equivalency testing program. The regional superintendent of schools shall make available for 8 9 qualified individuals residing within the region a High School 10 Equivalency Testing Program. For that purpose the regional superintendent alone or with other regional superintendents 11 may establish and supervise a testing center or centers to 12 administer the secure forms for high school equivalency testing 13 14 to qualified persons. Such centers shall be under the supervision of the regional superintendent in whose region such 15 16 centers are located, subject to the approval of the Executive Director of the Illinois Community College Board. 17

An individual is eligible to apply to the regional superintendent of schools for the region in which he or she resides if he or she is: (a) a person who is 17 years of age or older, has maintained residence in the State of Illinois, and is not a high school graduate; (b) a person who is successfully completing an alternative education program under Section

1 2-3.81, Article 13A, or Article 13B; or (c) a person who is 2 enrolled in a youth education program sponsored by the Illinois 3 National Guard. For purposes of this Section, residence is that abode which the applicant considers his or her home. Applicants 4 5 may provide as sufficient proof of such residence and as an 6 acceptable form of identification a driver's license, valid 7 passport, military ID, or other form of government-issued 8 national or foreign identification that shows the applicant's 9 name, address, date of birth, signature, and photograph or 10 other acceptable identification as may be allowed by law or as 11 regulated by the Illinois Community College Board. Such 12 regional superintendent shall determine if the applicant meets 13 statutory and regulatory state standards. If gualified the 14 applicant shall at the time of such application pay a fee 15 established by the Illinois Community College Board, which fee 16 shall be paid into a special fund under the control and 17 supervision of the regional superintendent. Such moneys received by the regional superintendent shall be used, first, 18 for the expenses incurred in administering and scoring the 19 examination, and next for other educational programs that are 20 developed and designed by the regional superintendent of 21 22 schools to assist those who successfully complete high school 23 equivalency testing in furthering their academic development or their ability to secure and retain gainful employment, 24 25 including programs for the competitive award based on test 26 scores of college or adult education scholarship grants or

similar educational incentives. Any excess moneys shall be paid
 into the institute fund.

3 Any applicant who has achieved the minimum passing standards as established by the Illinois Community College 4 5 Board shall be notified in writing by the regional superintendent and shall be issued a high school equivalency 6 certificate on the forms provided by the Illinois Community 7 8 College Board. The regional superintendent shall then certify 9 to the Illinois Community College Board the score of the 10 applicant and such other and additional information that may be 11 required by the Illinois Community College Board. The moneys 12 received therefrom shall be used in the same manner as provided 13 for in this Section.

Any applicant who has attained the age of 17 years and 14 15 maintained residence in the State of Illinois and is not a high 16 school graduate, any person who has enrolled in a youth 17 education program sponsored by the Illinois National Guard, or any person who has successfully completed an alternative 18 education program under Section 2-3.81, Article 13A, or Article 19 13B is eligible to apply for a high school equivalency 20 certificate (if he or she meets the requirements prescribed by 21 22 the Illinois Community College Board) upon showing evidence 23 that he or she has completed, successfully, high school equivalency testing, administered by the United States Armed 24 Forces Institute, official high school equivalency testing 25 26 centers established in other states, Veterans' Administration

1 Hospitals, or the office of the State Superintendent of 2 Education for the Illinois State Penitentiary System and the 3 Department of Corrections. Such applicant shall apply to the regional superintendent of the region wherein he or she has 4 5 maintained residence, and, upon payment of a fee established by 6 regional the Illinois Community College Board, the 7 shall issue а high school equivalency superintendent 8 certificate and immediately thereafter certify to the Illinois 9 Community College Board the score of the applicant and such 10 other and additional information as may be required by the 11 Illinois Community College Board.

12 Notwithstanding the provisions of this Section, any 13 applicant who has been out of school for at least one year may request the regional superintendent of schools to administer 14 15 restricted high school equivalency testing upon written 16 request of: the director of a program who certifies to the 17 Chief Examiner of an official high school equivalency testing center that the applicant has completed a program of 18 instruction provided by such agencies as the Job Corps, the 19 20 Postal Service Academy, or an apprenticeship training program; 21 an employer or program director for purposes of entry into 22 apprenticeship programs; another state's department of 23 education in order to meet regulations established by that department of education; or a post high school educational 24 25 institution for purposes of admission, the Department of 26 Financial and Professional Regulation for licensing purposes,

or the Armed Forces for induction purposes. The regional superintendent shall administer such testing, and the applicant shall be notified in writing that he or she is eligible to receive a high school equivalency certificate upon reaching age 17, provided he or she meets the standards established by the Illinois Community College Board.

7 Any test administered under this Section to an applicant who does not speak and understand English may at the discretion 8 9 of the administering agency be given and answered in any 10 language in which the test is printed. The regional 11 superintendent of schools may waive any fees required by this 12 Section in case of hardship. The regional superintendent of 13 schools shall waive any fees required by this Section for an 14 applicant who meets all of the following criteria:

15 (1) The applicant qualifies as a homeless person,
 16 child, or youth as defined in the Education for Homeless
 17 Children Act.

18 (2) The applicant has not attained 25 years of age as
19 of the date of the scheduled test.

20 <u>(3) The applicant can verify his or her status as a</u> 21 <u>homeless person, child, or youth. A homeless services</u> 22 <u>provider that is qualified to verify an individual's</u> 23 <u>housing status, as determined by the Illinois Community</u> 24 <u>College Board, and that has knowledge of the applicant's</u> 25 <u>housing status may verify the applicant's status for</u> 26 <u>purposes of this subdivision (3).</u>

1 In counties of over 3,000,000 population, a high school 2 equivalency certificate shall contain the signatures of the 3 Executive Director of the Illinois Community College Board and the superintendent, president, or other chief executive 4 5 officer of the institution where high school equivalency 6 testing instruction occurred and any other signatures 7 authorized by the Illinois Community College Board.

8 The regional superintendent of schools shall furnish the 9 Illinois Community College Board with any information that the 10 Illinois Community College Board requests with regard to 11 testing and certificates under this Section.
