2	AMENDMENT NO Amend Senate Bill 2882 by replacing
3	everything after the enacting clause with the following:
4	"Section 5. The Illinois Vehicle Code is amended by
5	changing Section 8-101 as follows:
6	(625 ILCS 5/8-101) (from Ch. 95 1/2, par. 8-101)
7	Sec. 8-101. Proof of financial responsibility - Persons who
8	operate motor vehicles in transportation of passengers for
9	hire.
10	(a) It is unlawful for any person, firm or corporation to
11	operate any motor vehicle along or upon any public street or
12	highway in any incorporated city, town or village in this State
13	for the carriage of passengers for hire, accepting and
14	discharging all such persons as may offer themselves for
15	transportation unless such person, firm or corporation has
16	given, and there is in full force and effect and on file with

the Secretary of State of Illinois, proof of financial
 responsibility provided in this Act.

3 (b) In addition this Section shall also apply to persons, 4 firms or corporations who are in the business of providing 5 transportation services for minors to or from educational or 6 recreational facilities, except that this Section shall not apply to public utilities subject to regulation under "An Act 7 concerning public utilities," approved June 29, 1921, as 8 9 amended, or to school buses which are operated by public or 10 parochial schools and are engaged solely in the transportation 11 of the pupils who attend such schools.

(c) This Section also applies to a contract carrier 12 13 transporting employees in the course of their employment on a 14 highway of this State in a vehicle designed to carry 15 or 15 fewer passengers. As part of proof of financial responsibility, 16 a contract carrier transporting employees, including but not limited to railroad employees, in the course of their 17 employment is required to verify hit and run and uninsured 18 motor vehicle coverage, as provided in Section 143a of the 19 20 Illinois Insurance Code, and underinsured motor vehicle coverage, as provided in Section 143a-2 of the Illinois 21 22 Insurance Code, in a total amount of not less than \$250,000 per 23 passenger, except that beginning on January 1, 2017 the total 24 amount shall be not less than \$500,000 per passenger.

commuter van, but only during the performance of activities
 authorized by the Ridesharing Arrangements Act.

3 (e) If the person operating such motor vehicle is not the 4 owner, then proof of financial responsibility filed hereunder 5 must provide that the owner is primarily liable.
