Makes appropriations for the ordinary and contingent expenses of the Department of Human Rights for the fiscal year beginning July 1, 2016, as follows:

A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The sum of \$9,029,800, or so much thereof as
6 may be necessary, is appropriated from the General Revenue
7 Fund to the Department of Human Rights for operational
8 expenses of the fiscal year ending June 30, 2017.

9 Section 5. The sum of \$100,000, or so much thereof as
10 may be necessary, is appropriated from the Department of
11 Human Rights Training and Development Fund to the Department
12 of Human Rights for the purpose of funding expenses
13 associated with administration.

14 Section 10. The following named sums, or so much thereof
15 as may be necessary, respectively, are appropriated from the
16 Special Projects Division Fund:

- 17 For Personal Services2,493,500
- 18 For State Contributions to State
- 19 Employees' Retirement System1,159,500
- 20 For State Contributions to Social Security190,700

2	For Contractual Services	177,000
3	For Travel	37,000
4	For Commodities	6,800
5	For Printing	9,300
6	For Equipment	0
7	For Telecommunications Services	<u>0</u>
8	Total	\$4,537,800

9 Section 15. The sum of \$978,200, or so much thereof as
10 may be necessary, is appropriated from the General Revenue
11 Fund to the Department of Human Rights for expenses relating
12 to the investigation and processing of human rights cases,
13 and expenses associated with Elementary and Higher Education
14 processing.

15 Section 20. The sum of \$500,000, or so much thereof as
16 may be necessary, is appropriated from the Department of
17 Human Rights Special Fund to the Department of Human Rights
18 for the purpose of funding expenses associated with the
19 Department of Human Rights.

20 Section 99. Effective Date. This Act takes effect July
21 1, 2016, if and only if Senate Bill 2789 of the 99th General
22 Assembly (the Unbalanced Budget Response Act), as introduced

1 in the Illinois Senate, becomes law.
