- Section 15. The amount of \$2,041,500, or so much thereof 4 5 as may be necessary, is appropriated from the Illinois Workers' Compensation Commission Operations Fund to Illinois 6 Workers' Compensation Commission for costs associated with 7 8 the establishment, administration and operations of 9 Insurance Compliance Division of the workers' compensation 10 anti-fraud program administered by Illinois 11 Compensation Commission.
- Section 20. The amount of \$60,000, or so much thereof as
 may be necessary, is appropriated from the Illinois Workers'
 Compensation Commission Operations Fund to Illinois Workers'
 Compensation Commission for costs associated with the
 establishment of the Medical Fee Schedule and other
 provisions of the Workers' Compensation Act.
- Section 99. Effective date. This Act takes effect July 1,
 2016, if and only if Senate Bill 2789 of the 99th General
 Assembly (the Unbalanced Budget Response Act), as introduced
 in the Illinois Senate, becomes law.
