A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much
6 thereof as may be necessary, respectively, are appropriated
7 for the ordinary and contingent expenses of the Office of the
8 State Fire Marshal, as follows:

20 Section 10. The sum of \$931,000, or so much thereof as
21 may be necessary, is appropriated from the Fire Prevention
22 Fund to the Office of the State Fire Marshal for costs and
23 expenses related to or in support of a public safety shared
24 services center.

1 Section 15. The sum of \$65,000, or so much thereof as
 2 may be necessary, is appropriated from the Fire Prevention
 3 Fund to the Office of the State Fire Marshal for costs and
 4 expenses related to or in support of the Fire Explorer and
 5 Cadet School.

6 Section 20. The sum of \$400,000, or so much thereof as
 7 may be necessary, is appropriated from the Illinois
 8 Firefighters' Memorial Fund to the Office of the State Fire
 9 Marshal for expenses related to the maintenance of the
 10 Illinois Firefighters' Memorial, holding the annual Fallen
 11 Firefighter Ceremony, and other expenses as allowed under
 12 Public Act 91-0832.

13 Section 25. The following named amounts, or so much
 14 thereof as may be necessary, respectively, are appropriated
 15 to the Office of the State Fire Marshal as follows:

16 Payable from the Fire Prevention Fund:

5 Section 30. The following named amounts, or so much
 6 thereof as may be necessary, respectively, are appropriated
 7 for the ordinary and contingent expenses of the Office of the
 8 State Fire Marshal, as follows:

10 Payable from the Fire Prevention Fund:
 11 For Chicago Fire Department Training Program2,689,600
 12 For payment to local governmental agencies
 13 which participate in the State Training
 14 Programs950,000
 15 Total \$3,639,600

16 Section 35. The sum of \$1,000, or so much thereof as may
 17 be necessary, is appropriated from the Fire Prevention Fund
 18 to the Office of the State Fire Marshal for grants available
 19 for the development of new fire districts.

20 Section 40. The sum of \$125,000, or so much thereof as
 21 may be necessary, is appropriated from the Fire Prevention
 22 Fund to the Office of the State Fire Marshal for grants

1 available for costs and services related to ILEAS/MABAS
2 administration.

3 Section 45. The sum of \$0, or so much thereof as may be
4 necessary, is appropriated from the Fire Prevention Fund to
5 the Office of the State Fire Marshal for deposit into the
6 Fire Truck Revolving Loan Fund.

7 Section 50. The sum of \$0, or so much thereof as may be
8 necessary, is appropriated from the Fire Prevention Fund to
9 the Office of the State Fire Marshal for grants for the Small
10 Equipment Grant Program.

11 Section 55. The sum of \$50,000, or so much thereof as
12 may be necessary, is appropriated from the Fire Prevention
13 Fund to the Office of the State Fire Marshal for a grant to
14 the Hazardous Materials Emergency Response Reimbursement.

15 Section 60. The sum of \$550,000, or so much thereof as
16 may be necessary, is appropriated from the Underground
17 Storage Tank Fund to the Office of the State Fire Marshal for
18 a grant to the City of Chicago for administrative costs
19 incurred as a result of the State's Underground Storage
20 Program.

1 Section 99. Effective date. This Act takes effect July 1,
2 2016, if and only if Senate Bill 2789 of the 99th General
3 Assembly (the Unbalanced Budget Response Act), as introduced
4 in the Illinois Senate, becomes law.
