# Be it enacted by the People of the State of Illinois, represented in the General Assembly:

#### 4 ARTICLE 1 Section 1. "Operational expenses" defined. For the 5 purposes of this Act, the term "operational expenses" 6 7 includes the following items: 8 (a) Personal Services; 9 (b) State contributions to Social Security (c) Group Insurances; 10 (d) Contractual Services 11 12 (e) Travel; 13 (f) Commodities; 14 (g) Printing; 15 (h) Equipment; (i) Electronic data processing; 16 17 (j) Telecommunications services; 18 (k) Operation of automotive equipment; 19 (1) Refunds; (m) Employee retirement contributions paid by the employer; 20 21 (n) Permanent improvements;

- Section 5. The sum of \$16,826,500, or so much thereof as
- 2 may be necessary, is appropriated from the General Revenue
- 3 Fund to the Board of Trustees of the University of Illinois
- 4 for costs and expenses related to or in support of the
- 5 Prairie Research Institute, in accordance with Public Act 95-
- 6 0728.
- 7 Section 10. The sum of \$45,000,000, or so much thereof
- 8 as may be necessary, is appropriated from the General Revenue
- 9 Fund to the Board of Trustees of the University of Illinois
- 10 for operating costs and expenses related to or in support of
- 11 the University of Illinois Hospital.
- 12 Section 15. The amount of \$455,922,500, or so much
- 13 thereof as may be necessary, is appropriated from the
- 14 Education Assistance Fund to the Board of Trustees of the
- 15 University of Illinois to meet its operational expenses for
- the fiscal year ending June 30, 2017.
- 17 Section 20. The sum of \$3,816,200, or so much thereof as
- 18 may be necessary, is appropriated from the Fire Prevention
- 19 Fund to the Board of Trustees of the University of Illinois
- 20 for the purpose of maintaining the Illinois Fire Service
- 21 Institute, paying the Institute's expenses, and providing the

- 1 facilities and structures incident thereto, including payment
- 2 to the University for personal services and related costs
- 3 incurred.
- 4 Section 25. The sum of \$250,000, or so much thereof as
- 5 may be necessary, is appropriated from the State College and
- 6 University Trust Fund to the Board of Trustees of the
- 7 University of Illinois for scholarship grant awards.
- 8 Section 30. The sum of \$200,000, or so much thereof as
- 9 may be necessary, is appropriated from the Emergency Public
- 10 Health Fund to the University of Illinois for costs and
- 11 expenses related to or in support of Emergency Mosquito
- 12 Abatement.
- 13 Section 35. The sum of \$200,000, or so much thereof as
- 14 may be necessary, is appropriated from the Used Tire
- 15 Management Fund to the University of Illinois for costs and
- 16 expenses related to or in support of mosquito research and
- 17 abatement.
- 18 Section 40. The sum of \$500,000, or so much thereof as
- 19 may be necessary, is appropriated from the Hazardous Waste
- 20 Research Fund to the University of Illinois for its ordinary
- 21 and contingent expenses.

- 1 Section 99. Effective date. This Act takes effect July 1,
- 2 2016, if and only if Senate Bill 2789 of the 99th General
- 3 Assembly (the Unbalanced Budget Response Act), as introduced
- 4 in the Illinois Senate, becomes law.
