## SENATE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT SC0021

Introduced 10/28/2015, by Sen. Jennifer Bertino-Tarrant

## SYNOPSIS AS INTRODUCED:

ILCON Art. IV, Sec. 6

Proposes to amend the Legislature Article of the Illinois Constitution. Limits a person's service in the office of Speaker of the House of Representatives, President of the Senate, Minority Leader of the House, or Minority Leader of the Senate to 8 years in any one office. Effective upon being declared adopted and applies to service on or after the second Wednesday in January, 2017.

## SENATE JOINT RESOLUTION 1 2 CONSTITUTIONAL AMENDMENT 3 RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL 4 ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES 5 CONCURRING HEREIN, that there shall be submitted to the 6 electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of 7 8 this resolution a proposition to amend Article IV of the 9 Illinois Constitution by changing Section 6 as follows: 10 ARTICLE IV 11 THE LEGISLATURE 12 (ILCON Art. IV, Sec. 6) 13 SECTION 6. ORGANIZATION 14 (a) A majority of the members elected to each house constitutes a quorum. 15 (b) On the first day of the January session of the General 16 17 Assembly in odd-numbered years, the Secretary of State shall 18 convene the House of Representatives to elect from its 19 membership a Speaker of the House of Representatives as 20 presiding officer, and the Governor shall convene the Senate to

elect from its membership a President of the Senate as

presiding officer. A person may serve no more than 8 years in

any one of the following offices: Speaker of the House of

- Representatives, President of the Senate, Minority Leader of 1
- the House of Representatives, or Minority Leader of the Senate; 2
- 3 provided that service before the second Wednesday in January of
- 2017 shall not be considered in the calculation of a person's 4
- 5 service.
- (c) For purposes of powers of appointment conferred by this 6
- 7 Constitution, the Minority Leader of either house is a member
- 8 of the numerically strongest political party other than the
- 9 party to which the Speaker or the President belongs, as the
- 10 case may be.
- 11 (d) Each house shall determine the rules  $\circ f$ its
- 12 proceedings, judge the elections, returns and qualifications
- 13 of its members and choose its officers. No member shall be
- expelled by either house, except by a vote of two-thirds of the 14
- 15 members elected to that house. A member may be expelled only
- 16 for the same offense. Each house may punish by
- 17 imprisonment any person, not a member, quilty of disrespect to
- the house by disorderly or contemptuous behavior in its 18
- presence. Imprisonment shall not extend beyond twenty-four 19
- 20 hours at one time unless the person persists in disorderly or
- contemptuous behavior. 21
