AN ACT to amend the Illinois Human Rights Act by changing Sections 1-102, 1-103, 3-103, and 3-106 and the heading of Article 1 and adding Section 1-101.1.

Be it enacted by the People of the State of Illinois,represented in the General Assembly:

6 Section 5. The Illinois Human Rights Act is amended by 7 changing Sections 1-102, 1-103, 3-103, and 3-106 and the 8 heading of Article 1 and adding Section 1-101.1 as follows:

9 (775 ILCS 5/Art. 1 heading)

10 ARTICLE 1. <u>GENERAL PROVISIONS</u> TITLE7-POLICY-AND-DEFINITIONS

11 (775 ILCS 5/1-101.1 new)

12 <u>Sec. 1-101.1. Construction. Nothing in this Act shall</u> 13 <u>be construed as requiring any employer, employment agency, or</u> 14 <u>labor organization to give preferential treatment or special</u> 15 <u>rights based on sexual orientation or to implement</u> 16 <u>affirmative action policies or programs based on sexual</u> 17 <u>orientation.</u>

19 Sec. 1-102. Declaration of Policy. It is the public 20 policy of this State:

(A) Freedom from Unlawful Discrimination. To secure for 21 all individuals within Illinois 22 the freedom from discrimination against any individual because of his or her 23 24 race, color, religion, sex, national origin, ancestry, age, 25 marital status, physical or mental handicap, military status, sexual orientation, or unfavorable discharge from military 26 27 service in connection with employment, real estate access to financial credit, and the transactions, 28 availability of public accommodations. 29

(B) Freedom from Sexual Harassment-Employment and Higher
 Education. To prevent sexual harassment in employment and
 sexual harassment in higher education.

4 (C) Freedom from Discrimination Based on Citizenship
5 Status-Employment. To prevent discrimination based on
6 citizenship status in employment.

7 (D) Freedom from Discrimination Based on Familial
8 Status-Real Estate Transactions. To prevent discrimination
9 based on familial status in real estate transactions.

10 (E) Public Health, Welfare and Safety. To promote the 11 public health, welfare and safety by protecting the interest 12 of all people in Illinois in maintaining personal dignity, in 13 realizing their full productive capacities, and in furthering 14 their interests, rights and privileges as citizens of this 15 State.

16 (F) Implementation of Constitutional Guarantees. To
17 secure and guarantee the rights established by Sections 17,
18 and 19 of Article I of the Illinois Constitution of 1970.

19 (G) Equal Opportunity, Affirmative Action. To establish Equal Opportunity and Affirmative Action as the policies of 20 21 this State in all of its decisions, programs and activities, 22 and to assure that all State departments, boards, commissions 23 and instrumentalities rigorously take affirmative action to provide equality of opportunity and eliminate the effects of 24 25 discrimination in the internal affairs of State past government and in their relations with the public. 26

(H) Unfounded Charges. To protect citizens of this State against unfounded charges of unlawful discrimination, sexual harassment in employment and sexual harassment in higher education, and discrimination based on citizenship status in employment.

Sec. 1-103. General Definitions. When used in this Act,
 unless the context requires otherwise, the term:

3 (A) Age. "Age" means the chronological age of a person 4 who is at least 40 years old, except with regard to any 5 practice described in Section 2-102, insofar as that practice 6 concerns training or apprenticeship programs. In the case of 7 training or apprenticeship programs, for the purposes of 8 Section 2-102, "age" means the chronological age of a person 9 who is 18 but not yet 40 years old.

10 (B) Aggrieved Party. "Aggrieved party" means a person 11 who is alleged or proved to have been injured by a civil 12 rights violation or believes he or she will be injured by a 13 civil rights violation under Article 3 that is about to 14 occur.

15 (C) Charge. "Charge" means an allegation filed with the
16 Department by an aggrieved party or initiated by the
17 Department under its authority.

(D) Civil Rights Violation. "Civil rights violation"
includes and shall be limited to only those specific acts set
forth in Sections 2-102, 2-103, 2-105, 3-102, 3-103, 3-104,
3-104.1, 3-105, 4-102, 4-103, 5-102, 5A-102 and 6-101 of this
Act.

(E) Commission. "Commission" means the Human RightsCommission created by this Act.

25 (F) Complaint. "Complaint" means the formal pleading 26 filed by the Department with the Commission following an 27 investigation and finding of substantial evidence of a civil 28 rights violation.

(G) Complainant. "Complainant" means a person including
the Department who files a charge of civil rights violation
with the Department or the Commission.

32 (H) Department. "Department" means the Department of33 Human Rights created by this Act.

34 (I) Handicap. "Handicap" means a determinable physical

or mental characteristic of a person, including, but not limited to, a determinable physical characteristic which necessitates the person's use of a guide, hearing or support dog, the history of such characteristic, or the perception of such characteristic by the person complained against, which may result from disease, injury, congenital condition of birth or functional disorder and which characteristic:

8 (1) For purposes of Article 2 is unrelated to the 9 person's ability to perform the duties of a particular 10 job or position and, pursuant to Section 2-104 of this 11 Act, a person's illegal use of drugs or alcohol is not a 12 handicap;

13 (2) For purposes of Article 3, is unrelated to the 14 person's ability to acquire, rent or maintain a housing 15 accommodation;

16 (3) For purposes of Article 4, is unrelated to a
17 person's ability to repay;

18 (4) For purposes of Article 5, is unrelated to a
19 person's ability to utilize and benefit from a place of
20 public accommodation.

(J) Marital Status. "Marital status" means the legal status of being married, single, separated, divorced or widowed.

24 (J-1) Military Status. "Military status" means a 25 person's status on active duty in the armed forces of the 26 United States.

(K) National Origin. "National origin" means the placein which a person or one of his or her ancestors was born.

(L) Person. "Person" includes one or more individuals, partnerships, associations or organizations, labor organizations, labor unions, joint apprenticeship committees, or union labor associations, corporations, the State of Illinois and its instrumentalities, political subdivisions, units of local government, legal representatives, trustees in

1 bankruptcy or receivers.

2 (M) Public Contract. "Public contract" includes every 3 contract to which the State, any of its political 4 subdivisions or any municipal corporation is a party.

5 (N) Religion. "Religion" includes all aspects of 6 religious observance and practice, as well as belief, except 7 that with respect to employers, for the purposes of Article 8 2, "religion" has the meaning ascribed to it in paragraph (F) 9 of Section 2-101.

(0) Sex. "Sex" means the status of being male or female. 10 11 (0-1) Sexual orientation. "Sexual orientation" means 12 having or being perceived as having an emotional, physical, 13 or sexual attraction to another person without regard to the sex of that person or having or being perceived as having an 14 15 orientation for such attraction, or having or being perceived as having a self-image or identity not traditionally 16 associated with one's biological maleness or femaleness. 17 "Sexual orientation" does not include a physical or sexual 18 19 attraction to a minor by an adult.

20 (P) Unfavorable Military Discharge. "Unfavorable 21 military discharge" includes discharges from the Armed Forces 22 of the United States, their Reserve components or any 23 National Guard or Naval Militia which are classified as RE-3 24 or the equivalent thereof, but does not include those 25 characterized as RE-4 or "Dishonorable".

(Q) Unlawful Discrimination. "Unlawful discrimination"
means discrimination against a person because of his or her
race, color, religion, national origin, ancestry, age, sex,
marital status, handicap, military status, <u>sexual</u>
<u>orientation</u>, or unfavorable discharge from military service
as those terms are defined in this Section.

Sec. 3-103. Blockbusting.) It is a civil rights
 violation for any person to:

(A) Solicitation. Solicit for sale, lease, listing or 3 4 purchase any residential real estate within this State, on grounds of loss of value due to the present or 5 the prospective entry into the vicinity of the property involved 6 7 any person or persons of any particular race, color, of 8 religion, national origin, ancestry, age, sex, <u>sexual</u> orientation, marital status, familial status or handicap. 9

(B) Statements. Distribute or cause to be distributed, 10 11 written material or statements designed to induce any owner of residential real estate in this State to sell or lease his 12 13 or her property because of any present or prospective changes in the race, color, religion, national origin, ancestry, age, 14 15 sex, sexual orientation, marital status, familial status or 16 handicap of residents in the vicinity of the property involved. 17

(C) Creating Alarm. Intentionally create alarm, among 18 residents of any community, by transmitting communications in 19 any manner, including a telephone call whether or not 20 21 conversation thereby ensues, with a design to induce any 22 owner of residential real estate in this state to sell or 23 lease his or her property because of any present or prospective entry into the vicinity of the property involved 24 25 of any person or persons of any particular race, color, religion, national origin, ancestry, age, sex, sexual 26 orientation, marital status, familial status or handicap. 27 (Source: P.A. 86-910.) 28

29 (775 ILCS 5/3-106) (from Ch. 68, par. 3-106) 30 Sec. 3-106. Exemptions.) Nothing contained in Section 31 3-102 shall prohibit:

32 (A) Private Sales of Single Family Homes. Any sale of a33 single family home by its owner so long as the following

1 criteria are met:

2 (1) The owner does not own or have a beneficial 3 interest in more than three single family homes at the 4 time of the sale;

5 (2) The owner or a member of his or her family was
6 the last current resident of the home;

7 (3) The home is sold without the use in any manner 8 of the sales or rental facilities or services of any real 9 estate broker or salesman, or of any employee or agent of 10 any real estate broker or salesman;

11 (4) The home is sold without the publication, 12 posting or mailing, after notice, of any advertisement or 13 written notice in violation of paragraph (F) of Section 14 3-102.

(B) Apartments. Rental of a housing accommodation in a building which contains housing accommodations for not more than five families living independently of each other, if the lessor or a member of his or her family resides in one of the housing accommodations;

(C) Private Rooms. Rental of a room or rooms in a private home by an owner if he or she or a member of his or her family resides therein or, while absent for a period of not more than twelve months, if he or she or a member of his or her family intends to return to reside therein;

(D) Reasonable local, State, or Federal restrictions
 regarding the maximum number of occupants permitted to occupy
 a dwelling.

Religious Organizations. A religious organization, 28 (王) 29 association, or society, or any nonprofit institution or 30 organization operated, supervised or controlled by or in conjunction with a religious organization, association, or 31 32 society, from limiting the sale, rental or occupancy of а dwelling which it owns or operates for other than a 33 34 commercial purpose to persons of the same religion, or from

giving preference to such persons, unless membership in such religion is restricted on account of race, color, or national origin.

4 (F) Sex. Restricting the rental of rooms in a housing5 accommodation to persons of one sex.

6 (G) Persons Convicted of Drug-Related Offenses. Conduct 7 against a person because such person has been convicted by 8 any court of competent jurisdiction of the illegal 9 manufacture or distribution of a controlled substance as 10 defined in Section 102 of the federal Controlled Substances 11 Act (21 U.S.C. 802).

12 (H) Persons engaged in the business of furnishing 13 appraisals of real property from taking into consideration 14 factors other than those based on unlawful discrimination or 15 familial status in furnishing appraisals.

16 <u>(H-1) The owner of an owner-occupied residential</u> 17 <u>building with 5 or fewer units (including the unit in which</u> 18 <u>the owner resides) from making decisions regarding whether to</u> 19 <u>rent to a person based upon that person's sexual orientation.</u> 20 (I) Housing for Older Persons. No provision in this

21 Article regarding familial status shall apply with respect to 22 housing for older persons.

23 (1) As used in this Section, "housing for older24 persons" means housing:

25 (a) provided under any State or Federal 26 that the Department determines program is specifically designed and operated to assist elderly 27 persons (as defined in the State 28 or Federal 29 program); or

30 (b) intended for, and solely occupied by,
31 persons 62 years of age or older; or

32 (c) intended and operated for occupancy by
 33 persons 55 years of age or older and:

34 (i) at least 80% of the occupied units

1 are occupied by at least one person who is 55 2 years of age or older;

(ii) the housing facility or community 3 4 publishes and adheres to policies and procedures that demonstrate the intent required 5 under this subdivision (c); and 6

7 (iii) the housing facility or community complies with rules adopted by the Department 8 9 for verification of occupancy, which shall:

(aa) provide for verification by 10 11 reliable surveys and affidavits; and

(bb) include examples of the types 12 of policies and procedures relevant to a 13 determination of compliance 14 with the 15 requirement of clause (ii).

These surveys and affidavits shall be admissible in 16 administrative and judicial proceedings for the purposes of 17 such verification. 18

19 (2) Housing shall not fail to meet the requirements for housing for older persons by reason of: 20

21 (a) persons residing in such housing as of the effective date of this amendatory Act of 1989 who do 22 23 not meet the age requirements of subsections (1)(b) or (c); provided, that new occupants of such housing 24 25 meet the age requirements of subsections (1)(b) or (c) of this subsection; or 26

(b) unoccupied units; provided, 27 that such units are reserved for occupancy by persons who meet 28 the age requirements of subsections (1)(b) or (c) of 29 30 this subsection.

(3) (a) A person shall not be held personally 31 liable for monetary damages for a violation of this 32 Article if the person reasonably relied, in good 33 34 faith, on the application of the exemption under

this subsection (I) relating to housing for older 1 2 persons. 3 (b) For the purposes of this item (3), a 4 person may show good faith reliance on the application of the exemption only by showing that: 5 (i) the person has no actual knowledge б 7 that the facility or community is not, or will not be, eligible for the exemption; and 8 9 (ii) the facility or community has stated 10 formally, in writing, that the facility or 11 community complies with the requirements for 12 the exemption.
