- 1 AN ACT in regard to vehicles.
- 2 Be it enacted by the People of the State of Illinois,
- 3 represented in the General Assembly:
- 4 Section 5. The Illinois Vehicle Code is amended by
- 5 adding Section 3-648 as follows:
- 6 (625 ILCS 5/3-648 new)
- 7 <u>Sec. 3-648. Illinois Lions Club license plates.</u>
- 8 (a) In addition to any other special license plate, the
- 9 <u>Secretary</u>, upon receipt of all applicable fees and
- 10 applications made in the form prescribed by the Secretary of
- 11 State, may issue Illinois Lions Club license plates to
- 12 <u>residents of Illinois who meet eligibility requirements</u>
- 13 prescribed by the Secretary of State. The special Illinois
- 14 Lions Club plate issued under this Section shall be affixed
- only to passenger vehicles of the first division and motor
- 16 <u>vehicles</u> of the second division weighing not more than 8,000
- 17 pounds. Plates issued under this Section shall expire
- 18 <u>according to the staggered multi-year procedure established</u>
- by Section 3-414.1 of this Code.
- 20 (b) The design, color, and format of the plates shall be
- 21 wholly within the discretion of the Secretary of State,
- 22 <u>except that the International Association of Lions Clubs</u>
- 23 <u>emblem shall appear at the lower right corner of the plate,</u>
- 24 and immediately to the left of the emblem shall appear the
- 25 <u>following words: "Member Illinois Lions Club". The Secretary</u>
- 26 may, in his or her discretion, allow the plates to be issued
- 27 <u>as vanity or personalized plates in accordance with Section</u>

- 3 (c) An applicant shall be charged a \$15 fee for original
- 4 <u>issuance in addition to the applicable registration fee.</u>
- 5 This additional fee shall be deposited into the Secretary of
- 6 State Special License Plate Fund. For each registration
- 7 renewal period, a \$2 fee, in addition to the appropriate
- 8 registration fee, shall be charged and shall be deposited
- 9 <u>into the Secretary of State Special License Plate Fund.</u>
