1 Office of the State Fire Marshal to determine the cause, 2 origin and circumstances of such fires or explosions that are suspected to be arson or arson-related crimes, may be 3 4 classified as a peace officer by the political subdivision or 5 agency employing such person. A person so classified shall 6 possess the same powers of arrest, search and seizure and the 7 securing and service of warrants as sheriffs of counties, and police officers within the jurisdiction of their political 8 9 subdivision. While in the actual investigation and matters incident thereto, such person may carry weapons as may be 10 11 necessary, but only if that person has satisfactorily completed (1) a training program offered or approved by the 12 Illinois Law Enforcement Training Standards Board which 13 substantially conforms to standards promulgated pursuant to 14 the Illinois Police Training Act and "An Act in relation to 15 firearms training for peace officers", approved August 16 1975, as amended; or in the case of employees of the Office 17 of the State Fire Marshal, a training course approved by the 18 19 Department of State Police which also substantially conforms to standards promulgated pursuant to "An Act in relation to 20 firearms training for peace officers", approved August 29, 21 22 1975, as amended; and (2) a course in fire and arson 23 investigation approved by the Office of the State Fire Marshal pursuant to the Illinois Fire Protection Training 24 25 Such training need not include exposure to vehicle and traffic law, traffic control and accident investigation, or 26 first aid, but shall include training in the law relating to 27 the rights of persons suspected of involvement in criminal 28 29 activities. 30 Any person granted the powers enumerated in this Section

Any person granted the powers enumerated in this Section
may exercise such powers only during the actual investigation
of the cause, origin and circumstances of such fires or

- 19 (a) The trustees shall have power to provide for the
- 20 requisite buildings, apparatus, and conveniences; to fix the
- 21 rates for tuition; to appoint such professors and
- 22 instructors, and to establish and provide for the management
- of such model farms, model art, and other departments and
- 24 professorships, as may be required to teach, in the most
- 25 thorough manner, such branches of learning as are related to
- 26 agriculture and the mechanic arts, and military tactics,
- 27 without excluding other scientific and classical studies. The
- 28 trustees shall, upon the written request of an employee
- 29 withhold from the compensation of that employee any dues,

Any lease to 22 23 the trustees of lands, buildings or facilities which will support scientific research and development in such areas as 24 25 computing, microelectronics, technology, super 26 biotechnology, robotics, physics and engineering shall be for a term not to exceed 18 years, and may grant to the trustees 27 the option to purchase the lands, buildings or facilities. 28 29 The lease shall recite that it is subject to termination and 30 cancellation in any year for which the General Assembly fails 31 to make an appropriation to pay the rent payable under the 32 terms of the lease.

Leases for the purposes described herein exceeding 5 years shall have the approval of the Illinois Board of Higher 1 Education.

2 The Board of Trustees may, directly or in cooperation with other institutions of higher education, acquire by 3 4 purchase or lease or otherwise, and construct, enlarge, 5 improve, equip, complete, operate, control and manage medical 6 research and high technology parks, together with the 7 necessary lands, buildings, facilities, equipment and 8 personal property therefor, to encourage and facilitate (a) 9 the location and development of business and industry in State of Illinois, and (b) the increased application and 10 11 development of technology and (c) the improvement and development of the State's economy. The Board of Trustees may 12 13 lease to nonprofit corporations all or any part of the land, buildings, facilities, equipment or other property included 14 15 in a medical research and high technology park upon such 16 terms and conditions as the University of Illinois may deem advisable and enter into any contract or agreement with such 17 nonprofit corporations as may be necessary or suitable for 18 19 the construction, financing, operation and maintenance and 20 management of any such park; and may lease to any person, 2.1 firm, partnership or corporation, either public or private, 22 any part or all of the land, building, facilities, equipment 23 or other property of such park for such purposes and upon such rentals, terms and conditions as the University may deem 24 25 advisable; and may finance all or part of the cost of any such park, including the purchase, lease, construction, 26 reconstruction, improvement, remodeling, addition to, and 27 extension and maintenance of all or part of such high 28 29 technology park, and all equipment and furnishings, 30 legislative appropriations, government grants, contracts, private gifts, loans, receipts from the operation of such 31 32 high technology park, rentals and similar receipts; and may make its other facilities and services available to tenants 33 34 or other occupants of any such park at rates which are

reasonable and appropriate.

The Trustees shall have power (a) to purchase real property and easements, and (b) to acquire real property and in the manner provided by law for the exercise of easements the right of eminent domain, and in the event negotiations for the acquisition of real property or easements for making any improvement which the Trustees are authorized to make shall have proven unsuccessful and the Trustees shall have by 8 resolution adopted a schedule or plan of operation for the execution of the project and therein made a finding that it 11 is necessary to take such property or easements immediately or at some specified later date in order to comply with the 12 schedule, the Trustees may acquire such property or easements 13 in the same manner provided in Sections 7-103 through 7-112 14 of the Code of Civil Procedure. 15

The Board of Trustees also shall have power to agree with the State's Attorney of the county in which any properties of the Board are located to pay for services rendered by the various taxing districts for the years 1944 through 1949 and to pay annually for services rendered thereafter by such district such sums as may be determined by the Board upon properties used solely for income producing purposes, title is held by said Board of Trustees, upon properties leased to members of the staff of the University of Illinois, title to which is held in trust for said Board of Trustees and upon properties leased to for-profit entities the title to which properties is held by the Board of Trustees. certified copy of any such agreement made with the State's Attorney shall be filed with the County Clerk and such sums shall be distributed to the respective taxing districts by the County Collector in such proportions that each taxing district will receive therefrom such proportion as the tax rate of such taxing district bears to the total tax rate that would be levied against such properties if they were not

exempt from taxation under the Property Tax Code.

The Board of Trustees of the University of Illinois, subject to the applicable civil service law, may appoint persons to be members of the University of Illinois Police Department. Members of the Police Department shall be peace officers and as such have all powers possessed by policemen in cities, and sheriffs, including the power to make arrests on view or warrants of violations of state statutes and city or county ordinances, except that they may exercise powers only in counties wherein the University and any of its branches or properties are located when such is required for the protection of university properties and interests, and its students and personnel, and otherwise, within such counties, when requested by appropriate state or local law enforcement officials; provided, however, that such officer shall have no power to serve and execute civil processes.

The Board of Trustees must authorize to each member of the University of Illinois Police Department and to any other employee of the University of Illinois exercising the powers of a peace officer a distinct badge that, on its face, (i) clearly states that the badge is authorized by the University of Illinois and (ii) contains a unique identifying number. No other badge shall be authorized by the University of Illinois. Nothing in this paragraph prohibits the Board of Trustees from issuing shields or other distinctive identification to employees not exercising the powers of a peace officer if the Board of Trustees determines that a shield or distinctive identification is needed by the employee to carry out his or her responsibilities.

The Board of Trustees may own, operate, or govern, by or through the College of Medicine at Peoria, a managed care community network established under subsection (r) of Section 5-16.3 of the Illinois Public Aid Code.

Any buildings or facilities to be developed on the land shall 5 be buildings or facilities that, in the determination of the 6 7 Board of Trustees, in whole or in part: (i) are for use by 8 the University; or (ii) otherwise advance the interests of 9 the University, including, by way of example, residential facilities for University staff and students and commercial 10 11 facilities which provide services needed by the University 12 community. Revenues from the development fund account may be withdrawn by the University for the purpose of demolition and 13 the processes associated with demolition; routine land and 14 15 property acquisition; extension of utilities; streetscape 16 landscape work; surface and structure parking; sidewalks, recreational paths, and street construction; 17 lease and lease purchase arrangements and the professional 18 19 services associated with the planning and development of the Moneys from the development fund account used for any 20 area. 21 other purpose must be deposited into and appropriated from 22 the General Revenue Fund. Buildings or facilities leased to 23 an entity or person other than the University shall not be subject to any limitations applicable to a State supported 24 25 college or university under any law. All development on the land and all use of any buildings or facilities shall be 26 subject to the control and approval of the Board of Trustees. 27
