- 2 Be it enacted by the People of the State of Illinois,
- 3 represented in the General Assembly:
- 4 Section 5. The State Finance Act is amended by adding
- 5 Section 5.570 as follows:

- 7 Sec. 5.570. The K-12 Education Fund.
- 8 Section 10. The Illinois Vehicle Code is amended by
- 9 adding Section 3-654 as follows:
- 10 (625 ILCS 5/3-654 new)
- 11 <u>Sec. 3-654. K-12 Education license plates.</u>
- 12 <u>(a) The Secretary, upon receipt of an application made</u>
- in the form prescribed by the Secretary, may issue special
- 14 registration plates designated as K-12 Education license
- 15 plates. The special plates issued under this Section shall
- 16 <u>be affixed only to passenger vehicles of the first division</u>
- 17 <u>and motor vehicles of the second division weighing not more</u>
- 18 than 8,000 pounds. Plates issued under this Section shall
- 19 <u>expire according to the multi-year procedure established by</u>
- 20 <u>Section 3-414.1 of this Code.</u>
- 21 (b) The design and color of the plates is wholly within
