AMENDMENT TO HOUSE BILL 4453

AMENDMENT NO.___. Amend House Bill 4453, AS AMENDED, with reference to page and line numbers of Senate Amendment No. 1, on page 7, by inserting the following after line 31:

5 "Section 1-35. Upon the payment of the sum of \$3,000.00 the State of Illinois, and subject to the conditions set 6 to forth in Section 1-900 of this Act, the Secretary of the 7 Department of Transportation is authorized to convey by 8 9 quitclaim deed all right, title, and interest in and to the 10 following described land in Morgan County, Illinois, to George H. Perbix Jr. Trust dated March 22, 1991; Jo Ellen 11 Perbix Kuzila Trust dated November 30, 1998; Jill Perbix 12 Chabut Trust dated December 24, 1991. 13
