- 3 Be it enacted by the People of the State of Illinois,
- 4 represented in the General Assembly:
- 5 Section 5. The Business Enterprise for Minorities,
- 6 Females, and Persons with Disabilities Act is amended by
- 7 adding Section 7.5 as follows:
- 8 (30 ILCS 575/7.5 new)
- 9 <u>Sec. 7.5. Legislative Contract Compliance Oversight</u>
- 10 Panel.
- 11 <u>(a) The Legislative Contract Compliance Oversight Panel</u>
- 12 <u>is created, consisting of 6 members of the Genial Assembly</u>
- 13 who serve by virtue of their office and are appointed as
- 14 follows:
- 15 (1) 2 Representatives appointed by the Speaker of
- the House of Representatives.
- 17 (2) One Representative appointed by the Minority
- 18 <u>Leader of the House of Representatives.</u>
- 19 (3) 2 Senators appointed by the President of the
- 20 <u>Senate</u>.
- 21 (4) One Senator appointed by the Minority Leader of
- the Senate.
- 23 <u>Members serve at the pleasure of their appointing</u>
- 24 <u>authority</u>. Annually, the members must select 2 from among
- 25 <u>themselves to serve as co-chairs of the Panel. Members</u>
- 26 <u>receive no compensation for their service on the Panel but</u>
- 27 <u>may be reimbursed for their actual and reasonable expenses</u>
- from funds appropriated for that purpose.
- 29 <u>(b) The Panel must oversee the compliance of the</u>
- 30 <u>Illinois Department of Transportation with the goals and</u>
- 31 requirements of this Act in the awarding of State

- 3 The Illinois Department of Transportation must provide the
- 4 Panel with copies of its compliance plan, contract notices,
- 5 and requests for exemptions and waivers under this Act. The
- 6 <u>Illinois Department of Transportation must report quarterly</u>
- 7 <u>in writing to the Panel on its progress in meeting the goals</u>
- 8 and requirements of this Act in its awarding of State
- 9 <u>construction</u> <u>contracts</u> <u>involving</u> <u>federal</u> <u>moneys</u> <u>or</u> <u>federal</u>

- 11 (c) The Panel must conduct public forums periodically
- 12 <u>throughout the State at which contractors subject to this Act</u>
- 13 and other interested parties may comment upon and question
- 14 the compliance of the Illinois Department of Transportation
- 15 with the goals and requirements of this Act. The Panel may
- 16 request the attendance at the public forums of appropriate
- 17 <u>representatives of the Department.</u>
- 18 <u>(d) The Panel must periodically report to the Business</u>
- 19 <u>Enterprise Council its findings and any recommendations</u>
- 20 regarding the compliance of the Illinois Department of
- 21 <u>Transportation with the goals and requirements of this Act.</u>
