- 29 Technology; since joining ComEd in 1966, he has held various
- 30 positions in both corporate support and line functions; and

- 1 Metropolitan Family Services, Governors State University
- 2 Foundation, the Illinois State Chamber of Commerce, and the
- 3 Chicago Legal Clinic, and on the board of trustees of

- 5 member of the Chicago Bar Association, The Economic Club of
- 6 Chicago, and the Executives' Club of Chicago; and
