- 22 Association during his judicial tenure, Al improved the legal
- 23 and judicial communities by serving in a variety of advisory
- 24 capacities, including as a member of the Judicial Conference
- of Illinois, on the Legislative Committee of the Illinois
- 26 Supreme Court, and on Commissions appointed by the General
- 27 Assembly; and
- WHEREAS, Virginia Bucko Green, Al's wife and an
- 29 accomplished attorney in her own right, has shown a
- 30 remarkable amount of tolerance through these fifty years in
- 31 having to share Al with Cook County, the Illinois General
- 32 Assembly, and the people of the State of Illinois, while Al

- 1 has always shown as much, if not more, diligence in the
- 2 support of his wife and family as that of his work; and
- 3 WHEREAS, Gini and Al have been blessed in their marriage
- 4 with five loving children, Valerie, Michael, Gregory,
- 5 Jonathan, and the late Vanessa, a wonderful grandchild,
- 6 Timothy, and lovely daughters-in-law Valerie and Monica;
