1 AN ACT to amend the State Comptroller Act by changing 2 Section 10.05.

3 Be it enacted by the People of the State of Illinois,4 represented in the General Assembly:

5 Section 5. The State Comptroller Act is amended by 6 changing Section 10.05 as follows:

7 (15 ILCS 405/10.05) (from Ch. 15, par. 210.05)

8 Sec. 10.05. Deductions from warrants; statement of reason for deduction. Whenever any person shall be entitled 9 to a warrant or other payment from the treasury or other 10 funds held by the State Treasurer, on any account, against 11 whom there shall be any account or claim in favor of the 12 13 State, then due and payable, the Comptroller, upon notification thereof, shall ascertain the amount due and 14 payable to the State, as aforesaid, and draw a warrant on the 15 16 treasury or on other funds held by the State Treasurer, stating the amount for which the party was entitled to a 17 18 warrant or other payment, the amount deducted therefrom, and on what account, and directing the payment of the balance; 19 20 which warrant or payment as so drawn shall be entered on the books of the Treasurer, and such balance only shall be paid. 21 22 The Comptroller may deduct the entire amount due and payable to the State or may deduct a portion of the amount due and 23 payable to the State in accordance with the request of 24 the notifying agency. No request from a notifying agency for an 25 amount to be deducted under this Section from a wage or 26 27 salary payment, or from a contractual payment to an individual for personal services, or from pension annuity 28 payments made under the Illinois Pension Code shall exceed 29 25% of the net amount of such payment. "Net amount" means 30 that part of the earnings of an individual remaining after 31

1 deduction of any amounts required by law to be withheld. For 2 purposes of this provision, wage, salary or other payments for personal services shall not include final compensation 3 4 payments for the value of accrued vacation, overtime or sick 5 Whenever the Comptroller draws a warrant or makes a leave. б payment involving a deduction ordered under this Section, the 7 Comptroller shall notify the payee and the State agency that submitted the voucher of the reason for the deduction and he 8 9 or she shall retain a record of such statement in his or her records. As used in this Section, an "account or claim in 10 11 favor of the State" includes all amounts owing to "State agencies" as defined in Section 7 of this Act. However, the 12 Comptroller shall not be required to accept accounts or 13 claims owing to funds not held by the State Treasurer, where 14 such accounts or claims do not exceed \$50, nor shall the 15 16 Comptroller deduct from funds held by the State Treasurer under the Senior Citizens and Disabled Persons Property Tax 17 18 Relief and Pharmaceutical Assistance Act. The Comptroller and 19 the Department of the Lottery shall enter into an interagency agreement to establish responsibility, duties, and procedures 20 21 relating to deductions from lottery prizes awarded under Section 20.1 of the Illinois Lottery Law. 22
