- 1 AN ACT concerning the Illinois Vehicle Code.
- 2 Be it enacted by the People of the State of Illinois,
- 3 represented in the General Assembly:
- 4 Section 5. The Illinois Vehicle Code is amended by
- 5 adding Section 3-648 as follows:
- 6 (625 ILCS 5/3-648 new)
- 7 <u>Sec. 3-648. Emergency services plates.</u>
- 8 (a) The Secretary of State, upon receipt of an
- 9 application made in the form prescribed by the Secretary, may
- 10 <u>issue special vehicle registration plates designated as</u>
- 11 <u>Emergency Services license plates. The special plates issued</u>
- 12 <u>under this Section shall be affixed only to passenger</u>
- 13 <u>vehicles of the first division, motor vehicles of the second</u>
- 14 <u>division weighing not more than 8,000 pounds, recreational</u>
- 15 <u>vehicles as defined in Section 1-169 of this Code, and</u>
- 16 <u>subject to the staggered registration system. Plates issued</u>
- 17 <u>under this Section shall expire according to the multi-year</u>
- procedure established by Section 3-414.1 of this Code.
- 19 <u>(b) The original application and subsequent renewals of</u>
- 20 <u>Emergency Services plates must be accompanied by a letter</u>
- 21 <u>from the Director of the Illinois Emergency Management Agency</u>
- 22 <u>or the chief officer of an Emergency Management Services and</u>
- 23 <u>Disaster Agency stating that the applicant is employed by the</u>
- 24 <u>respective agency</u>. An Emergency Service license plate shall
- 25 <u>not be issued to a person who is not employed by either the</u>

- 28 (c) The design and color of the plates shall be wholly
- 29 <u>within the discretion of the Secretary of State. The</u>
- 30 <u>Secretary of State may, in his or her discretion, allow the</u>
- 31 plates to be issued as vanity plates or personalized in

- 2 <u>not required to designate "Land of Lincoln", as prescribed in</u>

- 6 (d) An applicant shall be charged a \$15 fee for original
