- 4 Section 5. The Illinois Pension Code is amended by

- 7 <u>Sec. 3-110.8. Transfer to Article 5 Fund.</u>
- 8 (a) Until January 1, 2004, any active member of the
- 9 Article 5 pension fund may apply for transfer of his or her
- 10 <u>creditable service accumulated in any police pension fund</u>
- 11 <u>under this Article to that Article 5 fund. The creditable</u>
- 12 <u>service shall be transferred upon payment by the police</u>
