- 2 Be it enacted by the People of the State of Illinois,
- 3 represented in the General Assembly:
- 4 Section 5. The Illinois Vehicle Code is amended by
- 5 adding Section 16-108 as follows:
- 6 (625 ILCS 5/16-108 new)
- 7 Sec. 16-108. Claims of diplomatic immunity.
- 8 (a) This Section applies only to an individual that
- 9 <u>displays to a police officer a driver's license issued by the</u>
- 10 <u>U.S. Department of State or that otherwise claims immunities</u>
- or privileges under Title 22, Chapter 6 of the United States
- 12 <u>Code with respect to the individual's violation of Section</u>
- 13 <u>9-3 or Section 9-3.2 of the Criminal Code of 1961 or his or</u>
- 14 <u>her violation of a traffic regulation governing the movement</u>
- of vehicles under this Code or a similar provision of a local
- 16 <u>ordinance.</u>
- 17 (b) If a driver subject to this Section is stopped by a
- 18 police officer that has probable cause to believe that the
- 19 <u>driver has committed a violation described in subsection (a)</u>
- of this Section, the police officer shall:
- 21 (1) As soon as practicable contact the U.S.
- 22 <u>Department of State office in order to verify the</u>
- 23 <u>driver's status and immunity, if any;</u>
- 24 (2) Record all relevant information from any
- 25 <u>driver's license or identification card, including a</u>
- 26 <u>driver's license or identification card issued by the</u>
- U.S. Department of State; and
- 28 (3) Within 5 workdays after the date of the stop,
- 29 <u>forward the following to the Secretary of State of</u>
- 30 <u>Illinois:</u>
- 31 (A) A vehicle accident report, if the driver

2	(B) If a citation or charge was issued to the
3	driver, a copy of the citation or charge; and
4	(C) If a citation or charge was not issued to
5	the driver, a written report of the incident.
6	(c) Upon receiving material submitted under paragraph
7	(3) of subsection (b) of this Section, the Secretary of State
8	shall:
9	(1) File each vehicle accident report, citation or
10	charge, and incident report received;
11	(2) Keep convenient records or make suitable
12	notations showing each:
13	(A) Conviction;
14	(B) Disposition of court supervision for any
15	violation of Section 11-501 of this Code; and
16	(C) Vehicle accident; and
17	(3) Send a copy of each document and record
18	described in paragraph (2) of this subsection (c) to the
19	Bureau of Diplomatic Security, Office of Foreign

22	application of any law to a criminal or motor vehicle
23	violation by an individual who has or claims immunities or
