- 9 (a) The provisions of this Section shall apply only to

- (b) An alternative gas supplier must obtain a 13
- certificate of service authority from the Commission in 14

- (3) That the applicant will comply with such informational or reporting requirements as the Commission may by rule establish.
- 4 (4) That the area to be served by the applicant and 5 any limitations it proposes on the number of customers or maximum amount of load to be served meet the provisions 6 of Section 19-115, provided, that if the applicant seeks 7 8 to serve an area smaller than the service area of a gas 9 utility or proposes other limitations on the number of customers or maximum amount of load to be served, the 10 11 Commission can extend the time for considering such a 12 certificate request by up to 90 days, and can schedule 13 hearings on such a request.
- 14 (5) That the applicant will comply with all other
 15 applicable laws and rules.
- (f) The Commission shall have the authority to 16 promulgate rules to carry out the provisions of this Section. 17 Within 30 days after the effective date of this amendatory 18 Act of the 92nd General Assembly, the Commission shall adopt 19 an emergency rule or rules applicable to the certification of 20 21 those gas suppliers that seek to serve residential customers. 22 Within 180 days of the effective date of this amendatory Act of the 92nd General Assembly, the Commission shall adopt 23 rules that specify criteria which, if met by any such 24 alternative gas supplier, shall constitute the demonstration 25 of technical, financial, and managerial resources and 26 abilities to provide service required by item (1) of 27 subsection (e) of this Section, such as a requirement to post 28 a bond or letter of credit, from a responsible surety or 29 financial institution, of sufficient size for the nature and 30 scope of the services to be provided, demonstration of 31 adequate insurance for the scope and nature of the services 32 to be provided, and experience in providing similar services 33 in other jurisdictions. 34
