- 1 AN ACT concerned military funeral honors.
- 2 Be it enacted by the People of the State of Illinois,
- 3 represented in the General Assembly:
- 4 Section 5. The Military Code of Illinois is amended by
- 5 adding Article IV-A as follows:
- 6 (20 ILCS 1805/Art. IV-A heading new)
- 7 <u>ARTICLE IV-A. MILITARY FUNERAL HONORS</u>
- 8 (20 ILCS 1805/28.1 new)
- 9 <u>Sec. 28.1. Purpose. This Article establishes the</u>
- 10 <u>Illinois Military Funeral Honors Program to ensure, subject</u>
- 11 to the appropriation of adequate funds, an appropriate final
- 12 <u>tribute to deceased veterans and Governors in the absence of</u>
- 13 <u>federal military funeral honors or funeral honors provided by</u>
- 14 <u>veteran organizations. This Article establishes procedures</u>
- that ensure this tribute on behalf of a grateful citizenry to
- 16 <u>honor deceased veterans in recognition of their service to</u>
- 17 <u>the State of Illinois and to the United States of America.</u>
- 18 The rendering of military funeral honors is the ceremonial
- 19 paying of respects and final demonstration of gratitude to
- 20 those who, in times of war and peace, have faithfully
- 21 <u>defended freedom</u>.
- 22 (20 ILCS 1805/28.2 new)
- Sec. 28.2. Administration. The Adjutant General of
- 24 <u>Illinois</u>, as <u>Director of the Department of Military Affairs</u>,
- 25 <u>shall administer the Military Funeral Honors Program.</u>
- 26 (20 ILCS 1805/28.3 new)
- 27 <u>Sec. 28.3. State funeral honors. The funeral honors</u>
- 28 <u>entitlement established by this Article may be provided to an</u>

- 1 <u>eliqible veteran only if (i) a request for military funeral</u>
- 2 honors has been made on behalf of the deceased veteran to
- 3 <u>federal</u> <u>authorities</u> <u>and</u> (ii) <u>military</u> <u>funeral</u> <u>honors</u> <u>are</u> <u>not</u>
- 4 to be provided by federal authorities, regardless of the
- 5 reason. Governors are entitled to funeral honors without a
- 6 <u>federal request.</u>
- 7 (20 ILCS 1805/28.4 new)
- 8 Sec. 28.4. Eligibility. Only veterans and Governors are
- 9 <u>eligible for military funeral honors under this Article. In</u>
- 10 <u>this Article, "veteran" means an Illinois resident who is a</u>
- 11 <u>veteran as defined in subsection (h) of Section 1491 of Title</u>
- 12 <u>10 of the United States Code. Governors are eligible for</u>
- 13 military funeral honors because of their service as
- 14 <u>Commander-in-Chief of the military forces of the State of</u>
- 15 <u>Illinois</u>.
- 16 (20 ILCS 1805/28.5 new)
- Sec. 28.5. Waiver authority.
- 18 <u>(a) With approval of the Governor, the Adjutant General</u>
- 19 <u>may waive the requirement established in Section 28.3 of this</u>
- 20 <u>Article if the Adjutant General determines in writing that it</u>
- 21 <u>is in the best interests of the State of Illinois to do so.</u>
- (b) Waiver authority under this Section may be delegated
- 23 <u>only to the Assistant Adjutant General for Army or the</u>
- 24 <u>Assistant Adjutant General for Air.</u>
- 25 (20 ILCS 1805/28.6 new)
- 26 <u>Sec. 28.6. Policy.</u>
- 27 (a) A member of the Army National Guard or the Air
- 28 <u>National Guard may be ordered to funeral honors duty in</u>
- 29 <u>accordance with this Article. That member shall receive an</u>
- 30 <u>allowance of \$50 for any day on which a minimum of 2 hours of</u>
- 31 <u>funeral honors duty is performed. Members of the Illinois</u>

- 1 National Guard ordered to funeral honors duty in accordance
- 2 with this Article are considered to be in the active service
- 3 of the State for all purposes except for pay, and the
- 4 provisions of Sections 52, 53, 54, 55, and 56 of the Military
- 5 <u>Code of Illinois apply if a member of the Illinois National</u>
- 6 Guard is injured or disabled in the course of those duties.
- 7 (b) The Adjutant General may provide support for other
- 8 <u>authorized providers who volunteer to participate in a</u>
- 9 <u>funeral honors detail conducted on behalf of the Governor.</u>
- 10 This support is limited to transportation, reimbursement for
- 11 <u>transportation</u>, <u>expenses</u>, <u>materials</u>, <u>and training</u>.
- 12 (20 ILCS 1805/28.8 new)
- Sec. 28.8. Rules. The Adjutant General, as Director of
- 14 <u>the Department of Military Affairs, must adopt appropriate</u>
- 15 <u>rules to implement this program.</u>
- 16 (20 ILCS 1805/28.9 new)
- 17 <u>Sec. 28.9. Availability of funds. Nothing in this</u>
- 18 Article establishes any entitlement to military funeral
- 19 <u>honors if the Adjutant General determines that Illinois</u>
- 20 <u>National Guard personnel are not available to perform those</u>
- 21 <u>honors or if adequate appropriated funds are not available to</u>
- 22 <u>fund this program.</u>
- 23 Section 99. Effective date. This Act takes effect on
- 24 January 1, 2002.
