2 Be it enacted by the People of the State of Illinois,
3 represented in the General Assembly:

Section 3. The State Employees Group Insurance Act of
1971 is amended by changing Section 6.11 as follows:

6 (5 ILCS 375/6.11)

Sec. 6.11. Required health benefits; Illinois Insurance 7 8 <u>Code requirements</u>. The program of health benefits shall provide the post-mastectomy care benefits required to be 9 covered by a policy of accident and health insurance under 10 Section 356t of the Illinois Insurance Code. The program of 11 12 health benefits shall provide the coverage required under 13 Sections 356u, 356w, and 356x of the Illinois Insurance Code. The program of health benefits must comply with Section 14 155.37 of the Illinois Insurance Code. 15

Section 5. The Illinois Insurance Code is amended by adding Sections 155.37, 370t, and 511.114 as follows:

21 Sec. 155.37. Drug formulary; notice. Insurance 22 companies that transact the kinds of insurance authorized 23 under Class 1(b) or Class 2(a) of Section 4 of this Code and 24 provide coverage for prescription drugs through the use of a 25 drug formulary must notify insureds of any change in the 26 formulary. A company may comply with this Section by posting 27 changes in the formulary on its website.

9 another state, 30% of more of the enrollees of which are
10 residents of this State, except a corporation subject to
11 substantially the same requirements in its state of
12 organization as is a domestic company under Article VIII
13 1/2 of the Illinois Insurance Code.
