- 8 <u>Sec. 86. September 11th Day of Remembrance. September</u>
- 9 <u>11th of each year is designated as September 11th Day of</u>
- 10 Remembrance to be observed throughout the State as a day set
- 11 apart in honor and remembrance of the persons killed and
- injured in the terrorist attacks on September 11, 2001.
- 13 Section 10. The State Finance Act is amended by adding
- 14 Section 5.567 as follows:
- 15 (30 ILCS 105/5.567 new)
- Sec. 5.567. The September 11th Fund.
- 17 Section 15. The School Code is amended by changing
- 18 Section 24-2 as follows:
- 19 (105 ILCS 5/24-2) (from Ch. 122, par. 24-2)
- Sec. 24-2. Holidays. Teachers shall not be required to
- 21 teach on Saturdays; nor shall teachers or other school
- 22 employees, other than noncertificated school employees whose
- 23 presence is necessary because of an emergency or for the
- 24 continued operation and maintenance of school facilities or
- 25 property, be required to work on legal school holidays, which
- 26 are January 1, New Year's Day; the third Monday in January,
- 27 the Birthday of Dr. Martin Luther King, Jr.; February 12, the

1 Birthday of President Abraham Lincoln; the first Monday in 2 March (to be known as Casimir Pulaski's birthday); Good Friday; the day designated as Memorial Day by federal law; 3 4 July 4, Independence Day; the first Monday in September, 5 Labor Day; the second Monday in October, Columbus Day; 6 November 11, Veteran's Day; the Thursday in November commonly 7 called Thanksgiving Day; and December 25, Christmas Day. 8 School boards may grant special holidays whenever in their 9 judgment such action is advisable, except that no school board or board of education may designate or observe as a 10 11 special holiday on which teachers or other school employees are not required to work the days on which general elections 12 for members of the Illinois House of Representatives are 13 held. No deduction shall be made from 14 the time 15 compensation of a school employee on account of any legal or 16 special holiday. holidays, which recognize 17 Commemorative specified patriotic, civic, cultural or historical persons, activities, 18 19 or events, are regular school days. Commemorative holidays are: January 28 (to be known as Christa McAuliffe Day and 20 2.1 observed as a commemoration of space exploration), February 22 15 (the birthday of Susan B. Anthony), March 29 (Viet Nam War 23 September 11 (September 11th Day of Veterans Day), Remembrance), the school day immediately preceding Veteran's 24 25 Day (Korean War Veterans Day), October 1 (Recycling Day), December 7 (Pearl Harbor Veterans Day) and any day so 26 appointed by the President or Governor. School boards may 27 establish commemorative holidays whenever in their judgment 28 action is advisable. School boards shall include 29 30 instruction relative to commemorated persons, activities, or events on the commemorative holiday or at any other time 31 during the school year and at any point in the curriculum 32 when such instruction may be deemed appropriate. The State 33 34 Board of Education shall prepare and make available to school

- 1 boards instructional materials relative to commemorated
- 2 persons, activities, or events which may be used by school
- 3 boards in conjunction with any instruction provided pursuant

- 5 City of Chicago School District 299 shall observe March 4
- of each year as a commemorative holiday. This holiday shall

- 10 Daley and the late Mayor Harold Washington. If March 4 falls

- 15 Section 20. The Illinois Vehicle Code is amended by
- 16 adding Section 3-653 as follows:

- Sec. 3-653. September 11th license plates.
- 19 (a) Beginning on September 11, 2002, the Secretary, upon
- 20 <u>receipt of all applicable fees and applications made in the</u>
- 21 form prescribed by the Secretary, may issue special
- 22 <u>registration plates designated as September 11th license</u>
- 23 plates.
- 24 <u>The special plates issued under this Section shall be</u>
- 25 <u>affixed only to passenger vehicles of the first division or</u>
- 26 <u>motor vehicles of the second division weighing not more than</u>
- 27 <u>8,000 pounds.</u>
- 28 <u>Plates issued under this Section shall expire according</u>
- 29 <u>to the multi-year procedure established by Section 3-414.1 of</u>
- 30 <u>this Code</u>.
- 31 (b) The design and color of the special plates shall be
- 32 wholly within the discretion of the Secretary. The Secretary

- 1 may allow the plates to be issued as vanity or personalized

- (c) An applicant for the special plate shall be charged 5
- a \$40 fee for original issuance in addition to the 6
- appropriate registration fee. Of this fee, \$25 shall be 7
- deposited into the September 11th Fund and \$15 shall be 8
- 9 deposited into the Secretary of State Special License Plate
- Fund, to be used by the Secretary to help defray the 10
- 11 administrative processing costs.
- For each registration renewal period, a \$27 fee, in 12
- 13 addition to the appropriate registration fee, shall be
- charged. Of this fee, \$25 shall be deposited into the 14
- September 11th Fund and \$2 shall be deposited into the 15

- (d) The September 11th Fund is created as a special fund 17

- 21 September 11th Fund as grants to aid victims of terrorism and
