- 1 AN ACT relating to education.
- 2 Be it enacted by the People of the State of Illinois,
- 3 represented in the General Assembly:
- 4 Section 5. The School Code is amended by adding Section
- 5 2-3.131 as follows:
- 6 (105 ILCS 5/2-3.131 new)
- 7 <u>Sec. 2-3.131. Teacher Cadet Program.</u>
- 8 <u>(a) The Teacher Cadet Program is hereby established and</u>
- 9 shall be operated by the State Board of Education. The
- 10 Program is established for the purpose of introducing public
- 11 secondary school pupils to the teaching profession. The main
- 12 purpose of the Program is to encourage high school pupils who
- 13 possess a high level of academic achievement and the
- 14 personality traits found in good teachers to consider a
- 15 <u>career in teaching.</u>
- 16 (b) The State Board of Education shall develop a grant
- 17 program that assists school districts chosen by the State
- 18 Board of Education on a competitive basis in offering year
- 19 <u>long coursework designed to expose pupils to teaching careers</u>
- 20 <u>and the education system through the development of a</u>
- 21 <u>hands-on curriculum that includes the following elements:</u>
- 22 (1) Classroom discussions led by the supervising
- 23 <u>teacher at the high school.</u>
- 24 (2) Hands-on activities designed to excite pupils
- 25 <u>about teaching.</u>
- 26 (3) Observation and participation in public school
- 27 <u>classrooms.</u>
- 28 <u>(4) Interaction with successful administrators and</u>
- teachers.
- 30 (5) Opportunities for high school pupils to
- 31 participate in classrooms through tutoring, internships,

- 1 <u>and classroom observation of teaching.</u>
- 2 (c) A school district that participates in the Teacher
- 3 <u>Cadet Program shall receive, from funds appropriated for that</u>
- 4 purpose, a one-time grant of up to \$5,000 for the start-up of
- 5 the Program at its school site that will fund the development
- 6 of the curriculum, the purchase of materials, and the
- 7 <u>development of tutoring, internship, and observation options</u>
- 8 for the high school pupils enrolled in the Program.
- 9 (d) Subject to the availability of funding, the State
- 10 Board of Education shall contract for an evaluation of the
- 11 <u>Teacher Cadet Program and shall report on the evaluation to</u>
- 12 the General Assembly by January 1, 2006. This evaluation
- 13 <u>shall include (i) interviews with Program participants</u>
- 14 regarding their views on the value of the Program and whether
- 15 participation in the Program has been instrumental in
- 16 <u>encouraging the selection of teaching as a major in college</u>
- or as a career and (ii) surveys of colleges and universities
- 18 <u>to determine whether there has been an increase in the number</u>
- of pupils that indicate an interest in preparing for a career
- in public education.
- 21 (e) The State Board of Education may adopt any rules
- 22 <u>necessary to implement and administer this Section.</u>
- 23 (f) This Section is repealed on January 1, 2010.
