1 AN ACT in relation to vehicles.

Be it enacted by the People of the State of Illinois,represented in the General Assembly:

Section 5. The Illinois Vehicle Code is amended by
changing Section 12-215 as follows:

6 (625 ILCS 5/12-215) (from Ch. 95 1/2, par. 12-215)

Sec. 12-215. Oscillating, rotating or flashing lights on
motor vehicles. Except as otherwise provided in this Code:

9 (a) The use of red or white oscillating, rotating or 10 flashing lights, whether lighted or unlighted, is prohibited 11 except on:

Law enforcement vehicles of State, Federal or
 local authorities;

14 2. A vehicle operated by a police officer or county 15 coroner and designated or authorized by local 16 authorities, in writing, as a law enforcement vehicle; 17 however, such designation or authorization must be 18 carried in the vehicle;

Vehicles of local fire departments and State or
 federal firefighting vehicles;

4. Vehicles which are designed and used exclusively
as ambulances or rescue vehicles; furthermore, such
lights shall not be lighted except when responding to an
emergency call for and while actually conveying the sick
or injured;

5. Tow trucks licensed in a state that requires such lights; furthermore, such lights shall not be lighted on any such tow truck while the tow truck is operating in the State of Illinois; and

30 6. Vehicles of the Illinois Emergency Management31 Agency, and vehicles of the Department of Nuclear Safety.

(b) The use of amber oscillating, rotating or flashing
 lights, whether lighted or unlighted, is prohibited except
 on:

4 1. Second division vehicles designed and used for towing or hoisting vehicles; furthermore, such lights 5 shall not be lighted except as required in this paragraph 6 7 such lights shall be lighted when such vehicles are 1; 8 actually being used at the scene of an accident or 9 disablement; if the towing vehicle is equipped with a flat bed that supports all wheels of the vehicle being 10 11 transported, the lights shall not be lighted while the 12 vehicle is engaged in towing on a highway; if the towing vehicle is not equipped with a flat bed that supports all 13 wheels of a vehicle being transported, the lights shall 14 15 be lighted while the towing vehicle is engaged in towing 16 on a highway during all times when the use of headlights is required under Section 12-201 of this Code; 17

Motor vehicles or equipment of the State of
 Illinois, local authorities and contractors; furthermore,
 such lights shall not be lighted except while such
 vehicles are engaged in maintenance or construction
 operations within the limits of construction projects;

3. Vehicles or equipment used by engineering or
survey crews; furthermore, such lights shall not be
lighted except while such vehicles are actually engaged
in work on a highway;

4. Vehicles of public utilities, municipalities, or
other construction, maintenance or automotive service
vehicles except that such lights shall be lighted only as
a means for indicating the presence of a vehicular
traffic hazard requiring unusual care in approaching,
overtaking or passing while such vehicles are engaged in
maintenance, service or construction on a highway;

5. Oversized vehicle or load; however, such lights

1 2 shall only be lighted when moving under permit issued by the Department under Section 15-301 of this Code;

6. The front and rear of motorized equipment owned and operated by the State of Illinois or any political subdivision thereof, which is designed and used for removal of snow and ice from highways;

7 7. Fleet safety vehicles registered in another
8 state, furthermore, such lights shall not be lighted
9 except as provided for in Section 12-212 of this Code;

10 8. Such other vehicles as may be authorized by11 local authorities;

12 9. Law enforcement vehicles of State or local
13 authorities when used in combination with red
14 oscillating, rotating or flashing lights;

15 10. Vehicles used for collecting or delivering mail 16 for the United States Postal Service provided that such 17 lights shall not be lighted except when such vehicles are 18 actually being used for such purposes;

19 11. Any vehicle displaying a slow-moving vehicle
20 emblem as provided in Section 12-205.1;

21 12. All trucks equipped with self-compactors or 22 roll-off hoists and roll-on containers for garbage or 23 refuse hauling. Such lights shall not be lighted except 24 when such vehicles are actually being used for such 25 purposes;

26 13. Vehicles used by a security company, alarm
27 responder, or control agency, if the security company,
28 alarm responder, or control agency is bound by a contract
29 with a federal, State, or local government entity to use
30 the lights; and

31 14. Security vehicles of the Department of Human 32 Services; however, the lights shall not be lighted except 33 when being used for security related purposes under the 34 direction of the superintendent of the facility where the SB1657 Engrossed

1 vehicle is located. (c) The use of blue oscillating, rotating or flashing 2 lights, whether lighted or unlighted, is prohibited except 3 4 on: 5 1. Rescue squad vehicles not owned by a fire department and vehicles owned or fully operated by a: 6 7 voluntary firefighter; 8 paid firefighter; 9 part-paid firefighter; call firefighter; 10 11 member of the board of trustees of a fire 12 protection district; paid or unpaid member of a rescue squad; or 13 paid or unpaid member of a voluntary ambulance 14 15 unit. 16 However, such lights are not to be lighted except when responding to a bona fide emergency. 17 2. Police department vehicles in cities having a 18 population of 500,000 or more inhabitants. 19 3. Law enforcement vehicles of State or local 20 21 authorities when used in combination with red oscillating, rotating or flashing lights. 22 23 4. Vehicles of local fire departments and State or federal firefighting vehicles when used in combination 24 25 with red oscillating, rotating or flashing lights. 5. Vehicles which are designed and used exclusively 26 as ambulances or rescue vehicles when used in combination 27 red oscillating, rotating or flashing lights; 28 with furthermore, such lights shall not be lighted except when 29 30 responding to an emergency call. 6. Vehicles that are equipped and used exclusively 31 as organ transport vehicles when used in combination with 32 33 oscillating, rotating, or flashing lights; red furthermore, these lights shall only be lighted when the

1 transportation is declared an emergency by a member of 2 the transplant team or a representative of the organ 3 procurement organization.

Vehicles of the Illinois Emergency Management
Agency and vehicles of the Department of Nuclear Safety,
when used in combination with red oscillating, rotating,
or flashing lights.

In addition to the blue oscillating, rotating, 8 (c-1) or 9 flashing lights permitted under subsection (c), and notwithstanding subsection (a), a vehicle operated by a 10 11 voluntary firefighter, a voluntary member of a rescue squad, or a member of a voluntary ambulance unit may be equipped 12 with flashing white headlights and blue grill lights, which 13 may be used only in responding to an emergency call. 14

The use of a combination of amber and 15 (d) white 16 oscillating, rotating or flashing lights, whether lighted or unlighted, is prohibited, except motor vehicles or equipment 17 of the State of Illinois, local authorities and contractors 18 19 may be so equipped; furthermore, such lights shall not be lighted except while such vehicles are engaged in highway 20 21 maintenance or construction operations within the limits of 22 highway construction projects.

(e) All oscillating, rotating or flashing lights referred to in this Section shall be of sufficient intensity, when illuminated, to be visible at 500 feet in normal sunlight.

(f) Nothing in this Section shall prohibit a manufacturer of oscillating, rotating or flashing lights or his representative from temporarily mounting such lights on a vehicle for demonstration purposes only.

31 (g) Any person violating the provisions of subsections 32 (a), (b), (c) or (d) of this Section who without lawful 33 authority stops or detains or attempts to stop or detain 34 another person shall be guilty of a Class 4 felony.
