- 4 Section 5. The Code of Criminal Procedure of 1963 is
- 5 amended by changing Section 113-3 as follows:
- 6 (725 ILCS 5/113-3) (from Ch. 38, par. 113-3)
- 7 Sec. 113-3. (a) Every person charged with an offense
- 8 shall be allowed counsel before pleading to the charge. If
- 9 the defendant desires counsel and has been unable to obtain
- 10 same before arraignment the court shall recess court or
- 11 continue the cause for a reasonable time to permit defendant
- 12 to obtain counsel and consult with him before pleading to the
- 13 charge. If the accused is a dissolved corporation, and is not
- 14 represented by counsel, the court may, in the interest of
- 15 justice, appoint as counsel a licensed attorney of this

- 17 (b) In all cases, except where the penalty is a fine

Any person who knowingly 6 7 files such affidavit containing false information concerning 8 his assets and liabilities shall be liable to the county 9 where the case, in which such false affidavit is filed, pending for the reasonable value of the services rendered by 10 11 the public defender or other court-appointed counsel in the case to the extent that such services were unjustly or 12 falsely procured. 13

Upon the filing with the court of a verified statement of services rendered the court shall order the county treasurer of the county of trial to pay counsel other than the Public Defender a reasonable fee. The court shall consider all relevant circumstances, including but not limited to the time spent while court is in session, other time spent in representing the defendant, and expenses reasonably incurred by counsel. In counties with a population greater than 2,000,000, the court shall order the county treasurer of the county of trial to pay counsel other than the Public Defender a reasonable fee stated in the order and based upon a rate of compensation of not more than \$40 for each hour spent while court is in session and not more \$30 for each hour otherwise spent representing a defendant, and such compensation shall not exceed \$150 for each defendant represented in misdemeanor cases and \$1250 in felony cases, in addition to expenses reasonably incurred as hereinafter in this Section provided, except that, extraordinary circumstances, payment in excess of the limits herein stated may be made if the trial court certifies that such payment is necessary to provide fair compensation for 1 protracted representation. A trial court may entertain the

filing of this verified statement before the termination of

3 the cause, and may order the provisional payment of sums

during the pendency of the cause. In capital cases, the court

is not bound by the limitations prescribed in this subsection

(c), but shall pay counsel fees that are reasonably necessary

for the proper conduct of the case. Fees in capital cases

8 <u>must be in an amount equal to the average hourly rate for</u>

counsel in capital cases in the county in which the case is

10 tried.

- (d) In capital cases, in addition to counsel, if the court determines that the defendant is indigent the court may, upon the filing with the court of a verified statement of services rendered, order the county Treasurer of the county of trial to pay necessary expert witnesses for defendant reasonable compensation, in an amount equal to the average hourly rate for that type of expert witness in capital cases in the county in which the case is tried, stated in the order not-to-exceed-\$250--for--each--defendant.

 Upon payment of the ordered expenses, the county treasurer may apply to the State Treasurer for reimbursement for the ordered expenses from the Capital Litigation Trust Fund.
 - (e) If the court in any county having a population greater than 2,000,000 determines that the defendant is indigent the court may, upon the filing with the court of a verified statement of such expenses, order the county treasurer of the county of trial, in such counties having a population greater than 2,000,000 to pay the general expenses of the trial incurred by the defendant not to exceed \$50 for each defendant.
- 31 (f) The provisions of this Section relating to 32 appointment of counsel, compensation of counsel, and payment 33 of expenses in capital cases apply except when the 34 compensation and expenses are being provided under the

- 1 Capital Crimes Litigation Act.
