1 Commission may from time to time determine 2 established and operated (A) for any aspect of the carrying out of the Commission's purposes as set forth in 3 4 this Act, (B) for the study, diagnosis, and treatment of human ailments and injuries, whether physical or mental, 5 (C) to promote medical, surgical, and scientific 6 7 research and knowledge as permitted under this Act; and 8 (ii) medical research and high technology parks, together 9 with the necessary lands, buildings, facilities, equipment, and personal property for those parks. 10

- (b) The Commission has perpetual succession and the power to contract and be contracted with, to sue and be sued except in actions sounding in tort, to plead and be impleaded, to have and use a common seal, and to alter the same at pleasure. - (c) The Commission shall consist of the following members: 4 members of the public appointed by the Governor, with the advice and consent of the Senate; 4 members of the public appointed by the Mayor of Springfield, with the advice and consent of the Springfield city council, at least whom shall be members of neighborhood organizations located within the District; 2 members appointed by each governing body of each accredited public school of medicine located and conducting programs of study in the District; one member appointed by the Governor, with the advice and consent of the Senate, and one member appointed by the Mayor of Springfield, with the advice and consent of the Springfield city council, representing each licensed non-profit acute care hospital within the District, each of whom must at all times during the term of appointment be and remain an officer of the governing board of, or an officer of, the licensed non-profit

acute care hospital; and 2 physician members representing the

2 chartered county medical society in the county that includes the District, with one member appointed by the Governor, with 3 4 the advice and consent of the Senate and one member appointed by the Mayor of Springfield, with the advice and consent of 5 б the Springfield city council. A licensed non-profit acute 7 care hospital member shall no longer be qualified to be, and shall promptly be replaced as, a Commissioner, as provided in 8 9 this Act, if and when the member no longer is an officer of the governing board of, or an officer of, the licensed 10 11 non-profit acute care hospital represented. The members, except the physician members, members representing hospitals, 12 and the members representing a public school of medicine, 13 appointed by the Governor and by the Mayor of Springfield 14 shall not have been at any time during the 2-year period 15 16 immediately before their appointment as Commissioners, shall not be at any time during the term of their appointment 17 as Commissioners, (i) members of the faculty of a school of 18 19 medicine, (ii) members of the medical or dental staff of an acute care hospital, or (iii) directors, trustees, officers, 20 21 employees, or agents of a person or entity that owns and operates a health care delivery facility or service in 22 23 Springfield or of any person or entity that controls or owns, is controlled or owned by, or is under common control 24 25 ownership with any such person or party. All members of the Commission other than the initial public members appointed by 26 the Governor shall be appointed to hold office for a term of 27 5 years and until their successors are appointed as provided 28 in this Act. The initial public members of the Commission 29 30 appointed by the Governor shall be appointed for terms ending, respectively on the second, third, fourth, and fifth 31 32 anniversaries of their appointments. Thereafter, the public members appointed by the Governor shall be appointed to hold 33 office for a term of 5 years and until their successors are 34

- 1 appointed as provided in this Act.
- 2 (d) Any vacancy in the membership of the Commission
- 3 occurring by reason of the death, resignation,
- 4 disqualification, removal, or inability or refusal to act of
- 5 any of the members of the Commission shall be filled by the
- 6 entity that had appointed the particular member, and for the
- 7 unexpired term of office of that particular member. A vacancy
- 8 caused by the expiration of the period for which the member
- 9 was appointed shall be filled by a new appointment for a term
- 10 of 5 years from the date of the expiration of the prior
- 11 5-year term notwithstanding when the appointment is actually
- 12 made. The Commission shall obtain, under the provisions of
- 13 the Personnel Code, such personnel as to the Commission shall
- 14 deem advisable to carry out the purposes of this Act and the
- work of the Commission.

- 16 (e) The Commission shall hold regular meetings annually

- 23 (g) The Auditor General shall conduct audits of the
- 24 Commission in the same manner as the Auditor General conducts
- 25 audits of State agencies under the Illinois State Auditing
- 26 Act.
- 27 (h) Neither the Commission nor the District have any
- 28 power to tax.
- 29 (i) The Commission is a public body and subject to the
- 30 Open Meetings Act and the Freedom of Information Act.
- 31 Section 15. Grants; loans; contracts. The Commission may
- 32 apply for and accept grants, loans, or appropriations from
- 33 the State of Illinois, the federal government, any State or

federal agency or instrumentality, any unit 1 of local 2 government, or any other person or entity to be used for any of the purposes of the District. The Commission may enter 3 4 into any agreement with the State of Illinois, the federal 5 government, any State or federal instrumentality, any unit of local government, or any other person or entity in relation 6 7 to the grants, matching grants, loans, or appropriations. The Commission also may, by contractual agreement, accept and 8 9 collect assessments or fees from entities who enter into such a contractual agreement for 10 District enhancement improvements, common area shared services, shared facilities, 11 12 or other activities or expenditures in furtherance of the purposes of this Act. The Commission may make grants 13 neighborhood organizations within the District for the 14 15 purpose of benefitting the community.

16 Section 20. Property; acquisition. The Commission is 17 authorized to acquire the fee simple title to real property 18 lying within the District and personal property required for 19 its purposes, by gift, purchase, or otherwise. Title shall be 2.0 taken in the corporate name of the Commission. The Commission 21 may acquire by lease any real property lying within the 22 District and personal property found by the Commission to be necessary for its purposes and to which the Commission finds 23 24 that it need not acquire the fee simple title for carrying out of those purposes. All real and personal property within 25 26 the District, except that owned and used for purposes authorized under this Act by medical institutions or allied 27 28 educational institutions, hospitals, dispensaries, clinics, 29 dormitories or homes for the nurses, doctors, students, instructors, or other officers or employees of 30 31 institutions located in the District, or any real property that is used for offices or for recreational purposes in 32 33 connection with those institutions, or improved any

1 residential property within a currently effective historical 2 district properly designated under a federal statute or a State or local statute that has been certified by the 3 4 Secretary of the Interior to the Secretary of the Treasury as 5 containing criteria that will substantially achieve the б purpose of preserving and rehabilitating buildings 7 historical significance to the district, may be acquired by 8 the Commission in its corporate name under the provisions for 9 the exercise of the right of eminent domain under Article VII of the Code of Civil Procedure. The Commission has no 10 11 quick-take powers, no zoning powers, and no power to establish or enforce building codes. The Commission may not 12 13 acquire any property pursuant to this Section before a comprehensive master plan has been approved under Section 70. 14

Section 25. Construction. The Commission may, corporate capacity, construct or cause to be constructed within the District, hospitals, sanitariums, clinics, laboratories, any other institution, building, or or structure or other ancillary or related facilities that the Commission may, from time to time, determine are established and operated (i) for the carrying out of any aspect of Commission's purposes as set forth in this Act, for the study, diagnosis, and treatment of human ailments injuries, whether physical or mental, or to promote medical, surgical, and scientific research and knowledge, for any uses the Commission shall determine will support and nurture facilities and uses permitted by this Act, or for such nursing, extended care, or other facilities as the Commission shall find useful in the study of, research in, or treatment of illnesses or infirmities peculiar to aged people, after a public hearing to be held by any Commissioner or other person authorized by the Commission to conduct the hearing, which Commissioner or other person has the power to administer

1 oaths and affirmations and take the testimony of witnesses 2 and receive such documentary evidence as shall be pertinent, the record of which hearing he or she shall certify to the 3 4 Commission, which record shall become part of the records of 5 the Commission, notice of the time, place, and purpose of the б hearings to be given by a single publication notice in a secular newspaper of general circulation in the City of 7 Springfield at least 10 days before the date of the hearing, 8 9 or (ii) for such institutions as shall engage in the training, education, or rehabilitation of persons who by 10 11 reason of illness or physical infirmity are wholly or partially deprived of their powers of vision or hearing or of 12 the use of such other part or parts of their bodies as 13 prevent them from pursuing normal activities of life, for 14 office buildings for physicians or dealers 15 in accessories, for dormitories, homes, or residences for the 16 medical profession, including interns, nurses, students, or 17 other officers or employees of the institutions within the 18 19 District, for the use of relatives of patients in the hospitals or other institutions within the District, for the 20 rehabilitation or establishment of residential structures 2.1 22 within a historic district properly designated under a 23 federal statute or a State or local statute that has been certified by the Secretary of the Interior to the Secretary 24 25 Treasury as containing criteria t.he that will substantially achieve the purpose of 26 preserving and rehabilitating buildings of historic significance to the 27 district, or such other areas of the District as 28 t.he Commission shall designate, for research, 29 development, 30 resultant production in any of the fields of medicine, chemistry, pharmaceuticals, physics, and 31 genetically 32 engineered products, for biotechnology, information technology, medical technology, or environmental technology, 33 for the research and development of engineering, or for 34

1 computer technology related to any of the purposes for which

2 the Commission may construct structures and improvements

3 within the District. All such structures and improvements

4 shall be erected and constructed in accordance with the

provisions of the Illinois Procurement Code that apply to

6 State agencies. No construction may be undertaken pursuant to

this Section before a comprehensive master plan has been

8 approved under Section 70.

Section 30. Relocation assistance. The Commission shall provide relocation assistance to persons and entities displaced by the Commission's acquisition of property and improvement of the District. Relocation assistance shall not be less than provided under the federal Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and the regulations under that Act, including the eligibility criteria. Relocation assistance may include assistance with the moving of a residential unit to a new location. The Commission shall establish a single point of contact for all relocation assistance under this Section.

Section 35. Bonds. To obtain the funds necessary for financing the acquisition of land, for the acquisition, construction, maintenance, and rehabilitation of facilities and equipment within the District, and for the operation of the District as set forth in this Act, the Commission may borrow money from any public or private agency, department, corporation, or person. In evidence of and as security for funds borrowed, the Commission may issue revenue bonds in its corporate capacity to be payable from the revenues derived from the operation of the institutions or buildings owned, leased, or operated by or on behalf of the Commission, but the bonds shall in no event constitute an indebtedness of the Commission or a claim against the property of the Commission.

1 The bonds may be issued in such denominations as may be 2 expedient, in such amounts, and at such rates of interest as the Commission shall deem necessary to provide sufficient 3 4 funds to pay all the costs authorized under this Section. The 5 bonds shall be executed by the President of the Commission, 6 attested by the Secretary, and sealed with the Commission's 7 corporate seal. If either of those officers of the Commission who shall have signed or attested any of the bonds shall have 8 9 ceased to be such officer before delivery of the bonds, signature of the officer shall be valid and sufficient to the 10 11 same effect as if the officer had remained in office at the time of delivery. The Commission shall furnish the State 12 Comptroller with a record of all bonds issued under this Act. 13

Section 40. Power to sell or lease. The Commission may sell, convey, transfer, or lease, all at fair market value, any title or interest in real property owned by it to any person or persons, to be used, subject to the restrictions of this Act, for the purposes stated in Section 25, or for the purpose of serving persons using the facilities offered within the District or for carrying out of any aspect of the Commission's purposes as set forth in Section 10 of this Act, subject to such restrictions as to the use of the real property as the Commission shall determine will carry out the purpose of this Act. To assure that the use of the real property so sold or leased is in accordance with the provisions of this Act, the Commission shall inquire into and satisfy itself concerning the financial ability of purchaser to complete the project for which the real property is sold or leased in accordance with a plan to be presented by the purchaser or lessee, which plan shall be submitted, in writing, to the Commission. Under the plan, the purchaser or lessee shall undertake (1) to use the land for the purposes designated in the plan so presented; (2) to commence and

1 complete the construction of the buildings or other 2 structures to be included in the project within such periods of time as the Commission fixes as reasonable; and (3) to 3 4 comply with such other conditions as the Commission shall 5 determine are necessary to carry out the project. All 6 conveyances and leases authorized in this Section shall be on condition that, in the event of use for other than the 7 purposes prescribed in this Act, or of nonuse for a period of 8 9 one year, title to the property shall revert Commission. All conveyances and leases made by the Commission 10 11 to any corporation or person for the use of serving the residents or any person using the facilities offered within 12 the District shall be on condition that in the event of 13 violation of any of the restrictions as to the use of 14 15 property as the Commission shall have determined will carry 16 out the purposes of this Act, that title to the property shall revert to the Commission. If, however, the Commission 17 18 finds that financing necessary for the acquisition or 19 of any real estate or for the construction of any building or improvement to be used for purposes prescribed in this Act 20 cannot be obtained if title to the land or building or 2.1 improvement is subject to such a reverter provision, which 22 23 finding shall be made by the Commission after public hearing held pursuant to a single publication notice given in a 24 25 secular newspaper of general circulation in the City of Springfield at least 10 days before the date of the hearing, 26 27 the notice to specify the time, place, and purpose for hearing, and upon that finding being made, the Commission may 28 29 cause the real property to be conveyed free of a reverter 30 provision, provided that at least 10 members of Commission vote in favor thereof. The Commission may also 31 32 provide in the conveyances, leases, or other documentation provisions for notice of such violations or default and the 33 cure thereof for the benefit of any lender or mortgagee as 34

If, at a 2 regularly scheduled meeting, the Commission resolves that a parcel of real estate leased by it, or in which it has sold 3 4 the fee simple title or any lesser estate, is not being used 5 for the purposes prescribed in this Act or has been in nonuse 6 for a period of one year, the Commission may file a law suit 7 in the circuit court of Sangamon County to enforce the terms the sale or lease. 24 Section 45. Notice. Before holding any public hearing prescribed in Section 40 of this Act, or any meeting 25 regarding the passage of any resolution to file a law suit, 26 the Commission shall give notice to the grantee or lessee, or 27 28 his or her legal representatives, successors, or assigns, of 29 the time and place of the proceeding. The notice shall be accompanied by a statement signed by the Secretary of the 30 31 Commission, or by any person authorized by the Commission to sign the same, setting forth any act or things done or 32 33 omitted to be done in violation, or claimed to be in

- 1 violation, of any restriction as to the use of the property,

- Section 60. Judicial review. Any party may obtain a

- 29 court shall take judicial notice of all the rules of practice

1 Section 65. Parks. The Commission may set apart any 2 part of the District as a park, except those areas owned, operated, or used for purposes authorized under this Act by 3 4 organizations or institutions engaged in the delivery or conduct of health care services, education, or research, and 5 may construct, control, and maintain the same or may provide 6 7 by contract with the Springfield Park District or the City of 8 Springfield for the construction, control, and maintenance of 9 any area within the District set apart as a park.

Section 70. Master plan; improvement and management of District. The Commission shall prepare and approve comprehensive master plan for the orderly development and management of all property within the District. The master plan, and any amendment to the master plan, shall not take effect, however, until it has been approved by the council and the Springfield city council.
