- 20 pitcher Steve Kline and was Kline's guest in the Cardinal's
- 21 clubhouse just before he had a heart transplant in September,

- 24 and enjoyed all sports, especially professional wrestling; he
- 25 also enjoyed music; Michael was a member of the Family,
- 26 Career and Community Leaders of America and attended the

- the youth program; and
