The Illinois Sport Wagering Act requires submission to the General Assembly of a report on sports wagering. Attached is the report on sports wagering for a 12 month period beginning in December 2022 and ending in November 2023. The section of statute that requires this report is below:

(230 ILCS 45/25-105)

Sec. 25-105. Report to General Assembly. On or before January 15, 2021 and every January 15 thereafter, the Board shall provide a report to the General Assembly on sports wagering conducted under this Act.
