SENATE RESOLUTION NO. 178

WHEREAS, On March 31, 2023, President Joseph R. Biden proclaimed April 2023 as Second Chance Month and called upon all government officials, educators, volunteers, and all the people of the United States to observe the month with appropriate programs, ceremonies, and activities; and

WHEREAS, A criminal record can prevent individuals from landing a steady job, a safe place to live, quality health care, or the chance to go to back school; and

WHEREAS, A criminal record can keep someone from ever getting a loan to buy a home, start a business, or build a future; and

WHEREAS, A criminal record can bar an individual from voting; and

WHEREAS, Three-quarters of formerly incarcerated people remain unemployed a year after their release, and joblessness is a top predictor of recidivism; and

WHEREAS, The U.S. Department of Justice's Office of Justice Programs, Bureau of Justice Assistance and Office of Juvenile Justice and Delinquency Prevention are supporting Second Chance Month to help individuals, communities, and agencies across the country recognize the importance of reentry and their role in supporting safe and successful reentry; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare April of 2023 as "Second Chance Month" in the State of Illinois.

Senator Preston offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 179

WHEREAS, The Tennessee House of Representatives recently expelled two fellow lawmakers from the state legislature for their role in a protest calling for more gun control in the aftermath of the deadly school shooting at the Covenant School in Nashville, where six people were killed, including three children; and

WHEREAS, Of the three representatives who were involved in the protest, Reps. Gloria Johnson, Justin Jones, and Justin Pearson, only the latter two were expelled; and

WHEREAS, Reps. Jones and Pearson are Black, while Rep. Johnson is white; and

WHEREAS, Tennessee House leadership has denied that race was a factor, alleging that Reps. Jones and Pearson were trying to incite a riot at the protest, while Rep. Johnson was more subdued; and

WHEREAS, President Joe Biden has called the expulsions shocking, undemocratic, and without precedent; and

WHEREAS, Expulsion from the chamber is a move the Tennessee House has used only a handful times since the Civil War under distinctly different circumstances, including accusations of sexual misconduct and misuse of federal grant money; and

WHEREAS, While most state legislatures have the power to expel members, it is generally reserved as a punishment for lawmakers accused of serious misconduct, not used as a weapon against political opponents; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we condemn the actions taken by the Tennessee House of Representatives on their racist action of expelling and silencing two Black lawmakers duly elected by Tennesseans.

WHEREAS, March 25th commemorates the anniversary of Greek Independence Day, which honors the beginning of the War of Greek Independence in 1821; and

WHEREAS, On this day, the Greek community celebrates the bravery of its ancestors in their struggles and their relentless determination to ensure the survival of Greek heritage, culture, and religion; and

WHEREAS, In 1453, with the seizure of Constantinople, Greece unwillingly became part of the Ottoman Empire; for 400 years thereafter, the Greek people were forced to relinquish their customs, language, traditions, and, most importantly, their freedom; while many Greeks fled to Western Europe, countless others who were unable to flee were subjected to many forms of oppression; and

WHEREAS, On March 25, 1821, Bishop Germanos of Patras raised the flag of revolution at the Monastery of Agia Lavra and declared, "Eleftheria I Thanatos" ("Freedom or Death"), which became the cry of the War of Greek Independence; this single act is credited with inciting the people of Greece to unite together to stage a revolution and defeat the Ottoman Empire; and

WHEREAS, While the Greek armies won many battles, they were in danger of losing the War of Greek Independence by 1827; it was then that Great Britain, France, and Russia interceded, assisting the Greeks with overpowering the Ottoman Empire forces; and

WHEREAS, On September 14, 1829, the War of Greek Independence ended with the signing of the Treaty of Edirne, which is also known as the Treaty of Adrianople; with the signing of the Treaty of Edirne, the Ottoman Empire was forced to recognize Greece as an autonomous state; and

WHEREAS, In observance of Greek Independence Day, special events are held around the world, including parades, military processions, speeches, and festivals; and

WHEREAS, The contributions of Greek culture on modern civilizations are innumerable, influencing the world in every way imaginable, from the fields of mathematics, astronomy, science, and medicine to literature, theater, philosophy, and democracy; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare March 25, 2023 as Greek Independence Day in the State of Illinois.
