Senator Jacobs offered the following Senate Joint Resolution, which was referred to the Committee on Rules:

SENATE JOINT RESOLUTION NO. 6

WHEREAS, It is the goal of the Illinois General Assembly to encourage individuals to save for unexpected health care expenses through appropriate tax incentives; and

WHEREAS, Ensuring the efficient use of health care resources and encouraging access to affordable health care is of primary concern to the citizens of Illinois; and

WHEREAS, A little-known federal tax law is forcing some of this State's citizens to annually forfeit part of their salary to their employer; and

WHEREAS, This forfeiture is required at the end of each year for the total amount of a worker's unused money in the worker's flexible savings accounts (FSAs); and

WHEREAS This egregious penalty is contained in Section 125 of the current Internal Revenue Service tax code's "use it or lose it" rule; and

WHEREAS, This outdated tax policy discourages savings and encourages Americans to spend money, even on unnecessary services, rather than lose the money entirely; and

WHEREAS, The "use it or lose it" rule is inconsistent with the priorities of the citizens of Illinois; and

WHEREAS, Only an estimated one-fifth of workers eligible to contribute to an FSA do so today; and

WHEREAS, The "use it or lose it" rule is a major reason workers choose not to participate in FSAs: and

WHEREAS, Allowing workers to carry over any unused FSA funds would empower them with greater choice and control over how they spend their health care dollars; and

WHEREAS, Allowing contributions to be carried over in an FSA would encourage efficiency and personal savings for future health care spending and benefit a significant number of American workers; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we respectfully urge the Congress of the United States to adopt legislation to allow amounts elected by American workers for reimbursement of medical care expenses under a health flexible spending arrangement, as defined in the Internal Revenue Service Code Section 106(c)(2) and the regulations promulgated under Section 125, to be carried over to subsequent plan years without penalty of any kind: and be it further

RESOLVED, That FSA funds may be used for the payment of COBRA or State continuation coverage after the individual has become separated from employment; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to each member of the Illinois Congressional delegation, the Speaker of the United States House of Representatives, the Majority Leader of the United States Senate, the President of the United States, and the Secretary of the Department of the Treasury.

SENATE JOINT RESOLUTION NO. 7 CONSTITUTIONAL AMENDMENT

RESOLVED, BY THE SENATE OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 1 of Article IV of the Illinois Constitution as follows:

ARTICLE IV THE LEGISLATURE

(ILCON Art. IV, Sec. 1)

SECTION 1. LEGISLATURE - POWER AND STRUCTURE

The legislative power <u>is</u> is vested in a General Assembly consisting of a Senate and a House of Representatives, elected by the electors from 59 Legislative Districts and 118 Representative Districts. (Source: Amendment adopted at general election November 4, 1980.)

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.

SENATE JOINT RESOLUTION NO. 8 CONSTITUTIONAL AMENDMENT

RESOLVED, BY THE SENATE OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 1 of Article IX of the Illinois Constitution as follows:

ARTICLE IX REVENUE

(ILCON Art. IX, Sec. 1)

SECTION 1. STATE REVENUE POWER

The General Assembly <u>has</u> has the exclusive power to raise revenue by law except as limited or otherwise provided in this Constitution. The power of taxation shall not be surrendered, suspended, or contracted away. (Source: Illinois Constitution.)

SENATE JOINT RESOLUTION NO. 9

CONSTITUTIONAL AMENDMENT

RESOLVED, BY THE SENATE OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 1 of Article 1 of the Illinois Constitution as follows:

ARTICLE I BILL OF RIGHTS

(ILCON Art. I, Sec. 1)

SECTION 1. INHERENT AND INALIENABLE RIGHTS

All men are by nature free and independent and and have certain inherent and inalienable rights among which are life, liberty and the pursuit of happiness. To secure these rights and the protection of property, governments are instituted among men, deriving their just powers from the consent of the governed. (Source: Illinois Constitution.)

Senator E. Jones offered the following Senate Joint Resolution, which was ordered printed and referred to the Committee on Rules:

SENATE JOINT RESOLUTION NO. 10 CONSTITUTIONAL AMENDMENT

RESOLVED, BY THE SENATE OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 1 of Article V of the Illinois Constitution as follows:

ARTICLE V THE EXECUTIVE

(ILCON Art. V, Sec. 1) SECTION 1. OFFICERS

The Executive Branch shall shall include a Governor, Lieutenant Governor, Attorney General, Secretary of State, Comptroller and Treasurer elected by the electors of the State. They shall keep the public records and maintain a residence at the seat of government during their terms of office. (Source: Illinois Constitution.)

Senator E. Jones offered the following Senate Joint Resolution, which was ordered printed and referred to the Committee on Rules:

SENATE JOINT RESOLUTION NO. 11 CONSTITUTIONAL AMENDMENT

RESOLVED, BY THE SENATE OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 1 of Article X of the Illinois Constitution as follows:

ARTICLE X EDUCATION

(ILCON Art. X, Sec. 1)

SECTION 1. GOAL - FREE SCHOOLS

A fundamental goal of the the People of the State is the educational development of all persons to the limits of their capacities.

The State shall provide for an efficient system of high quality public educational institutions and services. Education in public schools through the secondary level shall be free. There may be such other free education as the General Assembly provides by law.

The State has the primary responsibility for financing the system of public education. (Source: Illinois Constitution.)

SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.

Senator Lauzen offered the following Senate Joint Resolution, which was ordered printed and referred to the Committee on Rules:

SENATE JOINT RESOLUTION NO. 12 CONSTITUTIONAL AMENDMENT

WHEREAS, We are, in the words of President Abraham Lincoln, a "government of the people, by the people, and for the people"; and

WHEREAS, An amendment to the Illinois Constitution built upon the Lincoln principles of government will serve to strengthen our democracy; and

WHEREAS, The petition rights of our citizens are central to our form of self-government; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Sections 1 and 8 of Article IV of the Constitution as follows:

ARTICLE IV THE LEGISLATURE

(ILCON Art. IV, Sec. 1)

SECTION 1. LEGISLATURE - POWER AND STRUCTURE

- (a) Except as provided in subsection (b), the legislative power is vested in a General Assembly consisting of a Senate and a House of Representatives, elected by the electors from 59 Legislative Districts and 118 Representative Districts.
- (b) The electors reserve to themselves the legislative power to propose bills by petition for consideration by the General Assembly as provided in subsection (b-5) of Section 8. (Source: Amendment adopted at general election November 4, 1980.)

(ILCON Art. IV. Sec. 8)

SECTION 8. PASSAGE OF BILLS

- (a) The enacting clause of the laws of this State shall be: "Be it enacted by the People of the State of Illinois, represented in the General Assembly."
- (b) The General Assembly shall enact laws only by bill. Except as provided in subsection (b-5), bills may originate in either house, but may be amended or rejected by the other.
- (b-5) Bills may be proposed by a petition signed by a number of electors equal in number to at least 6% of the total votes cast for candidates for Governor in the preceding gubernatorial election. A petition shall contain the text of the bill, shall have been signed by the petitioning electors not more than one year preceding the filing of the petition, and shall be filed with the Secretary of State not earlier than the second Wednesday in January in any year and not later than the fourth Wednesday in March in that year. The procedure for determining the validity and sufficiency of a petition shall be provided by law, but the procedure shall take not longer than 30 days.

If a petition is determined to be valid and sufficient as provided by law, the bill proposed by the petition shall be proposed to the members of the House of Representatives by the Speaker of the House of Representatives and to the members of the Senate by the President of the Senate. The bill may not be amended by either house. A record vote of all the members of the House of Representatives and all the members of the Senate shall be taken on the bill not more than 30 days after the petition is determined to be valid and sufficient.

- (c) No bill shall become a law without the concurrence of a majority of the members elected to each house. Final passage of a bill shall be by record vote. In the Senate at the request of two members, and in the House at the request of five members, a record vote may be taken on any other occasion. A record vote is a vote by yeas and nays entered on the journal.
- (d) A bill shall be read by title on three different days in each house. A bill and each amendment thereto shall be reproduced and placed on the desk of each member before final passage.

Bills, except bills for appropriations and for the codification, revision or rearrangement of laws, shall be confined to one subject. Appropriation bills shall be limited to the subject of appropriations.

A bill expressly amending a law shall set forth completely the sections amended.

The Speaker of the House of Representatives and the President of the Senate shall sign each bill that passes both houses to certify that the procedural requirements for passage have been met. (Source: Illinois Constitution.)

Senator Lauzen, offered the following Senate Joint Resolution, which was ordered printed and referred to the Committee on Rules:

SENATE JOINT RESOLUTION NO. 13 CONSTITUTIONAL AMENDMENT

RESOLVED, BY THE SENATE OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend the Illinois Constitution by changing Section 14 of and adding Section 14.5 to Article IV, changing Section 6 of Article V, and changing Section 15 of Article VI as follows:

ARTICLE IV THE LEGISLATURE

(ILCON Art. IV, Sec. 14) SECTION 14. IMPEACHMENT

The House of Representatives of the General Assembly has the sole power to conduct legislative investigations to determine the existence of cause for impeachment and, by the vote of a majority of the members elected, to impeach Executive and Judicial officers. Impeachments shall be tried by the Senate. When sitting for that purpose, Senators shall be upon oath, or affirmation, to do justice according to law. If the Governor is tried, the Chief Justice of the Supreme Court shall preside. No person shall be convicted without the concurrence of two-thirds of the Senators elected. Judgment shall not extend beyond removal from office and disqualification to hold any public office of this State. An impeached officer, whether convicted or acquitted, shall be liable to prosecution, trial, judgment and punishment according to law. (Source: Illinois Constitution.)

SECTION 14. 5. RECALL OF GENERAL ASSEMBLY MEMBERS ARTICLE V

THE EXECUTIVE

(ILCON Art. V, Sec. 6)

SECTION 6. GUBERNATORIAL SUCCESSION

- (a) In the event of a vacancy, the order of succession to the office of Governor of Illinois or to the position of Acting Governor shall be the Lieutenant Governor, the elected Attorney General, the elected Secretary of State, and then as provided by law.
- (b) If the Governor is unable to serve because of death, conviction on impeachment, failure to qualify, resignation or other disability, the office of Governor shall be filled by the officer next in line of succession for the remainder of the term or until the disability is removed.
- (c) Whenever the Governor determines that he may be seriously impeded in the exercise of his powers, he shall so notify the Secretary of State and the officer next in line of succession. The latter shall thereafter become Acting Governor with the duties and powers of Governor. When the Governor is prepared to resume office, he shall do so by notifying the Secretary of State and the Acting Governor.
- (d) The General Assembly by law shall specify by whom and by what procedures the ability of the Governor to serve or to resume office may be questioned and determined. The Supreme Court shall have original and exclusive jurisdiction to review such a law and any such determination and, in the absence of such a law, shall make the determination under such rules as it may adopt. (Source: Illinois Constitution.)

ARTICLE VI THE JUDICIARY

(ILCON Art. VI, Sec. 15)

SECTION 15. RETIREMENT - DISCIPLINE

- (a) The General Assembly of Illinois may provide by law for the retirement of Judges and Associate Judges at a prescribed age. Any retired Judge or Associate Judge, with his or her consent, may be assigned by the Supreme Court to judicial service for which he or she shall receive the applicable compensation in lieu of retirement benefits. A retired Associate Judge may be assigned only as an Associate Judge.
- (b) A Judicial Inquiry Board is created. The Supreme Court shall select two Circuit Judges as members and the Governor shall appoint four persons who are not lawyers and three lawyers as

members of the Board. No more than two of the lawyers and two of the non-lawyers appointed by the Governor shall be members of the same political party. The terms of Board members shall be four years. A vacancy on the Board shall be filled for a full term in the manner the original appointment was made. No member may serve on the Board more than eight years.

- (c) The Board shall be convened permanently, with authority to conduct investigations, receive or initiate complaints concerning a Judge or Associate Judge, and file complaints with the Courts Commission. The Board shall not file a complaint unless five members believe that a reasonable basis exists (1) to charge the Judge or Associate Judge with willful misconduct in office, persistent failure to perform his duties, or other conduct that is prejudicial to the administration of justice or that brings the judicial office into disrepute, or (2) to charge that the Judge or Associate Judge is physically or mentally unable to perform his duties. All proceedings of the Board shall be confidential except the filing of a complaint with the Courts Commission. The Board shall prosecute the complaint.
- (d) The Board shall adopt rules governing its procedures. It shall have subpoena power and authority to appoint and direct its staff. Members of the Board who are not Judges shall receive per diem compensation and necessary expenses; members who are Judges shall receive necessary expenses only. The General Assembly by law shall appropriate funds for the operation of the Board.
- (e) An independent Courts Commission is created consisting of one Supreme Court Judge selected by that Court as a member and one as an alternate, two Appellate Court Judges selected by that Court as members and three as alternates, two Circuit Judges selected by the Supreme Court as members and three as alternates, and two citizens selected by the Governor as members and two as alternates. Members and alternates who are Appellate Court Judges must each be from a different Judicial District. Members and alternates who are Circuit Judges must each be from a different Judicial District. Members and alternates of the Commission shall not be members of the Judicial Inquiry Board. The members of the Commission shall select a chairperson to serve a two-year term.

The Commission shall be convened permanently to hear complaints filed by the Judicial Inquiry Board. The Commission shall have authority after notice and public hearing, (1) to remove from office, suspend without pay, censure or reprimand a Judge or Associate Judge for willful misconduct in office, persistent failure to perform his or her duties, or other conduct that is prejudicial to the administration of justice or that brings the judicial office into disrepute, or (2) to suspend, with or without pay, or retire a Judge or Associate Judge who is physically or mentally unable to perform his or her duties.

- (f) The concurrence of four members of the Commission shall be necessary for a decision. The decision of the Commission shall be final.
- (g) The Commission shall adopt comprehensive rules to ensure that its procedures are fair and appropriate. These rules and any amendments shall be public and filed with the Secretary of State at least 30 days before becoming effective.
- (h) A member of the Commission shall disqualify himself or herself, or the other members of the Commission shall disqualify a member, with respect to any proceeding in which disqualification or recusal would be required of a Judge under rules of the Supreme Court, under rules of the Commission, or by law.

If a Supreme Court Judge is the subject of a proceeding, then there shall be no Supreme Court Judge sitting as a member of the Commission with respect to that proceeding. Instead, an alternate Appellate Court Judge not from the same Judicial District as the subject Supreme Court Judge shall replace the subject Supreme Court Judge. If a member who is an Appellate Court Judge is the subject of a proceeding, then an alternate Appellate Court Judge shall replace the subject Appellate Court Judge. If an Appellate Court Judge who is not a member is the subject of a proceeding and an Appellate Court Judge from the same Judicial District is a member, then an alternate Appellate Court Judge shall replace that member. If a member who is a Circuit Judge is the subject of a proceeding, then an alternate Circuit Judge shall replace the subject Circuit Judge. If a Circuit Judge who is not a member is the subject of a proceeding and a Circuit Judge from the same Judicial District is a member, then an alternate Circuit Judge shall replace that member.

If a member of the Commission is disqualified under this Section with respect to any proceeding, that member shall be replaced by an alternate on a rotating basis in a manner provided by rule of the Commission. The alternate shall act as member of the Commission with respect to that proceeding only

- (i) The Commission shall have power to issue subpoenas.
- (j) Members and alternates of the Commission who are not Judges shall receive per diem compensation and necessary expenses; members and alternates who are Judges shall receive necessary expenses only. WHEREAS, The members of Senate of the Ninety-Third General Assembly of Illinois were saddened to learn of the death of Eleanor "Sis" Daley on Sunday, February 16, 2003 at her home in her Bridgeport neighborhood of Chicago at the age of 95; and

WHEREAS, Mrs. Daley has been fittingly called Chicago's matriarch because she was the wife of the late Mayor Richard J. Daley and the mother of three politically prominent sons, two of whom, John and Richard M., served in this body before holding their respective current political offices of Cook County Commissioner and Mayor of Chicago, the third being William, the former United State's Secretary of Commerce; and

WHEREAS, Mrs. Daley was never greatly impressed by the trappings of high office, preferring to be out of the political limelight, where she provided her husband with shelter from his governmental and political duties and raised her seven children in a strict but loving manner, in a household where religion, education, and respect for others shared equal attention; and

WHEREAS, Mrs. Daley was born on March 4, 1907, sharing her birthday with Chicago, which was incorporated as a city on that day in 1837; she was the eighth of 11 children of Patrick and Nora Guilfoyle; and

WHEREAS, Both of her parents were Chicago-born immigrants from Ireland, her father working as a butcher in the Chicago Stockyards while the family lived in a home at 2949 South Troop Street; and

WHEREAS, Mrs. Daley was introduced to Richard J. Daley by her brother Lloyd at a softball game when she was a teenager and Daley was a law student, playing second base for the Hamburg Athletic Team Club; and

WHEREAS, By the time they started dating, Mrs. Daley had graduated from St. Mary's High School and St. Bridget's Commercial and was working as a secretary when their six-year courtship began; and

WHEREAS, Mrs. Daley and her husband were married in June 1936, and their two-week honeymoon was taken in the midst of Daley's first political campaign, which was a successful run

for State Representative; and

WHEREAS, The family's home, a bungalow at 3536 South Lowe Avenue in the heart of their native Bridgeport, was built by them in 1939 and would expand over the years to accommodate their growing family, which would include seven children: Patricia, Mary Carol, Eleanor, Richard, Michael, John and William; and

WHEREAS, When Richard J. Daley was elected mayor in 1955, little changed for Mrs. Daley, who concentrated on raising a family, taking care of her home, and providing Mayor Daley with a secure and peaceful refuge from the demands of his public schedule; and

WHEREAS, When the Daley's celebrated their 40th anniversary in 1976, the former Mayor Daley shared his feelings about his wife at a press conference as follows: "The secret is to get a good wife and a good companion. We've had a very happy marriage and we have a great family and there's been no great differences between us."; and

WHEREAS, Mrs. Daley again moved largely into the background after her son's election as mayor, enjoying the visits of her children, grandchildren, and great-grandchildren to her home in Bridgeport; and

WHEREAS, Mrs. Daley's public appearances have been few in recent years; on March 4, 2000, she acted as hostess of Chicago's 163rd birthday party at the Water Tower on North Michigan Avenue; and

WHEREAS, In her 90s, Mrs. Daley continued to enjoy listening to music and reading, rooting for her beloved Chicago White Sox, visiting her husband's grave twice a week, attending church, and taking pride in the accomplishments of her children and their children's children, which included watching her son William be named Secretary of Commerce by President Bill Clinton; and

WHEREAS, Mrs. Daley will long be remembered by all who knew her as a warm and unassuming person, with a good sense of humor and an abiding love for her family, her neighborhood, and Chicago; and

WHEREAS, Mrs. Daley's passing will be deeply felt by all who knew and loved her, especially her four sons, Richard M., John, William, and Michael; her two daughters, Mary Carol and Patricia; and her several grandchildren and great grandchildren: therefore be it
