PROCLAMATION

04-204

WHEREAS, the Illinois Constitution requires the General Assembly to make appropriations for the expenditures of public funds for the fiscal year for State departments, authorities, and public agencies; and

WHEREAS, the General Assembly has not made appropriations for fiscal year 2005 for the expenditure of public funds for the Children's Place Program within the Department of Human Services; and

WHEREAS, there are currently many children and families throughout the State of Illinois who are affected by HIV/AIDS; and

WHEREAS, the Children's Place Program provides day care and other services for children and families throughout the State who are affected by HIV/AIDS;

THEREFORE, pursuant to Article IV, Section 5(b) of the Illinois Constitution of 1970, I hereby call and convene the 93rd General Assembly in a special session to commence on July 12, 2004, at 4:00 p.m., to consider any legislation (new or pending), which will address directly the budget of the Department of Human Services for the Children's Place Program for fiscal year 2005.

SENATE RESOLUTION NO. 2

RESOLVED, BY THE SENATE OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, AT THE ELEVENTH SPECIAL SESSION THEREOF, that the President appoint a committee of five to wait upon his Excellency, the Governor, and inform him that the Eleventh Special Session of the Ninety-Third General Assembly is now duly in session in pursuance of his proclamation, and is ready to receive any message he may desire to submit.

And the resolution was adopted.

Senator Halvorson offered the following Senate Resolution and, having asked and obtained unanimous consent to suspend the rules for its immediate consideration, moved its adoption:

SENATE RESOLUTION NO. 3

RESOLVED, BY THE SENATE OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, AT THE ELEVENTH SPECIAL SESSION THEREOF, that a Committee of three (3) members of the Senate be appointed, two (2) members to be appointed by the President and one (1) member to be appointed by the Minority Leader, to approve any and all Journals of the Senate for all days of the Eleventh Special Session of the Ninety-Third General Assembly where such Journals, prior to adjournment SINE DIE, have not been approved by the body as a whole.
