WHEREAS, The members of the Senate of the State of Illinois congratulate Rotary International on its 100th anniversary; and

WHEREAS, To celebrate Rotary's centennial anniversary, the organization is taking time to reflect on all its accomplishments over the years; throughout 2005, there will be several events and volunteer efforts that will carry on the spirit of service to the community that began so many years ago; and

WHEREAS, Rotary International was established in Chicago on February 23, 1905 by Paul P. Harris; Mr. Harris founded Rotary International with the mission of promoting benevolence amongst club members and the community; as Rotary International began to expand, so did its mission of service to the community; with a motto of "Service Above Self", they inspire members to provide humanitarian service, encourage high ethical standards, and promote good will and peace throughout the world; and

WHEREAS, The Rotary Foundation, a not-for-profit organization, was formed in 1928 for the purpose of funding the many projects sponsored by Rotary International; today, contributions to the foundation total more than \$80 million dollars annually; this money supports a wide range of programs that enable citizens of the world to function better within their communities; and

WHEREAS, In 1985, Rotary International began one of its most ambitious missions, and that was to eradicate the world of polio; through their program, Polio Plus, they coordinated with the World Health Organization, U.S. Centers for Disease Control and Prevention, and UNICEF to provide polio immunizations to children around the world; and

WHEREAS, Rotary International has grown exponentially over the last 100 years; from its humble beginnings in Chicago to a world-wide organization, Rotary now boasts 1.2 million members who belong to over 31,000 clubs in more than 165 countries; in Illinois alone, there are 14,500 Rotary members in 330 different clubs; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FOURTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we do hereby proclaim February 23, 2005 as Rotary International Day in Illinois and encourage all citizens to be cognizant of the many great services this organization provides to people throughout the world.

Senator del Valle offered the following Senate Resolution, which was referred to the Committee on Rules:

SENATE RESOLUTION NO. 61

WHEREAS, The State of Illinois is a major center for news media; and

WHEREAS, The talent of the men and women who work in media is recognized, in part, by fair pay and benefits; and

WHEREAS, Chicago is the fourth-largest Spanish language media market in the country; and

WHEREAS, As a result of the rapid growth of the Latino population in Illinois, Spanish language media is becoming increasingly important in our State; and

WHEREAS, NBC, a subsidiary of General Electric, recognized the national importance and economic strength of the Latino community by its decision to purchase the Telemundo Television Network and its fifteen owned and operated stations for \$1.98 billion in 2001; and

WHEREAS, NBC owns and operates WMAQ, its English language outlet, and WSNS, the Telemundo Spanish language outlet in Chicago; and

WHEREAS, NBC spent more than \$10 million to create a single newsroom for the English-speaking and Spanish-speaking journalists in its employ; and

WHEREAS, NBC should treat its new Spanish-speaking employees with the same professional respect as it extends to its English language employees; and

WHEREAS, NBC should provide its Spanish language broadcasters with the same level of comparable wages, benefits, and working conditions as its English language newspersons; and

WHEREAS, The on-air newspersons at WSNS-TV Telemundo voted for representation by the American Federation of Television and Radio Artists, AFL-CIO (AFTRA) which represents more than 3,000 performers and broadcasters in the State of Illinois, including the 43 English-speaking journalists employed by NBC's WMAQ; and

WHEREAS, This successful vote for union representation was won after a hard fought campaign in which the support for the Telemundo broadcasters by the WSNS viewing audience and Latino community organizations throughout Chicago was critically important; and

WHEREAS, NBC/Telemundo and AFTRA have been negotiating for a first contract for nearly two years with little progress; and

WHEREAS, NBC/Telemundo has not offered its Spanish-speaking journalists wages, benefits, and working conditions comparable to the terms it provides to its English-speaking journalists on WMAQ even though they share work and a newsroom; and

WHEREAS, After nearly two years, it is past time for NBC/Telemundo to reach an overall collective bargaining agreement that is fair to the Spanish-speaking journalists who appear on WSNS; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FOURTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that by adoption of this resolution, the Senate of the State of Illinois urges NBC/Telemundo to meet with the American Federation of Television and Radio Artists and negotiate in good faith a contract for WSNS-TV Telemundo broadcast journalists.

WHEREAS, Many places in Illinois are significant sites of local, state, national, and world history; and

WHEREAS, Visitors to these sites learn about historic people, ideas, and developments; and

WHEREAS, History helps us understand our place in the world and how we might improve it; and

WHEREAS, Increasing visits to historical sites stimulates beautification, preservation, conservation, tourism, and business in Illinois communities and counties where they are located; and

WHEREAS, The Illinois State Historical Society, recognized by the Illinois General Assembly in 1903 as a major contributor to the awareness and appreciation of history in Illinois, has already placed its markers at more than four hundred historical sites around the State; and

WHEREAS, The Illinois General Assembly and The Illinois State Historical Society now seek to heighten historical awareness in Illinois residents and visitors by calling attention to these markers and historic sites throughout the State; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FOURTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the week of February 28 through March 6 in 2005 shall be known as Illinois State Historical Society Markers Awareness Week with a special State ceremony in Springfield on March 3; and be it further

RESOLVED, That all Illinois residents and visitors are encouraged to celebrate this week by learning about historic sites in their locales, visiting them, reflecting on their importance in history, communicating with others about them, and attending ceremonies commemorating them; and be it further

RESOLVED, That Illinois State Senators are encouraged to participate in the events of this week with their colleagues in the Capitol and their constituents in their home districts.
