RESOLVED, BY THE SENATE OF THE NINETY-FOURTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that a Court System Committee be created to investigate ways to ease the backlog of cases in the court system by utilizing retired judges on a part-time or temporary basis; in its investigation, at a minimum, the Committee shall consider the use of retired judges as both hearing officers and arbitrators; and be it

RESOLVED, That the Committee shall take into account the effect that appointing retired judges to these positions shall have on the retired judges' pensions and shall look for ways in which to minimize the effect on the retired judges' pensions; and be it further

RESOLVED, That the Committee shall consist of the following: the President of the Senate, the Minority Leader of the Senate, the Speaker of the House of Representatives, and the Minority Leader of the House of Representatives shall each appoint one member, and the Chief Justice of the Supreme Court is asked to appoint two members; and be it further

RESOLVED, That the Court System Committee shall submit a written report of its findings and recommendations to the General Assembly no later than November 1, 2005.

**SENATE JOINT RESOLUTION NO. 23  
CONSTITUTIONAL AMENDMENT**

RESOLVED, BY THE SENATE OF THE NINETY-FOURTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Section 9 to Article XIII of the Illinois Constitution as follows:

ARTICLE XIII  
GENERAL PROVISIONS

SECTION 9. SAME SEX MARRIAGE

Only marriage between one man and one woman shall be valid or recognized in Illinois. The uniting of persons of the same sex in a civil union, domestic partnership, or other similar same sex relationship shall not be valid or recognized in Illinois.

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.

CONSTITUTIONAL AMENDMENT**

RESOLVED, BY THE SENATE OF THE NINETY-FOURTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 2 of Article III of the Illinois Constitution as follows:

ARTICLE III  
SUFFRAGE AND ELECTIONS

SECTION 2. VOTING DISQUALIFICATIONS

A person convicted of a felony, or otherwise under sentence in a correctional institution or jail, or civilly committed as a sexually dangerous person or as a sexually violent person, shall lose the right to vote, which right shall be restored not later than upon completion of his sentence or civil commitment.
