SENATE RESOLUTION NO. 980

Offered by Senator Althoff and all Senators: Mourns the death of Judith A. Hutchinson of Spring Grove.

SENATE RESOLUTION NO. 982

Offered by Senator Harmon and all Senators: Mourns the death of David E. Linde of Oak Park.

Senator Barickman offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 981

WHEREAS, Operation Endangered Species seeks to address the recognized needs of all State agencies, as well as the plight of organisms threatened with extinction through the empowerment of students in classrooms across the State to cooperate, collaborate, and create a template which reaches across many disciplines, easily adapts to any endangered species, and creates a curriculum template for giving students the tools to take action; and

WHEREAS, Operation Endangered Species' mission is to engineer innovated education techniques to better educate students in order to protect and bring back endangered species; and

WHEREAS, Operation Endangered Species was founded and established in 2011 at Pontiac Township High School; the program is currently in 11 schools with over 1,000 students; the organization started with 4 Alligator Snapping Turtles and now has 17; Mr. Ritter and Mr. Soares, along with their students, plan to have 5,000 turtles by 2021; and

WHEREAS, Pontiac Township High School has been aided by a generous support donation from the State Farm Youth Advisory Board, Illinois State University, the Illinois Department of Natural Resources, and Tetra-Fauna for donating supplies and food for the Alligator Snapping Turtles; Dr. Brady Barr from National Geographic is also recognized for inspiring the project and for bestowing knowledge of endangered species; and

WHEREAS, Article XI, Section I of the Constitution of the State of Illinois states: "The public policy of the State and the duty of each person is to provide and maintain a helpful environment for the benefit of this and future generations"; Section II of the Constitution states that "each person has the right to a healthful environment. Each person may enforce this right against any party, governmental or private, through appropriate legal proceedings subject to reasonable limitation and regulation as the General Assembly may provide by law"; and

WHEREAS, Operation Endangered Species remains true to this plan and is continuing to expand; students are participating in the saving of a species and taking advantage of their right to improve the environment and their communities; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the date of March 20, 2014 as Endangered Species Day in the State of Illinois in hopes to gain national awareness for all endangered species; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Operation Endangered Species at Pontiac Township High School.

Senator Kotowski offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 983

WHEREAS, Epilepsy is a neurological disorder producing brief disturbances in the normal electrical functions of the brain that temporarily affects a person's consciousness, bodily movements, or sensations, while creating long-term effects on the lifestyle of individuals with epilepsy; and

WHEREAS, One in 26 people will develop epilepsy and one in 10 people will have an epileptic seizure during his or her lifetime; and

WHEREAS, Epilepsy can affect anyone regardless of their gender, race, age, religion, educational background, or socioeconomic status; and

WHEREAS, More people suffer from epilepsy than from Parkinson's Disease, multiple sclerosis, muscular dystrophy, and cerebral palsy combined; and

WHEREAS, Epilepsy affects more than 65 million people worldwide; and

WHEREAS, Although there is no known cure for epilepsy, existing drug therapy, surgery, and other nonpharmacological treatments enable approximately 80% of individuals with epilepsy to lead normal lives with no seizures or a significant reduction in seizures; and

WHEREAS, Epilepsy is a complex disorder that requires further research to find a cure and prevention; and

WHEREAS, The public is often unable to recognize common seizure types or to respond with appropriate first aid; and

WHEREAS, The annual observance of Purple Day on March 26 advocates for the rights, humane treatment, and appropriate education of all persons with epilepsy, while raising awareness with families, professionals, and the general public to better understand this lifelong disorder; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate March 26, 2014 as "Purple Day" and invite all citizens to participate by wearing purple; and be it further

RESOLVED, That we call upon all citizens, government agencies, public and private institutions, businesses, and schools to recommit our community to increasing awareness and understanding of epilepsy through education while ensuring that all individuals with epilepsy lead a full and productive life; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Kurt W. Florian, Jr., President and Chief Executive Officer of the Epilepsy Foundation of Greater Chicago, as an expression of our support for the purposes and goals of "Purple Day".

SENATE JOINT RESOLUTION NO. 60

WHEREAS, The Illinois Prescription Monitoring Program serves as a clinical tool to assist medical providers to better serve their patients while maximizing safety; the Program, in accordance with the enactment of Public Act 91-0576, began electronically collecting information on controlled substances dispensed in the State of Illinois on April 1, 2000; and

WHEREAS, The goal of the Illinois Prescription Monitoring Program is to assist prescribers and pharmacists in the effective treatment of patients seeking medical care, and the Illinois Prescription Monitoring Program website allows prescribers and pharmacists to view a current or prospective patient's prescription history; and

WHEREAS, The Illinois Prescription Monitoring Program has expanded its commitment to service and improved healthcare outcomes by helping prevent the misuse, abuse, and diversion of controlled substance medications; and

WHEREAS, The Illinois Prescription Monitoring Program is a component of and managed by the Illinois Department of Human Services and, through the services of the Illinois Prescription Monitoring Program, has improved the ability to serve healthcare providers in augmenting the effectiveness of patient care while similarly successfully helping to reduce healthcare costs and dramatically improve patient safety; and

WHEREAS, The access to the Illinois Prescription Monitoring Program website is available to physicians, pharmacists, dentists, veterinarians, physician assistants, and advanced practice nurses, as well as other prescribers and dispensers; and

WHEREAS, Last year, the Illinois Prescription Monitoring Program collected 16.4 million prescription records; 22,000 prescribers and dispensers referred to its clinical data on a regular basis; and

WHEREAS, Illinois is a participating state in the evolving national program of Prescription Monitoring Program services through the National Association of Boards of Pharmacy to facilitate interstate sharing of data with other participating states on the "Interconnect"; and

WHEREAS, Using the Illinois Prescription Monitoring Program website is voluntary, free to registrants, provides fully functional availability for mobile devices, and is accessible 24 hours per day and 7 days a week to provide immediate access to patient prescription history; and

WHEREAS, The Illinois Prescription Monitoring Program is built on the foundation of improving healthcare outcomes while not denying information as needed to assist law enforcement and placing paramount priority on HIPAA privacy requirements; and

WHEREAS, The use of the Illinois Prescription Monitoring Program in the evaluation of a patient's controlled substance history is a tool for prescribers and dispensers to incorporate into their daily practice to prevent the accidental overdose or potential drug interactions; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we designate the month of April of 2014 as "Illinois Prescription Monitoring Program Month" in the State of Illinois.
