**SENATE RESOLUTION NO. 1011**

[March 21, 2014]

WHEREAS, The State of Illinois, and much of the United States, has experienced historical cold and record levels of snowfall over the 2013-2014 winter; and

WHEREAS, Propane gas is how thousands of rural central Illinoisians heat their homes, normally a fairly cost-effective way to do so; 55,000,000 people in the U.S., most of them located in the Midwest or South, use propane to heat their homes; and

WHEREAS, The extreme winter has caused propane usage in Illinois to rise between 20% and 30%; the combination of high usage and historically low propane inventory levels has created a shortage; this shortage has caused prices for propane to jump considerably, putting an increased financial burden on those who use the gas; and

WHEREAS, Governor Pat Quinn has declared a propane emergency in Illinois, a first in State history, to try and ease the financial strain; this declaration eases driving regulations on trucks delivering propane from other states; and

WHEREAS, Various federal trucking regulations, most notably, weight limits for trucks on roads, limits the amount of propane that can be transported, contributing to the current shortage and increasing prices; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge President Barack Obama to temporarily increase the amount of trucking weight allowed on the country's interstate highways from 80,000 to 100,000, in to order ease the propane shortage, and in doing so, drive down the price of propane; and be it further

RESOLVED, That suitable copies of this resolution be presented to President Barack Obama, United States Secretary of Transportation Anthony Foxx, and Illinois Propane Gas Association Board President Jim Jackson.

Senator Hutchinson offered the following Senate Resolution, which was referred to the Committee on Assignments:

#### **SENATE RESOLUTION NO. 1012**

WHEREAS, The future of our nation's productivity and competitiveness in the global marketplace depends on the success of all men and women; and

WHEREAS, Women have been discriminated against in education, the workplace, and society as a whole; and

WHEREAS, Women continue to earn no more than 78 cents on the dollar compared to men; and

WHEREAS, The pay gap has been shown to start as soon as one year after college; this inequality affects not only women, but their families and society as a whole; and

WHEREAS, The pay gap between women and men has long-term effects on women's economic security; such a gap affects women's Social Security earnings, their ability to save for retirement, and their children's education; and

WHEREAS, Pay equity is closely linked to the eradication of poverty and is essential to having a highly-motivated workforce; and

WHEREAS, Equal Pay Day was originated by the National Committee on Pay Equity in 1996 as a public awareness event to illustrate the gap between men's and women's wages; the day, observed in April, symbolizes how far into the year a woman must work, on average, to earn as much as a man earned the previous year, with Tuesday being the day in which women's wages catch up to men's wages from the

previous week; because women earn less on average than men, they must work longer for the same amount of pay; this wage gap is even greater for most women of color; and

WHEREAS, Equal pay is a priority for all women and for our society at large; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate April 8, 2014 as Pay Equity Day in the State of Illinois in order to raise awareness about this endemic inequity.

Senator Althoff offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

**SENATE JOINT RESOLUTION NO. 61**

WHEREAS, The McHenry County Conservation District owns and manages the North Branch Conservation Area, formerly owned by the Eldredge family, where 2 separate tragedies befell a pair of brothers while serving as State conservation officers years apart; and

WHEREAS, Brothers G. Earle Eldredge and Charles Marcus Eldredge were employed by the Illinois Department of Resources and Conservation; and

WHEREAS, Game Warden G. Earle Eldredge served with distinction for 7 years until February 24, 1907 when he was shot while investigating a report of poachers on the family's game reserve near today's Village of Richmond; and

WHEREAS, Charles Marcus Eldredge was a successful attorney, elected to the Illinois General Assembly in 1896, and later became an inspector for the Illinois Department of Natural Resources and Conservation, serving for 24 years; and

WHEREAS, Charles Marcus Eldredge devoted his time to finding and prosecuting his brother's murderer and carried with him the gun of his brother to remind him at all times of his personal mission; and

WHEREAS, Charles Marcus Eldredge was found dead in 1931 at an entrance leading to a nature preserve near the site of his brother's murder in 1907, with the same gun having been used in the murder of both brothers; and

WHEREAS, Both men are the only Illinois Department of Natural Resource and Conservation Officers to have been murdered in the line of duty; and

WHEREAS, Both men have been recognized at the Illinois Department of Natural Resources, the Illinois Police Officers Memorial, and the National Memorial in Washington, D.C.; and

WHEREAS, Both men had their family roots tied to the McHenry County community and both died on McHenry County soil while in the line of duty; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we recognize G. Earle Eldredge and Charles Marcus Eldredge for their service and sacrifice; and be it further

RESOLVED, That the Department of Natural Resources is requested to erect at suitable locations within the nature preserve at Nippersink Creek, consistent with State and federal regulations, signage in remembrance of both G. Earle Eldredge and Charles Marcus Eldredge; and be it further

RESOLVED, That suitable copies of this resolution be delivered to both the Department of Natural Resources and the McHenry County Board.

Senator Rose offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

**SENATE JOINT RESOLUTION NO. 62**

WHEREAS, Emergency responders are constantly placed in danger while performing their duties, both from the dangerous conditions of their work and the hazardous locations where incidents occur; and

WHEREAS, On March 5, 2013, Hudson Community Fire Protection District volunteer firefighter Chris Brown was struck and killed by a motorist while working at the scene of a motor vehicle collision; and

WHEREAS, On October 30, 2013, Pontiac Police Department K9 Officer Casey Kohlmeier was struck and killed by a drunk driver while performing his duties on Interstate 55; and

WHEREAS, Many other emergency responders have been killed, injured, or placed in needless danger by similar incidents; and

WHEREAS, More comprehensive solutions are required to ensure that emergency responders are able to safely perform the vital duties they carry out for the citizens of our State; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there is created the Emergency Responder Roadway Safety Task Force to identify and recommend ways that the State of Illinois can increase the safety of emergency responders while they perform their duties; and be it further

RESOLVED, That the Task Force shall consist of the following members: one member appointed by the Speaker of the House of Representatives; one member appointed by the Minority Leader of the House of Representatives; one member appointed by the President of the Senate; one member appointed by the Minority Leader of the Senate; 2 members appointed by the Secretary of the Illinois Department of Transportation, one of which must be currently employed as a highway maintainer with the Illinois Department of Transportation; one member appointed by the Director of the Illinois State Police; one police officer from a county with a population of less than 60,000 citizens appointed by the Director of the Illinois Emergency Management Agency; one police officer from a county with a population between 60,000 and 1,000,000 citizens appointed by the Director of the Illinois Emergency Management Agency; one police officer from a county with a population of more than 1,000,000 citizens appointed by the Director of the Illinois Emergency Management Agency; one firefighter from a county with a population of less than 60,000 citizens appointed by the Director of the Illinois Emergency Management Agency; one firefighter from a county with a population between 60,000 and 1,000,000 citizens appointed by the Director of the Illinois Emergency Management Agency; one firefighter from a county with a population of more than 1,000,000 citizens appointed by the Director of the Illinois Emergency Management Agency; one emergency medical services personnel from a county with a population of less than 60,000 citizens appointed by the Director of the Illinois Emergency Management Agency; one emergency medical services personnel from a county with a population between 60,000 and 1,000,000 citizens appointed by the Director of the Illinois Emergency Management Agency; and one emergency medical services personnel from a county with a population of more than 1,000,000 citizens appointed by the Director of the Illinois Emergency Management Agency; the members of the Task Force shall select a chairperson at the initial meeting; and be it further

RESOLVED, That the Illinois Emergency Management Agency shall provide administrative and other support to the Task Force; and be it further

RESOLVED, That the members of the Task Force shall serve without compensation; and be it further

RESOLVED, That the Task Force shall submit a report of its findings and recommendations to the General Assembly no later than January 1, 2015.

**SENATE JOINT RESOLUTION NO. 63  
CONSTITUTIONAL AMENDMENT**

SC0063

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend the Illinois Constitution by adding Section 2.5 to Article IV as follows:

ARTICLE IV  
THE LEGISLATURE

SECTION 2.5. TERM LIMITS

(a) A person may not serve more than 5 consecutive terms of office as a Representative from the same Representative District. A person who has served 5 consecutive terms of office as a Representative from the same Representative District may not serve another term of office as a Representative from that Representative District until after the expiration of at least the next 2 terms of the office of Representative from that Representative District following the conclusion of the person's fifth consecutive term.

(b) A person may not serve more than 3 consecutive terms of office as a Senator from the same Legislative District. A person who has served 3 consecutive terms of office as a Senator from the same Legislative District may not serve another term of office as a Senator from that Legislative District until after the expiration of at least the next 2 terms of the office of Senator from that Legislative District following the conclusion of the person's third consecutive term.

(c) A person is considered to serve a term of office for the purpose of this Section if the person is elected or appointed to serve any portion of the term.

SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act and applies to terms of office beginning on or after the second Wednesday in January 2015.
