Senator Althoff offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 1114

WHEREAS, Recognizing that work remains to be done to aid the high number of unemployed and underemployed individuals, this State and the federal government have announced major initiatives to promote workforce development activities; and

WHEREAS, These activities are primarily aimed at helping individuals acquire the knowledge and skills necessary to pursue a career in the current competitive job market; and

WHEREAS, As part of these efforts, this State will be promoting a new initiative to increase the work readiness of individuals by obtaining a college degree or career certificate; and

WHEREAS, At the federal level, major efforts are being made to review the nation's workforce and training system to make it more job-driven, integrated, and effective; and

WHEREAS, A key aspect in State and federal efforts is the active involvement of the private business sector; and

WHEREAS, Workforce Investment Boards provide businesses with an important forum to inform training providers, including the public education system, community colleges, the State university system, and proprietary schools of the needs of the local business community; and

WHEREAS, Workforce Investment Boards were established by federal law to serve as a vital provider of information, programs, and services to individuals seeking employment, employers, and training providers; and

WHEREAS, Under the authority provided to Workforce Investment Boards, opportunities and funds are available for individuals to enroll in training programs and services at job centers throughout this State that give priority to the local business community's current and future needs; and

WHEREAS, It is fitting that the members of the Senate support the role that Workforce Investment Boards play in providing important programs and services that help strengthen local communities and, by extension, this State and the nation; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the week of August 25 through August 31, 2014 as "Workforce Development Week" in Illinois and encourage individuals, businesses, and governmental organizations to visit and promote the programs and services offered through local Workforce Investment Boards; and be it further

RESOLVED, That August 25 through August 31, 2014 will be an opportunity for Workforce Investment Boards to highlight and promote the many ways in which they are undertaking this important work; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Department of Commerce and Economic Opportunity.

Senator Harmon offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 1115

WHEREAS, More than 15% of Illinoisans struggle to provide enough food for their families and more than 22% of Illinoisans' children are food insecure, meaning they do not have consistent access to adequate food: and

WHEREAS, Illinois ranks 24th in the nation for childhood hunger and 21% of children live in poverty; and

WHEREAS, There are children in every county of the State of Illinois who experience food insecurity; and

WHEREAS, No child deserves to go without food, and children who are food insecure suffer from increased risk of chronic diseases, increased rates of behavioral problems, decreased academic achievement, and long-term social and economic impacts; and

WHEREAS, Federal nutrition programs play a pivotal role in helping low-income children access free, healthy meals, including the School Breakfast Program, the National School Lunch Program, Summer Meals Programs, Child and Adult Care Food Program Afterschool Meals Programs, and the Special Supplemental Nutrition Program for Women, Infants, and Children; and

WHEREAS, More than 825,000 children participate in free and reduced price school lunch; 376,000 children participate in free and reduced price school breakfast; and 95,000 children participate in the summer meals program; and

WHEREAS, Students who eat school breakfast achieve 17.5% higher scores on standardized math tests and attend 1.5 more days of school each year than those who do not; and

WHEREAS, Thirty-two percent of low-income families find themselves without enough food in the summer months and 43% of low-income families find it harder to make ends meet in the summer months; low-income families spend an additional \$300 per month in the summer months to provide food for their families; and

WHEREAS, 4,189,025 summer meals were provided through the Summer Food Service Program; these meals were distributed through 1,716 sites, of which only 882 were open to the community and did not require enrollment; and

WHEREAS, Summer Food Service Program sites are an ideal model for summer food delivery and provide on-site adult supervision and enrichment activities for children; however, more Summer Food Service Program sites are needed that are open to the community; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we encourage schools participating in the School Breakfast Program to utilize alternative delivery models, such as Breakfast in the Classroom, Grab n'Go, and Second Chance Breakfast, to provide breakfast after the bell to all students at no cost to students; and be it further

RESOLVED, That we encourage Summer Food Service Program sites to operate as open sites to the community so that all children can access healthy, nutritious meals during the summer; and be it further

RESOLVED, That we encourage eligible providers to participate in Child and Adult Care Food Program Afterschool Meals Programs; and be it further

[April 29, 2014]

RESOLVED, That we urge Congress to develop a 2015 Child Nutrition Reauthorization that protects and strengthens the federal food and nutrition safety net for children; and be it further

RESOLVED, That we are opposed to cuts in funding to federal food and nutrition programs for children and families through the annual federal budget process or any other measures; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the members of the Illinois congressional delegation, the President of the United States, and the United States Secretary of Agriculture.

Senator Hutchinson offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 1121

WHEREAS, The Smith-Lever Act of 1914 codified into federal law and provided funding for outreach endeavors at the Land-Grant Universities founded by the Morrill Act of 1862; the appropriation for Cooperative Extension as established by Smith-Lever was unique in that it set up a shared partnership among the federal, state, and county levels of government; a formula funding mechanism was designed to insure that there was support from each of the levels to help the fledgling system achieve stability and leverage resources; and

WHEREAS, The original formula called for federal funding to be divided in the following manner: 20% shared by all states in equal proportions, 40% shared in the proportion that the rural population inhabits, and 40% shared in the proportion that the farm population inhabits; and

WHEREAS, The original formula called federal funding to be divided in a manner based on an agrarian society; in the 1980s, Extension responded to societal problems, which included urban issues; 47% of Illinois Extension funds come from State sources, while 32% of funds come from federal sources, and 18% come from local sources; and

WHEREAS, University of Illinois Extension in Cook County continues to provide residents with programs to address urban issues in the 1990s, as the expansion of urban areas increased; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the month of May 2014 as University of Illinois Extension in Cook County Month in the State of Illinois to celebrate the 100 years of dedicated service that Extension has provided to the residents of Cook County.

MESSAGE FROM THE HOUSE

A message from the House by

Mr. Mapes, Clerk:

Mr. President -- I am directed to inform the Senate that the House of Representatives has adopted the following joint resolution, in the adoption of which I am instructed to ask the concurrence of the Senate, to-wit:

HOUSE JOINT RESOLUTION NO. 77

WHEREAS, Recent data indicates that Latinos represent about 4% of individuals in the Prioritization for Urgency of Need for Services (PUNS) list of residents who have been screened and waiting for services relating to their disabilities; and

WHEREAS, Latinos make up 16% of the general population in the State of Illinois and 25% of the children under 18 in the State; and

WHEREAS, The disparity between the State's Latino population and Latino membership in the PUNS program indicates significant barriers and unmet needs for services in the Latino community; and

WHEREAS, There exists a great need for further study of the State's policies concerning Latinos with disabilities; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the Latinos with Disabilities Task Force is created to examine the current status of Latinos with Disabilities in the State of Illinois and to advise the General Assembly and the Governor on necessary improvements; and be it further

RESOLVED, That the Task Force shall:

- (1) compile information regarding Latinos with disabilities in the State of Illinois, including but not limited to incidence, prevalence, type of disability, access to services, participation in programming, and outcome data;
- (2) consider any other available and relevant information on Latinos with disabilities in Illinois, including but not limited community feedback, survey, or Census data;
- (3) assess the responsiveness of the current and evolving delivery system of services for persons with disabilities in the Latino community, including barriers to participation;
 - (4) assess current health and human services system reform efforts; and
- (5) identify and recommend specific best-practices and changes at the policy, structural, and programmatic level that can facilitate equitable Latino participation; and be it further

RESOLVED, That the Task Force shall be composed of the following members:

- (1) 3 members appointed by the Governor who are persons with developmental disabilities or their immediate relatives or guardians;
- (2) 3 members appointed by the Governor who are representatives of advocate organizations which are concerned with protecting the rights of persons with developmental disabilities;
- (3) 6 members appointed by the Governor who are representatives of provider agencies or research organizations; and
- (4) One member appointed by the Secretary of the Illinois Department of Human Services as a representative of that office; and be it further

RESOLVED, That all members of the Task Force appointed by the Governor are to be appointed upon the recommendation of the Illinois Legislative Latino Caucus and the Illinois Latino Family Commission; the members of the Task Force shall elect a chairperson from among their membership; and be it further

RESOLVED, That members of the Task Force shall serve without compensation but shall be reimbursed for their reasonable and necessary expenses from funds appropriated for that purpose; and be it further

RESOLVED, That the Task Force shall receive administrative support from the Illinois Latino Family Commission and the Illinois Department of Human Services; and be it further

RESOLVED, That the Task Force shall submit its final report and recommendations to the Governor and General Assembly no later than January 1, 2016.

SENATE JOINT RESOLUTION NO. 70

WHEREAS, The desire to maintain and enhance fire prevention and safety standards is a primary concern to the General Assembly; and

WHEREAS, There are many effective fire prevention and fire safety systems and techniques available in the State of Illinois; and

WHEREAS, State and local rules and regulations related to the implementation of fire safety systems are varied and sometimes in conflict; and

WHEREAS, It is in the best interest of the people of the State of Illinois to implement the most effective methods of fire prevention and fire safety; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there is created the Task Force on Fire Prevention and Fire Safety Education, consisting of 23 members appointed as follows:

- (1) one member of the Senate appointed by the President of the Senate, who shall serve as a co-chairperson of the Task Force;
- (2) one member of the Senate appointed by the Minority Leader of the Senate;
- (3) one member of the House of Representatives appointed by the Speaker of the House of Representatives, who shall serve as a co-chairperson of the Task Force;
- (4) one member of the House of Representatives appointed by the Minority Leader of the House of Representatives;
- (5) two members of the general public appointed jointly by the President of the Senate and the Speaker of the House of Representatives;
- (6) one member appointed by the Illinois State Fire Marshal;

- (7) one member appointed jointly by the President of the Senate and the Speaker of the House of Representatives, representing a statewide association of fire chiefs;
- (8) one member appointed jointly by the President of the Senate and the Speaker of the House
- of Representatives, representing a statewide association of firefighters; (9) one member appointed jointly by the President of the Senate and the Speaker of the House
- of Representatives, representing a northern Illinois advisory board focused on fire sprinkler education;
- (10) one member appointed jointly by the President of the Senate and the Speaker of the

House of Representatives, representing the Joint Labor and Management Committee created under the Fire Department Promotion Act;

- (11) one member appointed by the Mayor of the City of Chicago;
- (12) one member appointed jointly by the President of the Senate and the Speaker of the
- House of Representatives, representing a statewide organization representing municipalities;
- (13) one member appointed jointly by the President of the Senate and the Speaker of the

House of Representatives, representing a statewide association of realtors;

- (14) one member appointed jointly by the President of the Senate and the Speaker of the
- House of Representatives, representing a statewide association of home construction contractors;
- (15) one member appointed jointly by the President of the Senate and the Speaker of the

House of Representatives, representing a statewide association of the pipe trades;

- (16) one member appointed jointly by the President of the Senate and the Speaker of the
- House of Representatives, representing a statewide labor organization representing more than one international union;
- (17) one member appointed jointly by the President of the Senate and the Speaker of the

House of Representatives, representing a nationwide association dedicated to fire, electrical, and building safety;

(18) one member appointed jointly by the President of the Senate and the Speaker of the

House of Representatives, representing a single statewide association of condominium, townhouse, and homeowner associations:

- (19) one member appointed jointly by the President of the Senate and the Speaker of the
- House of Representatives, representing a Chicago-based organization of building owners and managers;
- (20) one member appointed jointly by the President of the Senate and the Speaker of the
- House of Representatives, representing a statewide association of apartment building owners and managers in the Chicago area;
- (21) one member appointed jointly by the President of the Senate and the Speaker of the
- House of Representatives, representing a statewide association of the insurance trade; and
- (22) one member appointed by the Executive Director of the Illinois Finance Authority; and be it further

RESOLVED, That all appointments to the Task Force shall be made as soon as practicable after the adoption of this resolution; vacancies in the Task Force shall be filled by their respective appointing authorities within 30 days after the vacancy occurs; and be it further

RESOLVED, That the members shall serve without compensation; the Task Force may employ skilled experts with the approval of the co-chairpersons and shall receive the cooperation of any State agencies it deems appropriate to assist the Task Force in carrying out its duties; and be it further

RESOLVED, That the members of the Task Force shall be considered members with voting rights; a quorum of the Task Force shall consist of a simple majority of the members of the Task Force; the Task Force shall meet initially at the call of the co-chairpersons, no later than 90 days after the adoption of this resolution, and shall thereafter meet at the call of the co-chairpersons; and be it further

RESOLVED, That the Office of the State Fire Marshal shall provide administrative and other support to the Task Force; and be it further

RESOLVED, That the Task Force shall research, analyze, and consider:

- (1) the benefits of legislation requiring fire sprinkler systems in homes, places of employment, and highrise buildings;
- (2) the costs and benefits of fire sprinkler systems, hard-wired smoke detectors, and public education about fire drills and other prevention education measures;
- (3) the actions of other states pertaining to fire sprinklers, including but not limited to

long-term financing options;

- (4) the actions of units of local government pertaining to fire sprinkler mandates and other options or alternatives to mandates;
- (5) insurance benefits and discounts for structures with fire sprinkler systems;
- (6) code interpretations between State agencies and units of local government;
- (7) collaboration by governmental bodies to explore assistance options available to property owners and renters wishing to install fire sprinkler systems; and
- (8) the creation of legislative recommendations to the General Assembly; and be it further

RESOLVED, That the Task Force shall summarize its findings and recommendations in a report to the General Assembly on or before March 1, 2015.
