## SENATE RESOLUTION NO. 138

WHEREAS, In recent fiscal years, appropriations to various agencies and groups have been closely examined for their efficiency; and

WHEREAS, Questions remain regarding the efficiency of certain programs and use of State funds by the College of DuPage; and

WHEREAS, State institutions of higher education are competing for every dollar available from the State; and

WHEREAS, Community colleges and universities in Illinois receive State funding; and

WHEREAS, Recent events over the last 12 months at the College of DuPage, including the payment of College of DuPage funds to a company owned by an employee and the seeking of State funds for a project that had yet to be identified, have raised concerns of improper use of taxpayer funds by the College of DuPage; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed to conduct a performance audit of the State moneys provided to the College of DuPage in Fiscal Year 2011, Fiscal Year 2012, Fiscal Year 2013, and Fiscal Year 2014; and be it further

RESOLVED, That the College of DuPage and any other State agency or entity that may have information relevant to this audit cooperate fully and promptly with the Auditor General's Office in conducting of its audit; and be it further

RESOLVED, That the Auditor General commence this audit as soon as practical and report his findings and recommendations upon completion in accordance with the provisions of Section 3-14 of the Illinois State Auditing Act; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Auditor General.

Senator T. Cullerton offered the following Senate Resolution, which was referred to the Committee on Assignments:

### SENATE RESOLUTION NO. 139

WHEREAS, Certain communities on the Northwest side of the City of Chicago lay underneath the key nighttime air routes that converge over the community; this includes 5 glide paths, 2 major take-off plates, and air routes, all used after 10 p.m.; and

WHEREAS, These communities of the City of Chicago seek a solution to the nighttime sleep interruptions during the hours of 10 p.m. and 7 a.m., including the shoulder hours as well; and

WHEREAS, The Nextgen Program is currently being applied at O'Hare International Airport, where flights that used to be 5-miles spaced apart will soon have only a 3-mile separation, times 6 east-to-west approach patterns for all inbound flights; and

WHEREAS, These communities of the City of Chicago are experiencing higher levels of jet noise, especially during the phase 1 nighttime flight operations; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Federal Aviation Administration and the United States Environmental Protection Agency to conduct a study describing the environmental and human health impacts caused by runways and air traffic noise at Chicago O'Hare International Airport and the actual noise levels experienced in 2015; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Commissioner of O'Hare International Airport, the Acting Administrator of the Federal Aeronautics Administration, and to each member of the Illinois congressional delegation.

Senator Morrison offered the following Senate Resolution, which was referred to the Committee on Assignments:

### SENATE RESOLUTION NO. 140

WHEREAS, The Department of Children and Family Services is required by the Children and Family Services Act (20 ILCS 505/7] to place children in its care in safe and adequate placements consistent with each child's health, safety and best interests; and

WHEREAS, The Department of Children and Family Services has adopted rules, entitled "Placement Selection Criteria", (89 Ill. Adm. Code Part 301.60) that provide that "all placement decisions will be made consistent with the safety, best interests and special needs of the child" and that consideration shall be given to "the least restrictive setting appropriate for the child which most closely approximates a family"; and

WHEREAS, The Department of Children and Family Services has adopted procedures, entitled "Psychiatric Hospitalization, Basic Premises Regarding Psychiatric Hospitalization" (DCFS Procedures 301.110(b)), that provide that "a psychiatric hospitalization is not a placement" and that "discharge and placement planning shall begin from the moment of admission"; and

WHEREAS, The Department of Children and Family Services is the party to a federal court consent decree (B.H. et al., 88 C 5599, N.D. ILL) that provides that emergency shelter placements "shall be limited to 30 days"; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed to conduct a performance audit of the Department of Children and Family Services' compliance with its obligations to place children in its care in placements consistent with their best interests; and be it further

RESOLVED, That the audit include, but not be limited to, the following determinations as they pertain to children (up to the age of 21) in the care of the Department of Children and Family Services in calendar years 2014 and 2015:

- (1) The number of children who remain psychiatrically hospitalized beyond the time when they are clinically ready for discharge or beyond medical necessity for hospitalization, whichever is sooner, the reason they remain hospitalized, the length of time they remain hospitalized, the type of recommended placement, the barriers to timely placement, and whether they were placed in the recommended placement type after leaving the hospital;
- (2) The number of children who remain in emergency shelters beyond 30 days, the reason they remain in an emergency shelter, the length of time they remain in an emergency shelter, the type of recommended placement, the barriers to timely placement, and whether they were placed in the recommended placement type after they were moved from the shelter; and
- (3) The number of children who remain in a detention center or Department of Juvenile Justice (DJJ) facility solely because the Department cannot locate a placement for the child, the length of time they remain in a detention center or DJJ facility, the type of recommended placement, the barriers to timely placement, and whether they were placed in the recommended placement type after being released from detention or from the DJJ facility; and be it further

RESOLVED, That the Department of Children and Family Services shall cooperate fully and promptly with the Auditor General's Office in conducting this audit; and be it further

RESOLVED, That the Auditor General commence this audit as soon as possible and distribute the report upon completion in accordance with Section 3-14 of the Illinois State Auditing Act.

Senator Harmon offered the following Senate Resolution, which was referred to the Committee on Assignments:

### SENATE RESOLUTION NO. 141

WHEREAS, All citizens of Illinois should be made aware of the ever-present dangers posed by potentially poisonous household substances; and

WHEREAS, Children too often have access to over-the-counter and prescription medications and potentially toxic household products; and

WHEREAS, Over the past 50 years, the nation has been observing National Poison Prevention Week to help prevent accidental poisonings and tips for promoting community involvement in poison prevention; and

WHEREAS, The Illinois Poison Center has been providing timely poison prevention and treatment services to the people of Illinois for over 60 years as the oldest and one of the largest poison centers in the nation; and

WHEREAS, The Illinois Poison Center is a mainstay in the emergency medical care system of the State of Illinois and is recognized nationally for its contributions to poison treatment and prevention; and

WHEREAS, Fifty percent of the more than 80,000 poisonings reported last year to the Illinois Poison Center involved children under the age of 5 and could have been prevented; and

WHEREAS, The Illinois Poison Center manages approximately 90% of cases from the general public at home, saving the State of Illinois over \$52 million in reduced health care and lost productivity costs; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate March of 2015 as Poison Prevention Month in the State of Illinois and urge all Illinoisans to educate themselves about the potentially harmful substances in their homes and take steps to create healthy and safe home, play, and work environments; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Illinois Poison Center.

Senator Hunter offered the following Senate Resolution, which was referred to the Committee on Assignments:

#### SENATE RESOLUTION NO. 142

WHEREAS, In late 2013, Target experienced a security data breach that affected as many as 40 million people who used their credit or debit cards at the retailer; and

WHEREAS, In 2014, credit card data security breaches were reported by retailers including, but not limited to: Neiman Marcus, Sally Beauty, Michaels, P.F. Chang's China Bistro, Albertson's and Supervalu, UPS, Dairy Queen, Goodwill Industries, Home Depot, Jimmy John's, Kmart, Staples, and Bebe; and

WHEREAS, On February 5, 2015, Anthem Inc., a health insurer, announced that it experienced a cyberdata breach on its database of 80 million records containing personal information such as names, birth dates, addresses, and Social Security numbers; and

WHEREAS, On January 27, 2015, United States Representative Gus Bilarikis of Florida stated in the United States House Subcommittee on Commerce, Manufacturing, and Trade that a need exists to ensure that merchants are appropriately protecting consumers; and

WHEREAS, The Credit Union National Association has created a national action alert regarding data breaches, including a website, StoptheDataBreaches.com; and

WHEREAS, The Credit Union National Association urges citizens to make their government officials and representatives aware of the problem of data breaches; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the federal government of the United States of America to address the issue of data security breaches; and be it further

RESOLVED, That we urge the United States government to focus on increased accountability and higher security regarding both credit data used at retailers and personal information data kept by any organization; and be it further

RESOLVED, That suitable copies of this resolution be presented to the members of the Illinois congressional delegation.

Senator Silverstein offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

#### SENATE JOINT RESOLUTION NO. 10

WHEREAS, Illinoisans are increasingly using new technology, including smart phones, in their daily lives for such core, day-to-day functions like working, banking, and shopping; and

WHEREAS, Increasing convenience is one way to improve the quality of life for our residents and citizens: and

WHEREAS, There is both a financial and an environmental cost for producing plastic driver's licenses; and

WHEREAS, There is an emergent technology that allows for secure digital driver's licenses; and

WHEREAS, The States of Iowa and Delaware are planning to experiment with digital licenses in 2015; and

WHEREAS, The digital driver's license would be optional and not required; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we urge the Secretary of State to study and consider the issuance of optional digital driver's licenses for Illinois motorists: and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Secretary of State.

# SENATE JOINT RESOLUTION NO. 10 CONSTITUTIONAL AMENDMENT

SC0010

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article IV of the Illinois Constitution by changing Section 6 as follows:

## ARTICLE IV THE LEGISLATURE

## SECTION 6. ORGANIZATION

- (a) A majority of the members elected to each house constitutes a quorum.
- (b) On the first day of the January session of the General Assembly in odd-numbered years, the Secretary of State shall convene the House of Representatives to elect from its membership a Speaker of the House of Representatives as presiding officer, and the Governor shall convene the Senate to elect from its membership a President of the Senate as presiding officer. A person may serve no more than a total of 10 years in any one of the following offices and no more than a combined total of 14 years in any 2 or more of the following offices: Speaker of the House of Representatives, President of the Senate, Minority Leader of the House of Representatives, or Minority Leader of the Senate; provided that service before the second Wednesday in January of 2017 shall not be considered in the calculation of a person's service.

- (c) For purposes of powers of appointment conferred by this Constitution, the Minority Leader of either house is a member of the numerically strongest political party other than the party to which the Speaker or the President belongs, as the case may be.
- (d) Each house shall determine the rules of its proceedings, judge the elections, returns and qualifications of its members and choose its officers. No member shall be expelled by either house, except by a vote of two-thirds of the members elected to that house. A member may be expelled only once for the same offense. Each house may punish by imprisonment any person, not a member, guilty of disrespect to the house by disorderly or contemptuous behavior in its presence. Imprisonment shall not extend beyond twenty-four hours at one time unless the person persists in disorderly or contemptuous behavior. (Source: Illinois Constitution.)

SC0011

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 3 of Article IX of the Illinois Constitution as follows:

## ARTICLE IX REVENUE

### SECTION 3. LIMITATIONS ON INCOME TAXATION

- (a) A tax on or measured by income shall be at a non-graduated rate. At any one time there may be no more than one <u>income</u> such tax imposed by the State for State purposes on individuals and one such tax so imposed on corporations. In any such tax imposed upon corporations the rate shall not exceed the <u>weighted average</u> rate imposed on individuals by more than a ratio of 8 to 5.
- (b) Laws imposing taxes on or measured by income may adopt by reference provisions of the laws and regulations of the United States, as they then exist or thereafter may be changed, for the purpose of arriving at the amount of income upon which the tax is imposed. (Source: Illinois Constitution.)

### SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.
