#### **SENATE RESOLUTION NO. 218**

WHEREAS, The Export-Import Bank of the United States (Ex-Im Bank) is the official export credit agency of the United States; and

WHEREAS, The mission of the Ex-Im Bank is to ensure that United States companies have access to export sales through working capital guarantees, loan guarantees, export-credit insurance, and financing to help foreign buyers purchase U.S. goods and services; and

WHEREAS, The Ex-Im Bank does not compete with private institutions because it finances exports that the private sector is unwilling or unable to undertake alone; and

WHEREAS, The Ex-Im Bank has generated nearly \$3 billion in fees from its customers over the past 3 fiscal years, including \$674.7 million in FY 2014; these funds were deposited in the U.S Treasury to reduce the U.S. deficit and indebtedness; and

WHEREAS, Eighty-five percent of Ex-Im Bank transactions benefit small businesses; and

WHEREAS, Between 2007 and 2014, the Ex-Im Bank supported 382 Illinois companies including 246 small companies employing 35,000 workers that exported products; and

WHEREAS, These 382 Illinois companies sold more than \$8 billion in goods and services across the globe; and

WHEREAS, Since FY 2012, the Ex-Im Bank has supported nearly \$115 billion in exports; and

WHEREAS, The Ex-Im Bank has supported more than 1.3 million American jobs in all 50 states since FY 2009; and

WHEREAS, Illinois exported a record \$68.2 billion of goods and services in 2014; and

WHEREAS, Illinois companies, particularly in the manufacturing and agricultural sectors, rely on the sales of products across the world; and

WHEREAS, Nearly 90% of world trade relies on trade finance provided by 60 export credit agencies, according to the Congressional Research Service; and

WHEREAS, The Ex-Im Bank's statutory authority has been renewed many times over the past 80 years under both Democrat and Republican administrations; and

WHEREAS, The Ex-Im Bank's statutory charter is scheduled to expire on June 30, 2015; and

WHEREAS, Expiration of the Ex-Im Bank's authority would stop operations and prevent Illinois companies from selling billions of dollars in products; and

WHEREAS, Expiration of the Ex-Im Bank will have a negative impact on the Illinois economy, its communities, and its workers; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge President Barack Obama and members of the United States Senate and House of Representatives to reauthorize the United States Export-Import Bank before June 30, 2015; and be it further

RESOLVED, That suitable copies of this resolution be provided to U.S. House Speaker John Boehner, House Minority Leader Nancy Pelosi, Senate Majority Leader Mitch McConnell, Senate Minority Leader Harry Reid, U.S. Senator Dick Durbin, U.S. Senator Mark Kirk, and every member of the Illinois Congressional Delegation.

#### **SENATE RESOLUTION NO. 219**

WHEREAS, 2015 marks the 150th anniversary for Regional Superintendents of Schools in Illinois, represented by the Illinois Association of Regional Superintendents of Schools; and

WHEREAS, Regional Superintendents of Schools have a rich history of serving as an essential support office between the Illinois State Board of Education and local school districts; and

WHEREAS, The office of County Superintendent of Schools was created as a predecessor for Regional Superintendents of Schools by State law in 1865; the County Superintendent was to serve 4 years in office and was required to visit each school in the county at least once a year; and

WHEREAS, These first County Superintendents were also allowed to sell school lands, were given the custody of all county school funds, and were the official advisers of school officers and teachers in their counties and the agents of the State Superintendent of Schools in reaching schools; and

WHEREAS, Duties for County Superintendents grew significantly over the next several decades, including to oversee the difficult process of large-scale school consolidations in the 1950s; and

WHEREAS, County Superintendents shrank from 102 offices to 78 and became Regional Superintendents in 1973; further consolidation dropped the number of offices to 57 in 1977; and

WHEREAS, Further consolidation will reduce the number of Regional Offices of Education to 35 in July of 2015, along with 3 Intermediate Service Centers that serve schools in Cook County outside Chicago; and

WHEREAS, As Regional Superintendents of Schools turn 150 this year, they are a vital part of educational success for students in every county of Illinois; and

WHEREAS, Regional Superintendents of Schools are committed to providing 3 pillars of exceptional service to students, educators, and parents: (1) safety, by inspecting school buildings and ensuring school bus drivers are trained and teachers have proper background checks and fingerprints; (2) support, by licensing educators and providing top-notch professional development services; and (3) success, by providing safe schools and administering high school equivalency examinations and certificates; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize and congratulate the members of the Illinois Association of Regional Superintendents of Schools on their sesquicentennial celebration; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the leadership at the Illinois Association of Regional Superintendents of Schools as an expression of our esteem and respect.

#### HOUSE JOINT RESOLUTION NO. 28

WHEREAS, Guaranteeing equal employment opportunity in federal jobs has traditionally been at the forefront of the government's efforts to curtail nationwide racial discrimination; and

WHEREAS, Over the years, a series of executive orders have been propagated to promote these policies of ending racial discrimination; and

WHEREAS, On September 24, 1965, President Lyndon B. Johnson signed Executive Order 11246, which prohibits federal contractors and subcontractors and federally-assisted contractors and subcontractors that generally have contracts exceeding \$10,000 from discriminating in employment decisions based on race, color, religion, sex, or national origin; and

WHEREAS, Executive Order 11246 requires covered contractors to "take affirmative action to ensure that applicants are employed, and that employees are treated during employment without regard to race, color, religion, sex or national origin"; and

WHEREAS, The United States Department of Labor's Office of Federal Contract Compliance Programs enforces Executive Order 11246 and other regulations banning discrimination; and

WHEREAS, A covered contractor in violation of Executive Order 11246 or associated regulations may have its contracts canceled, terminated, or suspended; the contractor may also be declared ineligible for future government contracts; and

WHEREAS, Section 201 of Executive Order 11246 requires that the Secretary of the Department of Labor shall adopt rules, regulations, and orders as he or she deems necessary to achieve the purposes of the Order; and

WHEREAS, Since October of 1980, the Code of Federal Regulations requires the Director of the United States Department of Labor to issue goals and timetables for minority and female utilization in the contracts covered under Executive Order 11246; and

WHEREAS, The Code of Federal Regulations requires these minority and female utilization goals to be published in the Federal Register; and

WHEREAS, On October 3, 1980, the Minority Participation Goals were published in the Federal Register, declaring that until further notice, the goals for minority utilization shall be included in all federal or federally-assisted construction contracts and subcontracts in excess of \$10,000 to be performed in the respective geographical area; and

WHEREAS, The Minority Participation Goals published in 1980 were calculated using data from the 1970 United States Census and are set at the 1970 levels of minority representation in the experienced civilian work force; and

WHEREAS, The United States workforce has seen a substantial increase in representation by women and minorities; however, the minority participation goals and timetables have not been updated since they were issued in 1980; and

WHEREAS, Since 2010, the United States Department of Labor has included Executive Order 11246 on its Annual Regulatory Agenda for retrospective analysis of the existing related rules; and

WHEREAS, The Regulatory Agenda declares that the guidance issued to Executive Order 11246 "is more than 30 years old and warrants a lookback"; and

WHEREAS, The Regulatory Agenda declares that the Office of Federal Contract Compliance Programs "will issue a Notice of Proposed Rulemaking to create sex discrimination regulations that reflect the current state of the law in this area"; and

WHEREAS, Neither has a Notice of Proposed Rulemaking been filed, nor any other action been taken to update the regulations implementing Executive Order 11246, including the minority utilization goals; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we, as elected representatives of the people, respectfully but emphatically urge the President of the United States, the Secretary of the United States Department of Labor, the Office of Federal Contract Compliance Programs, and the members of Congress to update the regulations implementing Executive Order 11246, including the minority utilization goals; and be it further

RESOLVED, That we respectfully but emphatically urge the United States Department of Labor Office of Federal Contract Compliance Programs to issue a Notice of Proposed Rulemaking providing guidance and regulations for implementation of Executive Order 11246, which accurately reflect the current state of the United States workforce; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States, the Speaker and Clerk of the United States House of Representatives, the President Pro Tempore and Secretary of the United States Senate, the Secretary of the United States Department of Labor, and the members of the Illinois congressional delegation.
