Senator Lightford offered the following Senate Resolution, which was referred to the Committee on Assignments:

#### SENATE RESOLUTION NO. 477

WHEREAS, Illinois has a proud legacy as the home of the world's first juvenile court; and

WHEREAS, Illinois has another proud legacy from its first peoples -the practice of restorative justice; in the First Nation justice systems, healing and reintegration of individuals is the primary goal, rather than reliance on prisons and punishment; and

WHEREAS, The principle of restorative justice was included within the Purpose and Policy Section of Article 5 of the Illinois Juvenile Court Act in 1999; and

WHEREAS, To date, there have been multiple pilots throughout the State of restorative justice practices in the juvenile justice system, both as diversion from court and as sentencing alternatives, however there is no uniform statewide practice of restorative justice in the juvenile justice system; and

WHEREAS, As prison costs prove increasingly burdensome for taxpayers, and as studies reveal high repeat offending rates by prisoners who have little education or vocational skills upon release, states are increasingly examining restorative justice practices as effective diversion and sentencing alternatives; Northern Ireland, Finland, New Zealand, and other jurisdictions have successfully revamped their juvenile justice systems through the system-wide implementation of restorative justice practices and these nations serve as models of system reform through restorative justice practices; and

WHEREAS, Restorative justice practices in other nations have been implemented along with full due process and human rights protections for children in conflict with the law, including respect for confidentiality and use of dispositions that represent the least restrictive alternative; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Illinois Juvenile Justice Commission, working in partnership with the Illinois Balanced and Restorative Justice Project and the Illinois Juvenile Justice Initiative, community groups, and schools, review the current practice of restorative justice in juvenile justice systems in the State of Illinois and review restorative justice practices in juvenile justice systems in other states and cultures and nations, and report back to the Illinois General Assembly with recommendations to expand the practice of restorative justice in the juvenile justice system in Illinois with the goal of restoring public safety through restoration of the child in conflict with the law, within a system that incorporates the full range of due process and human rights protections, maximizing community based responses and utilizing incarceration only as a last resort for as short a time as possible; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Illinois Juvenile Justice

Senator Holmes offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

#### SENATE JOINT RESOLUTION NO. 26

WHEREAS, Aurora University is a private university with a public purpose that desires to engage partners for the betterment of the community; and

WHEREAS, Aurora University and its partners desire to increase interest and achievement in science and mathematics prior to students matriculating to high school; and

WHEREAS, 43% of 2014 ACT-tested high school graduates in the United States met the ACT College Readiness Benchmark for mathematics; and

WHEREAS, 37% of 2014 ACT-tested high school graduates in the United States met the ACT College Readiness Benchmark for science; and

WHEREAS, Aurora University and its partners wrote a proposal to strengthen science and mathematics education in response to a community challenge from the Dunham Fund; and

WHEREAS, The John C. Dunham STEM Partnership School was authorized by Public Act 98-786, which provided that 2 or more contiguous school districts with all or a portion of their territory located within the same municipality may provide a math and science partnership school through an institution of higher learning; and

WHEREAS, Aurora University, Aurora East School District 131, Aurora West School District 129, Batavia School District 101, and Indian Prairie School District 204 entered into a governing agreement to operate the John C. Dunham STEM Partnership School under this law to inspire students to transformative academic achievement in science and mathematics; and

WHEREAS, Corporations, businesses, not-for-profits, and government entities have partnered with the university and school districts to develop and implement a curriculum that utilizes the community and university as a laboratory; and

WHEREAS, The success of the school's vision and the model depends in large measure on the on-going commitment of its partners; and

WHEREAS, The John C. Dunham STEM Partnership School can serve as a national model of education that can be replicated in other municipalities; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that the John C. Dunham STEM Partnership School on the campus of Aurora University be recognized as a replicable model for education throughout the State of Illinois.

Mr. President -- I am directed to inform the Senate that the House of Representatives has adopted the following joint resolution, in the adoption of which I am instructed to ask the concurrence of the Senate, to-wit:

#### HOUSE JOINT RESOLUTION NO. 58

WHEREAS, The Partnership for Assessment of Readiness for College and Careers (PARCC) exam has replaced well-recognized State assessments, such as the ISAT and IGAP, as an accountability measure to test students from kindergarten to 12th grade on college readiness; and

WHEREAS, The PARCC exam is not recognized by any college as a college readiness exam, nor does it serve as a replacement for the ACT or SAT, leaving little incentive for students to do their best; and

WHEREAS, The PARCC exam administered in the 2014-2015 school year resulted in computer glitches that slowed down testing or did not allow students to access the exam at all; and

WHEREAS, The length and difficulty of administering the PARCC exam takes away too much traditional class time; and

WHEREAS, Content errors and poorly-worded questions in the exam make it difficult for students to know what the questions are asking; and

WHEREAS, There exists standards-based systems of assessments to monitor progress toward college and career readiness aligned with the ACT College Benchmarks and in which student outcomes are aligned to the Domain and Cluster reporting categories of the Common Core State Standards; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge the State Board of Education to reconsider its use of the PARCC exam as a way to test students; and be it further

RESOLVED, That we urge the State Board of Education to review the school assessment solutions offered by other Common Core-based exams in order to better and more efficiently test students' readiness for higher education; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the State Board of Education.
