SENATE RESOLUTION NO. 736

WHEREAS, Illinois has more units of local government than any state in the country, numbered at over 7,000; and

WHEREAS, The General Assembly finds that consolidation of units of local government will result in cost-saving for the taxpayers; and

WHEREAS, The General Assembly finds that consolidation of units of local government shall only occur with no reduction in the quality of service to taxpayers; and

WHEREAS, Lake County and the 31st Legislative District would benefit from a study assessing how specific units of local government may be consolidated or dissolved; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Working Group on Local Government Consolidation is created to identify ways to eliminate barriers to consolidation and resolve certain discrepancies in the Illinois statutes governing local governments and special districts in Lake County and the 31st Legislative District; and be it further

RESOLVED, The Working Group shall consist of the following members:

(1) one member of the Senate appointed by the President of the Senate, who shall serve as chair;

(2) one member of the Senate appointed by the Senate Minority Leader;

(3) one member selected from recommendations provided by the Lake County Board appointed by the Governor;

(4) one member selected from recommendations provided by the Lake County Forest Preserve District appointed by the Governor;

(5) three members from local townships appointed by the Governor;

(6) two members from local fire protection districts appointed by the Governor;

(7) two members from local park districts appointed by the Governor;

(8) one member selected by the College of Lake County appointed by the Governor;

(9) two members from local elementary school districts selected by recommendations

provided by the Superintendent of Schools appointed by the Governor; and

(10) two members from local high school districts selected by recommendations provided

by the Superintendent of Schools appointed by the Governor; and be it further

RESOLVED, The Working Group shall meet periodically but no less than once every 3 months; the group shall meet in accordance with the requirements of the Open Meetings Act; and be it further

RESOLVED, That the Illinois Department of Revenue shall provide administrative support and technical assistance to the Working Group; and be it further

RESOLVED, The Working Group shall accept testimony and evidence from third parties, including comments from the public at large, in crafting their report to the General Assembly; and be it further

RESOLVED, That Working Group shall submit their report to the General Assembly no later than October 1, 2016; the report shall include findings including, but not limited to, the following issues as they occur in Lake County:

(1) an assessment of the number of units of local government and the costs associated with each unit, including salaries, expenses, and operating costs;

(2) an assessment of the units of local government are engaged in intergovernmental cooperation efforts and what, if any, cost savings such partnerships have resulted in;

(3) recommendations for the elimination of barriers to consolidation;

(4) recommendations for the streamlining or consolidation of units of local government; and

(5) recommendations for intergovernmental cooperation potential.

Senator Muñoz offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 743

WHEREAS, Illinois Vision 20/20 has established a blueprint for the future of education in Illinois for the more than 2 million school children educated in the State; and

WHEREAS, One of the pillars and areas for prioritization of this vision is to provide students with a 21st century learning environment; and

WHEREAS, Illinois should modernize its approach by delivering 21st century instruction that provides all students access to modern learning environments and incorporate technology in state learning standards; education should also allow students to learn and apply knowledge, think creatively, and be well-prepared for a global citizenry; and

WHEREAS, A 21st century education must address the role of technology in the broad definition of learning, not as the total solution, but technology as a tool that can enhance and augment the teaching and learning processes in our schools by reducing costs, encouraging higher-level thinking, increasing student engagement, and aiding in individualized instruction; and

WHEREAS, A technology gap exists in Illinois schools, with less affluent schools unable to provide their students the benefits of technology in instruction; and

WHEREAS, Broadband has become a fundamental infrastructure need for instruction providing students with direct access to a world of learning materials; access to adequate broadband and bandwidth is not equitable, with only 26% of Illinois districts having adequate infrastructure; and

WHEREAS, Thousands of citizens of Illinois, 500 school districts representing nearly 760,000 students, education organizations, companies, non-profits, and those who support public education have endorsed the Vision 20/20 plan in order to fulfill the promise of public education in Illinois; and

WHEREAS, The members of this body join the Vision 20/20 supporters in promoting the priorities of this vision; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate August 18, 2015 as The Vision 20/20 21st Century Learning Day in the State of Illinois and applaud the architects of the Vision 20/20 plan to invest in our children's future, our State's future, and our nation's future; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Alliance Vision 20/20 organization as a symbol of our respect and esteem for its work.

Senator LaHood offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 746

WHEREAS, Ingersoll Scout Reservation near London Mills celebrates the 50th Anniversary since its opening by the W. D. Boyce Council of the Boy Scouts of America; and

WHEREAS, Ingersoll Scout Reservation, initially named Wilderness Camp, was officially renamed in 1973 to posthumously honor William Parlin Ingersoll, who donated the land; and

WHEREAS, Ingersoll Scout Reservation opened in mid-June of 1965 to Boy Scouts throughout Central Illinois; and

WHEREAS, Since Ingersoll Scout Reservation's opening, an estimated 10 million dollars has been invested in improvements to the facilities, with large portions of the improvements accomplished by outstanding volunteer services and donations from businesses, Boy Scout supporters and others within the communities of the W.D. Boyce Council; and

WHEREAS, Since Ingersoll Scout Reservation's opening, an estimated 40,000 Boy Scouts have enjoyed this outstanding Central Illinois treasure, and it has been staffed by an estimated 1,500 Camp Counselors; and

WHEREAS, Ingersoll Scout Reservation has received National Accreditation almost every year since its opening; and

WHEREAS, Ingersoll Scout Reservation's camp staff have gone on to become executives within Boy Scout Councils and Boy Scout Camp Rangers, members of the Airborne Rangers and other units within the military, police departments, and fire departments, professors at colleges and universities, local civic leaders, and members of clergy; the outstanding camp counselors throughout the years have always treasured their time as Ingersoll Scout Reservation Staff and have continued to bring pride to the W.D. Boyce Council of the Boy Scouts of America by excelling in their careers throughout all fields of employment; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare July 18, 2015 as "Ingersoll Scout Reservation Day" in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Ingersoll Scout Reservation as a symbol of our admiration and respect.

Senator Radogno offered the following Senate Joint Resolution, which was ordered printed and referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 16 CONSTITUTIONAL AMENDMENT

SC0016

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Section 2.5 to Article IV and amend Section 2 of Article V of the Illinois Constitution as follows:

ARTICLE IV

THE LEGISLATURE

SECTION 2.5. TERM LIMITS. A person may not be elected to the office of State Senator or State Representative, or a combination of those offices, for terms totalling more than 10 years. Service before the second Wednesday in January of 2017 shall not be considered in the calculation of a person's service.

ARTICLE V THE EXECUTIVE

SECTION 2. TERMS

These elected officers of the Executive Branch shall hold office for four years beginning on the second Monday of January after their election and, except in the case of the Lieutenant Governor, until their successors are qualified. They shall be elected at the general election in 1978 and every four years thereafter. A person may not be elected to any Executive Branch office, or any combination of Executive Branch offices, for terms totalling more than 8 years. Service before the second Monday in January of 2017 shall not be considered in the calculation of a person's service.

Senator Radogno offered the following Senate Joint Resolution, which was ordered printed and referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 17 CONSTITUTIONAL AMENDMENT

SC0017

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 3 of Article IV of the Illinois Constitution as follows:

ARTICLE IV

THE LEGISLATURE

SECTION 3. LEGISLATIVE REDISTRICTING

(a) The Independent Redistricting Commission comprising 11 Commissioners shall adopt and file with the Secretary of State a redistricting plan for Legislative Districts and Representative Districts by June 30 of the year following each Federal decennial census. Legislative Districts shall be contiguous and substantially equal in population. Representative Districts shall be contiguous and substantially equal in population. The redistricting plan shall comply with Federal law. Subject to the foregoing, the Commission shall apply the following criteria: (1) the redistricting plan shall not dilute or diminish the ability of a racial or language minority community to elect the candidates of its choice, including when voting in concert with other persons; (2) the redistricting plan shall respect the geographic integrity of units of local government; and (3) the redistricting plan shall respect the geographic integrity of communities sharing common social and economic interests, which do not include relationships with political parties or candidates for office. The redistricting plan shall not either intentionally or unduly discriminate against or intentionally or unduly favor any political party, political group, or particular person. In designing the redistricting plan, the Commission shall consider party registration and voting history data only to assess compliance with the requirements in this subsection (a).

(b) For the purpose of conducting the Commissioner selection process, an Applicant Review Panel comprising three Reviewers shall be chosen in the manner set forth in this subsection (b). Beginning not later than January 1 and ending not later than March 1 of the year in which the Federal decennial census occurs, the Auditor General shall request and accept applications to serve as a Reviewer. The Auditor General shall review all applications and select a pool of 30 potential Reviewers. The Auditor General should select applicants for the pool of potential Reviewers who would operate in an ethical and nonpartisan manner by considering whether each applicant is a resident and registered voter of the State and has been for the four years preceding his or her application, has demonstrated understanding of and adherence to standards of ethical conduct, and has been unaffiliated with any political party for the three years preceding appointment. By March 31 of the year in which the Federal decennial census occurs, the Auditor General shall publicly select by random draw the Panel of three Reviewers from the pool of potential Reviewers.

(c) Beginning not later than January 1 and ending not later than March 1 of the year in which the Federal decennial census occurs, the Auditor General shall request and accept applications to serve as a Commissioner on the Independent Redistricting Commission. By May 31, the Panel shall select a pool of 100 potential Commissioners. The Panel should select applicants for the pool of potential Commissioners

who would be diverse and unaffected by conflicts of interest by considering whether each applicant is a resident and registered voter of the State and has been for the four years preceding his or her application, as well as each applicant's prior political experience, relevant analytical skills, ability to contribute to a fair redistricting process, and ability to represent the demographic and geographic diversity of the State. The Panel shall act by affirmative vote of two Reviewers. All records of the Panel, including applications to serve on the Panel, shall be open for public inspection, except private information about applicants for which there is no compelling public interest in disclosure.

(d) Within 45 days after the Panel has selected the pool of 100 potential Commissioners, but not later than June 23 of the year in which the Federal decennial census occurs, the Speaker and Minority Leader of the House of Representatives and the President and Minority Leader of the Senate each may remove up to five of those potential Commissioners. Thereafter, but not later than June 30, the Panel shall publicly select seven Commissioners by random draw from the remaining pool of potential Commissioners; of those seven Commissioners, including any replacements, (1) the seven Commissioners shall reside among the Judicial Districts in the same proportion as the number of Judges elected therefrom under Section 3 of Article VI of this Constitution, (2) two Commissioners shall be affiliated with the political party whose candidate for Governor received the most votes cast in the last general election for Governor, two Commissioners shall be affiliated with the political party whose candidate for Governor received the second-most votes cast in such election and the remaining three Commissioners shall not be affiliated with either such political party, and (3) no more than two Commissioners may be affiliated with the same political party. The Speaker and Minority Leader of the House of Representatives and the President and Minority Leader of the Senate each shall appoint one Commissioner from among the remaining applicants in the pool of potential Commissioners on the basis of the appointee's contribution to the demographic and geographic diversity of the Commission. A vacancy on the Panel or Commission shall be filled within five days by a potential Reviewer or potential Commissioner from among the applicants remaining in the pool of potential Reviewers or potential Commissioners, respectively, in the manner in which the office was previously filled.

(e) The Commission shall act in public meetings by affirmative vote of six Commissioners, except that approval of any redistricting plan shall require the affirmative vote of at least (1) seven Commissioners total, (2) two Commissioners from each political party whose candidate for Governor received the most and second-most votes cast in the last general election for Governor, and (3) two Commissioners not affiliated with either such political party. The Commission shall elect its chairperson and vice chairperson, who shall not be affiliated with the same political party. Six Commissioners shall constitute a quorum. All meetings of the Commission attended by a quorum, except for meetings qualified under attorney-client privilege, shall be open to the public and publicly noticed at least two days prior to the meeting. All records of the Commission shall adopt rules governing its procedure, public hearings, and the implementation of matters under this Section. The Commission shall hold public hearings throughout the State both before and after releasing the initial proposed redistricting plan. The Commission may not adopt a final redistricting plan unless the plan to be adopted without further amendment, and a report explaining its compliance with this Constitution, have been publicly noticed at least seven days before the final vote on such plan.

(f) If the Commission fails to adopt and file with the Secretary of State a redistricting plan by June 30 of the year following a Federal decennial census, the Chief Justice of the Supreme Court and the most senior Judge of the Supreme Court who is not affiliated with the same political party as the Chief Justice shall appoint jointly by July 31 a Special Commissioner for Redistricting. The Special Commissioner shall adopt and file with the Secretary of State by August 31 a redistricting plan satisfying the requirements set forth in subsection (a) of this Section and a report explaining its compliance with this Constitution. The Special Commissioner shall hold at least one public hearing in a different location in the State after releasing plan and at least one public hearing in a different location in the State after releasing posed redistricting plan, and before filing the final redistricting plan with the Secretary of State. All records of the Special Commissioner shall be open for public inspection, except for records qualified under attorney-client privilege.

(g) An adopted redistricting plan filed with the Secretary of State shall be presumed valid and shall be published promptly by the Secretary of State.

(h) The Supreme Court shall have original jurisdiction in cases relating to matters under this Section.

(a) Legislative Districts shall be compact, contiguous and substantially equal in population. Representative Districts shall be compact, contiguous, and substantially equal in population.

(b) In the year following each Federal decennial census year, the General Assembly by law shall redistrict the Legislative Districts and the Representative Districts.

If no redistricting plan becomes effective by June 30 of that year, a Legislative Redistricting Commission shall be constituted not later than July 10. The Commission shall consist of eight members, no more than four of whom shall be members of the same political party.

The Speaker and Minority Leader of the House of Representatives shall each appoint to the Commission one Representative and one person who is not a member of the General Assembly. The President and Minority Leader of the Senate shall each appoint to the Commission one Senator and one person who is not a member of the General Assembly.

The members shall be certified to the Secretary of State by the appointing authorities. A vacancy on the Commission shall be filled within five days by the authority that made the original appointment. A Chairman and Vice Chairman shall be chosen by a majority of all members of the Commission.

Not later than August 10, the Commission shall file with the Secretary of State a redistricting plan approved by at least five members.

If the Commission fails to file an approved redistricting plan, the Supreme Court shall submit the names of two persons, not of the same political party, to the Secretary of State not later than September 1.

Not later than September 5, the Secretary of State publicly shall draw by random selection the name of one of the two persons to serve as the ninth member of the Commission.

Not later than October 5, the Commission shall file with the Secretary of State a redistricting plan approved by at least five members.

An approved redistricting plan filed with the Secretary of State shall be presumed valid, shall have the force and effect of law and shall be published promptly by the Secretary of State.

The Supreme Court shall have original and exclusive jurisdiction over actions concerning redistricting the House and Senate, which shall be initiated in the name of the People of the State by the Attorney General.

SENATE RESOLUTION NO. 760

WHEREAS, Illinois has more units of local government than any state in the country, numbered at over 7,000; and

WHEREAS, The General Assembly finds that consolidation of units of local government will result in cost-saving for the taxpayers; and

WHEREAS, The General Assembly finds that consolidation of units of local government shall only occur with no reduction in the quality of service to taxpayers; and

WHEREAS, Lake County and the 31st Legislative District would benefit from a study assessing how specific units of local government may be consolidated or dissolved; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Working Group on Local Government Consolidation is created to identify ways to eliminate barriers to consolidation and resolve certain discrepancies in the Illinois statutes governing local governments and special districts in Lake County and the 31st Legislative District; and be it further

RESOLVED, The Working Group shall consist of the following members:

(1) one member of the Senate appointed by the President of the Senate, who shall serve as chair;

(2) one member of the Senate appointed by the Senate Minority Leader;

(3) one member selected from recommendations provided by the Lake County Board appointed by the Governor;

(4) one member selected from recommendations provided by the Lake County Forest Preserve District appointed by the Governor;

(5) three members selected from recommendations provided by an association representing local townships appointed by the Governor;

(6) two members selected from recommendations provided by an association representing local fire protection districts appointed by the Governor;

(7) two members selected from recommendations provided by an association representing local park districts appointed by the Governor;

(8) one member selected by the College of Lake County appointed by the Governor;

(9) two members from local elementary school districts selected from recommendations

provided by the Superintendent of Schools appointed by the Governor; and

(10) two members from local high school districts selected from recommendations provided by the Superintendent of Schools appointed by the Governor; and be it further

RESOLVED, The Working Group shall meet periodically but no less than once every 3 months; the group shall meet in accordance with the requirements of the Open Meetings Act; and be it further

RESOLVED, That the Illinois Department of Revenue shall provide administrative support and technical assistance to the Working Group; and be it further

RESOLVED, The Working Group shall accept testimony and evidence from third parties, including comments from the public at large, in crafting their report to the General Assembly; and be it further

RESOLVED, That Working Group shall submit their report to the General Assembly no later than October 1, 2016; the report shall include findings including, but not limited to, the following issues as they occur in Lake County:

(1) an assessment of the number of units of local government and the costs associated with each unit, including salaries, expenses, and operating costs;

(2) an assessment of the units of local government are engaged in intergovernmental

cooperation efforts and what, if any, cost savings such partnerships have resulted in;

(3) recommendations for the elimination of barriers to consolidation;

 $\left(4\right)$ recommendations for the streamlining or consolidation of units of local government; and

(5) recommendations for intergovernmental cooperation potential.
