WHEREAS, A single unit of blood can save up to 3 lives, while a single trauma patient can use over 100 units of blood; and

WHEREAS, Blood only has a shelf life of 42 days; and

WHEREAS, Blood centers rely heavily not only on blood donated on their premises, but on blood drives organized throughout their communities by volunteers; and

WHEREAS, Blood can be donated every 56 days and can improve the health of the donor by reducing excess iron and encouraging the body to produce more blood; and

WHEREAS, The State of Illinois recognizes the importance of blood donation through the Blood Donation Act, the Employee Blood Donation Leave Act, and the Organ Donor Leave Act; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Latino community in the State to share its unique gift of life by donating blood; and be it further

RESOLVED, That we further urge Latino businesses, churches, and other organizations to consider hosting a blood drive in their community and urge community colleges, colleges, universities, and trade schools to host blood drives and participate in the National Cesar E. Chavez Blood Drive Scholarship Challenge; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Illinois Coalition of Community Blood Centers.

#### ARTICLE IV THE LEGISLATURE

#### SECTION 6. ORGANIZATION

(a) A majority of the members elected to each house constitutes a quorum.

(b) On the first day of the January session of the General Assembly in odd-numbered years, the Secretary of State shall convene the House of Representatives to elect from its membership a Speaker of the House of Representatives as presiding officer, and the Governor shall convene the Senate to elect from its membership a President of the Senate as presiding officer.

(c) For purposes of powers of appointment conferred by this Constitution, the Minority Leader of either house is a member of the numerically strongest political party other than the party to which the Speaker or the President belongs, as the case may be. <u>A person who has served four 2-year terms as Speaker of the House of Representatives</u>, President of the Senate, Minority Leader of the House of Representatives, or Minority Leader of the Senate may not be re-elected to the same office. Service before the second Wednesday in January of 2017 shall not be considered in the calculation of a person's service.

(d) Each house shall determine the rules of its proceedings, judge the elections, returns and qualifications of its members and choose its officers. No member shall be expelled by either house, except by a vote of two-thirds of the members elected to that house. A member may be expelled only once for the same offense. Each house may punish by imprisonment any person, not a member, guilty of disrespect to the house by disorderly or contemptuous behavior in its presence. Imprisonment shall not extend beyond twenty-four hours at one time unless the person persists in disorderly or contemptuous behavior. (Source: Illinois Constitution.)

# ARTICLE V

# THE EXECUTIVE

SECTION 2. TERMS

These elected officers of the Executive Branch shall hold office for four years beginning on the second Monday of January after their election and, except in the case of the Lieutenant Governor, until their successors are qualified. They shall be elected at the general election in 1978 and every four years thereafter. A person may not be elected to the office of Governor or Lieutenant Governor for terms totalling more than 8 years for each office. Service before the second Monday in January of 2017 shall not be considered in the calculation of a person's service.

A person may serve no more than 8 years in any one of the following offices: Speaker of the House of Representatives, President of the Senate, Minority Leader of the House of Representatives, or Minority Leader of the Senate; provided that service before the second Wednesday in January of 2017 shall not be considered in the calculation of a person's service.

(c) For purposes of powers of appointment conferred by this Constitution, the Minority Leader of either house is a member of the numerically strongest political party other than the party to which the Speaker or the President belongs, as the case may be.

(d) Each house shall determine the rules of its proceedings, judge the elections, returns and qualifications of its members and choose its officers. No member shall be expelled by either house, except by a vote of two-thirds of the members elected to that house. A member may be expelled only once for the same offense. Each house may punish by imprisonment any person, not a member, guilty of disrespect to the house by disorderly or contemptuous behavior in its presence. Imprisonment shall not extend beyond twenty-four hours at one time unless the person persists in disorderly or contemptuous behavior. (Source: Illinois Constitution.)

#### SECTION 2. TERMS

These elected officers of the Executive Branch shall hold office for four years beginning on the second Monday of January after their election and, except in the case of the Lieutenant Governor, until their successors are qualified. Today I veto Senate Bill 33 from the 99<sup>th</sup> General Assembly, which would prematurely expand the Medical Cannabis Pilot Program by adding post-traumatic stress disorder (PTSD) to the list of "debilitating medical conditions" for which a patient may be treated with medical cannabis.

The pilot program is moving forward, but remains in its early stage. Cultivation centers are just beginning to grow their crops, and the first dispensary was licensed at the end of August. No patients have yet been served, and, consequently, the State has not had the opportunity to evaluate the benefits and costs of the pilot program or determine areas for improvement or even whether to extend the program beyond its pilot period.

It is therefore premature to expand the pilot program – before any patient has been served and before we have had the chance to evaluate it.

Therefore, pursuant to Section 9(b) of Article IV of the Illinois Constitution of 1970, I hereby return Senate Bill 33, entitled "AN ACT concerning health", with the foregoing objections, vetoed in its entirety.

# State Government Report Center Executive Summary

The following report outlines waivers of School Code mandates that school districts, regional offices of education, or special education or vocational education cooperatives have requested since the last report, which was transmitted in February 2015. Pursuant to Section 2-3.25g of the School Code (105 ILCS 5/2-3.25g), these requests must be sent to the General Assembly for its consideration before October 1, 2015.

The report is organized by subject area and by school district, regional office, or special education or vocational education cooperative. The General Assembly may disapprove the report in whole or in part within 60 calendar days after each chamber next convenes once the report is filed. This is done by a joint resolution. If either chamber fails to reject a waiver request, then that request is deemed granted.

Section I summarizes the 62 requests received for waivers of School Code mandates for consideration by the General Assembly, which are presented alphabetically by topic area. The largest number of

applications received (18 requests) seeks waivers from the requirements for non-resident tuition. There are 12 requests for school improvement/inservice training; ten requests for daily physical education; ten requests to raise the fee to be charged for driver's education; five requests related to administrative cost cap limitations; and four requests for the use of other practice driving methods in lieu of one or more of the required six hours of behind-the-wheel instruction in a dual control car on public roadways. There is one request each for the following topics: calculation of General State Aid; instructional time; and parent/teacher conferences.

Additionally, the General Assembly will be asked to consider one appeal of a State Board of Education decision to deny a request wishing to modify/waive statutory and regulatory requirements pertaining to rules governing administration of Transitional Bilingual Education, and four appeals of State Board decisions to deny requests pertaining to rules governing administration of the Illinois Kindergarten Individual Development Survey (KIDS). The five appeals are summarized in Section II.

Section 2-3.25g of the School Code (105 ILCS 5/2-3.25g) limits the number of waivers of daily physical education that may be requested by school districts and other eligible applicants to an initial, 2-year request, with the possibility of no more than two additional, 2-year requests. Of the ten waiver requests for physical education contained in this report, five districts are requesting their second and final renewal.

This document contains an additional section beyond what is required under Section 2-3.25g of the School Code. Section III is a database with listings of modifications or waivers of State Board of Education rules and modifications of School Code mandates upon which the State Superintendent of Education has acted in accordance with Section 1A-4 of the School Code (105 ILCS 5/1A-4). The database also includes listings of requests that have been returned to or withdrawn by the petitioning entities. In addition, the database includes the 67 waiver requests for the General Assembly's consideration and is organized by Senate and House districts.

Complete copies of the waiver requests for the General Assembly's consideration have been made available to legislative staff.

This is the forty-first report submitted pursuant to Section 2-3.25g of the School Code, which requires that the State Board of Education through agency staff compile and submit requests for waivers of School Code mandates to the General Assembly before March 1 and October 1 of each year.

The district states that this course of instruction accommodates more learning styles in a safe and controlled environment. If granted, this waiver would take effect in the 2016-17 school year.

# Wheaton CUSD 200 - DuPage (SD 21/HD 42) / Expiration: 2020-21 school year

**WM100-6101 (renewal)** – **Waiver of School Code** (Section 27-24.3) request to allow the district to use computerized simulators for up to 12 hours of practice driving in lieu of three hours of behind-thewheel instruction required to be conducted in a car with dual operating controls operated on public roadways. The district states that this format offers students the most consistent integrated program of driver education. If granted, this waiver would take effect in the 2016-17 school year.

# Lyons THSD 204 - Cook (SD 04/HD 08) / Expiration: 2020-21 school year

**WM100-6108 (renewal)** – **Waiver of School Code** (Section 27-24.3) request to allow the district to use practice driving on a controlled course with a supervisor for 11 hours in lieu of four hours of behindthe-wheel instruction required to be conducted in a car with dual operating controls operated on public roadways. The district states that this schedule will allow for more time spent on each area of instruction and more time spent with each student. If granted, this waiver would take effect in the 2016-17 school year.

# Vernon Hills CHSD 128 - Lake (SD 30/HD 59) / Expiration: 2020-21 school year

**WM100-6116 (renewal) – Waiver of School Code** (Section 27-24.3) request to allow the district to use computerized simulators for nine hours of practice driving in lieu of two and one-quarter hours of behind-the-wheel instruction required to be conducted in a car with dual operating controls operated on public roadways. The district states that simulators assist students to learn the mechanics of safe driving and accommodate more student learning styles. If granted, this waiver would take effect in the 2016-17 school year.

# General State Aid

# Indian Prairie CUSD 204 - DuPage (SD 42/HD 84) / Expiration: 2020-21 school year

**WM100-6088-1** – **Waiver of School Code** (Section 18-8.05(F)(2)) request to allow the district to count the attendance of students in grades 6 through 12 enrolled in a district-offered and/or district-approved online/blended education program by claiming one-fifth of a day for every clock hour of instruction attended in the online/blended education program, for up to two hours on each day that pupils are physically present in the school for three hours of in-school instruction. The district intends to create a virtual and blended learning model, which will cover 40 percent of students' time. The district states that offering online and/or blended course options will expand learning opportunities for all students, address individual learning needs, and assist students with unique circumstances. If granted, this waiver would take effect in the 2016-17 school year.

# Instructional Time

Community Unit School District 300 - Kane (SD 33/HD 65) / Expiration: 2020-21 school year WM100-6126-1 – Waiver of School Code (Section 18-8.05(F)(1)) request to allow the district to count days of attendance by pupils only for sessions of not less than three clock hours of school work

per day under direct supervision of teachers or non-teaching personnel engaged in non-teaching duties. The request applies solely for the implementation of a new virtual educational program designed to supplement the current high school (not elementary or middle school) curriculum and would not be used for programming outside of the virtual educational program. Students enrolled in the virtual educational learning program would have the same graduation requirements as students enrolled in traditional classroom courses, but would have the flexibility of completing up to 40 percent of their coursework in a different medium, at their own pace, in their own environment, and on their own schedule. If granted, this waiver would take effect in the 2016-17 school year.

#### Limitation of Administrative Costs

#### Paw Paw CUSD 271 - Lee (SD 45/HD 90) / Expiration: 2014-15 school year

WM100-6093 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The previous superintendent retired at the conclusion of the FY 2013 term. He continued to serve as an interim superintendent during the 2013-14 school year for no more than 100 days. A new superintendent was hired during FY 2014. The move from an interim superintendent to a full-time administrator caused the district's budgeted administrative costs for FY 2015 to exceed those for FY 2014 by more than the 5 percent limitation.

#### Jonesboro CCSD 43 - Union (SD 58/HD 115) / Expiration: 2015-16 school year

WM100-6115 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The district employed an interim superintendent during FY 2015. A full-time superintendent was hired for FY 2016. The move from an interim superintendent to a full-time administrator caused the district's budgeted administrative costs for FY 2016 to exceed those for FY 2015 by more than the 5 percent limitation.

# Nauvoo-Colusa CUSD 325 - Hancock (SD 47/HD 94) / Expiration: 2015-16 school year

WM100-6124 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The district closed its elementary school during FY 2015 and placed all students in the middle school. The superintendent had also served as a building principal before the district closed one school building. In FY 2016 the superintendent's salary will no longer be split between the two roles of superintendent/principal and the majority of his salary will be classified under a different category. This change in classification caused the district's budgeted administrative costs for FY 2016 to exceed those for FY 2015 by more than the 5 percent limitation.

# Odin PSD 722 – Marion (SD 54/HD 107) / Expiration: 2015-16 school year

WM100-6129 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The district employed an interim superintendent during FY 2015. A full-time superintendent was hired for FY 2016. The move from an interim superintendent to a full-time administrator caused the district's budgeted administrative costs for FY 2016 to exceed those for FY 2015 by more than the 5 percent limitation.

#### East St. Louis SD 189 - St. Clair (SD 57/HD 114) / Expiration: 2014-15 school year

WM100-6132 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. During FY 2015, as a function of corrective changes made to accounting codes in order to follow the Illinois Program Accounting Manual, the district's finance system reflected an increase in administrative expenses exceeding 5 percent without any actual changes in administrative positions or salaries. The necessary accounting corrections caused the district's budgeted administrative costs for FY 2016 to exceed those for FY 2015 by more than the 5 percent limitation.

# Eswood CCSD 269 - Ogle (SD 45/HD 90) / Expiration: 2019-20 school year

WM100-6062 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students to attend its schools at a reduced tuition cost of \$2,500. #### Princeville CUSD 326 - Peoria (SD 37/HD 73) / Expiration: 2020-21 school year

**WM100-6066 (renewal)** – **Waiver of School Code** (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are employees of the district to attend its schools free of charge. If granted, this waiver would take effect in the 2016-17 school year.

#### Lincoln CHSD 404 - Logan (SD 44/HD 87) / Expiration: 2019-20 school year

WM100-6078 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge.

*Hillsboro CUSD 3 – Montgomery* (SD 48/HD 95) / **Expiration: 2019-20 school year WM100-6082 – Waiver of School Code** (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are permanent employees of the district to attend its schools free of charge.

*New Holland – Middletown ED* 88 – *Logan* (SD 44/HD 87) / **Expiration: 2019-20 school year WM100-6086 – Waiver of School Code** (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge.

# Allen-Otter Creek CCSD 65 – LaSalle (SD 38/HD 75) / Expiration: 2019-20 school year

WM100-6087 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are employees of the district to attend its schools at a reduced tuition cost of \$675.

#### Galatia CUSD 1 - Saline (SD 59/HD 118) / Expiration: 2020-21 school year

**WM100-6091 (renewal)** – **Waiver of School Code** (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge. If granted, this waiver would take effect in the 2016-17 school year.

*Northwestern CUSD 2 – Macoupin* (SD 50/HD 100) / **Expiration: 2020-21 school year WM100-6095 (renewal) – Waiver of School Code** (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge. If granted, this waiver would take effect in the 2016-17 school year.

*Prairieview – Ogden CCSD 197 – Champaign* (SD 52/HD 104) / **Expiration: 2020-21 school year** WM100-6097-1 (renewal) – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge. If granted, this waiver would take effect in the 2016-17 school year.

*Prairieview – Ogden CCSD 197 – Champaign* (SD 52/HD 104) / **Expiration: 2020-21 school year** WM100-6097-2 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students to attend district schools at a reduced tuition charge of approximately 80 percent of the total per capita yearly tuition charge. If granted, this waiver would take effect in the 2016-17 school year.

*Cerro Gordo CUSD 100 – Piatt* (SD 51/HD 101) / **Expiration: 2020-21 school year WM100-6098 – Waiver of School Code** (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge. If granted, this waiver would take effect in the 2016-17 school year.

*Bluford USD 318 – Jefferson* (SD 58/HD 115) / **Expiration: 2019-20 school year WM100-6099 – Waiver of School Code** (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge.

Annawan CUSD 226 – Henry, Bureau (SD 37/HD 74) / Expiration: 2019-20 school year WM100-6100 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow

non-resident students whose parents are employees of the district to attend its schools free of charge.

# Raccoon CSD 1 - Marion (SD 54/HD 107) / Expiration: 2020-21 school year

**WM100-6107 (renewal)** – **Waiver of School Code** (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are employees of the district to attend its schools free of charge. If granted, this waiver would take effect in the 2016-17 school year.

#### Rankin SD 98 – Tazewell (SD 46/HD 91) / Expiration: 2020-21 school year

**WM100-6109** (renewal) – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge. If granted, this waiver would take effect in the 2016-17 school year.

Stewardson – Strasburg CUSD 5A – Shelby (SD 51/HD 102) / Expiration: 2019-20 school year WM100-6121 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge.

*Arthur CUSD 305 – Douglas* (SD 51/HD 102) / **Expiration: 2019-20 school year WM100-6122 – Waiver of School Code** (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are employees of the district to attend its schools free of charge.

*Kewanee CUSD 229 – Henry, Bureau* (SD 37/HD 74) / **Expiration: 2019-20 school year WM100-6131 – Waiver of School Code** (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are employees of the district to attend its schools free of charge.

# Parent-Teacher Conferences

#### Naperville CUSD 203 - DuPage (SD 21/HD 41) / Expiration: 2020-21 school year

**WM100-6090 (renewal)** – **Waiver of School Code** (Section 18-8.05(F)(2)(d)(1)) request to allow the district the option of scheduling twice during the school year a parent-teacher conference in the evening after a five-hour teacher institute held earlier that day. On the following day parent-teacher conferences will be conducted for four hours and employees will be dismissed in the afternoon. Each evening/morning session combination will be counted as one of the 176 days of pupil attendance required by Section 10-19. If granted, this waiver would take effect in the 2016-17 school year.

# Physical Education

#### Community High School District 117 - Lake (SD 32/HD 64) / Expiration: 2017-18 school year

**WM100-6074 (renewal)** – **Waiver of School Code** (Section 27-6) request to allow the district to excuse students in grades 11 and 12 from the daily physical education requirement for ongoing participation in cheerleading and the dance team (pom-pons squad). The district states that these activities are comparable in character and intensity to the interscholastic athletic activities in which juniors and seniors may participate in place of daily physical education. If approved, this waiver would take effect in the 2016-17 school year. If granted, this is the last physical education waiver the district will be permitted to request under the law.

#### Manteno CUSD 5 - Kankakee (SD 17/HD 34) / Expiration: 2017-18 school year

**WM100-6080** – **Waiver of School Code** (Section 27-6) request to allow the district to excuse students in grades 11 and 12 from the daily physical education requirement for ongoing participation in show choir. Students spend an average of six hours a week rehearsing choreography and performing. If the waiver is approved, students will have an opportunity to take an additional academic class in preparation for college and/or a career. If granted, this waiver would take effect in the 2016-17 school year.

# River Bend CUSD 2 - Whiteside (SD 36/HD 71) / Expiration: 2017-18 school year

**WM100-6096 (renewal)** – **Waiver of School Code** (Section 27-6) request to allow the district to permit students in kindergarten through grade 5 to participate in physical education for 45 minutes five times over a three-week period (averaging 15 minutes daily) and students in grades 6 through 8 to participate twice a week for 48 minutes each session due to inadequate facilities. The elementary

students share a gymnasium -- which also serves as the lunchroom -- with the middle school. Students in kindergarten through grade 5 also receive two recess periods each day, and middle school students participate in an extended lunch period that includes intramural activities under the direction of a teacher. If approved, this waiver would take effect in the 2016-17 school year. If granted, this is the last physical education waiver the district will be permitted to request under the law.

#### Downers Grove CHSD 99 - DuPage (SD 41/HD 81) / Expiration: 2016-17 school year

**WM100-6103** – **Waiver of School Code** (Section 27-6) request to allow the district to excuse students in grades 10 through 12 from the daily physical education requirement for the semester in which they are enrolled in driver education. The waiver would allow eligible students to participate in yearlong elective courses, including world languages, fine arts, and career and technical classes.

# Gardner South Wilmington THSD 73 – Grundy, Kankakee (SD 40/HD 79) / Expiration: 2016-17 school year

**WM100-6105** – **Waiver of School Code** (Section 27-6) request to allow the district to excuse students in grades 11 through 12 from the daily physical education requirement for courses offered through the Grundy Area Vocational Center (AVC). The waiver would allow upper-level high school students the opportunity to take career, technology and vocational classwork. Student use of the waiver would be determined on a semester-by-semester basis pending enrollment in the Grundy AVC.

#### Bureau Valley CUSD 340 - Bureau (SD 37/HD 74) - Expiration: 2017-18 school year

**WM100-6114 (renewal)** – **Waiver of School Code** (Section 27-6) request to allow the district to permit students in kindergarten through grade 5 to participate in physical education three times a week for 25 minutes each session. The district requests this waiver in order to achieve the best use of instructional time and in consideration of the various curricular demands affecting elementary teachers. If granted, this waiver would take effect in the 2016-17 school year.

# Community Consolidated School District 59 – Cook (SD 28/HD 55) / Expiration: 2017-18 school year

**WM100-6117 (renewal)** – **Waiver of School Code** (Section 27-6) request to allow the district to permit students in kindergarten through grade 5 to participate in physical education every third day for 40 minutes each session due to inadequate facilities. Students will participate in structured physical activities from classroom teachers to supplement the time spent in formal physical education. If granted, this waiver would take effect in the 2016-17 school year.

#### Lake Villa CCSD 41 - Lake (SD 32/HD 64) / Expiration: 2017-18 school year

**WM100-6118 (renewal)** – **Waiver of School Code** (Section 27-6) request to allow the district to permit students in kindergarten through grade 6 to participate in physical education once a week for 35 minutes. Students will also have daily recess, and teachers will provide structured classroom activities requiring movement and fitness. The district states that the waiver will allow additional classroom time to implement the Common Core State Standards. If approved, this waiver would take effect in the 2016-17 school year. If granted, this is the last physical education waiver the district will be permitted to request under the law.

#### Central CUSD 4 - Iroquois, Kankakee (SD 53/HD 106) / Expiration: 2017-18 school year

WM100-6127 (renewal) – Waiver of School Code (Section 27-6) request to allow the district to excuse students in grades 11 and 12 from the daily physical education requirement for daily enrollment in either the Kankakee Area Career Center or a work-study program. In addition, students in grades 9 and 10 would be excused from the daily physical education requirement if they participate in interscholastic sports for two of the three seasons encompassed in the school year. The district states that students eligible for this waiver would accrue additional college and/or career readiness courses. If approved, this waiver would take effect in the 2016-17 school year. If granted, this is the last physical education waiver the district will be permitted to request under the law.

# Proviso THSD 209 - Cook (SD 4/HD 7) / Expiration: 2017-18 school year

WM100-6128 (renewal) – Waiver of School Code (Section 27-6) request to allow the district to excuse students in grades 9 and 10 from the daily physical education requirement in order to take an academic course not mandated by existing graduation requirements but required by a post-secondary institution the student plans to attend or to take another academic or Advanced Placement class, with

prior approval of the superintendent. If approved, this waiver would take effect in the 2016-17 school year. If granted, this is the last physical education waiver the district will be permitted to request under the law.

# School Improvement/Inservice Training

*Warrensburg-Latham CUSD 11 – Macon* (SD 51/HD 101) / **Expiration: 2020-21 school year WM100-6069 – Waiver of School Code** (Section 18-8.05(F)(2)(d)(2)) request to allow the district to hold two full-day school improvement in-service sessions instead of four half days, and to count the days among the 176 days of actual pupil attendance required by Section 10-19. The district will accumulate sufficient time beyond the five-clock-hour requirement to apply towards these days. If granted, this waiver would take effect in the 2016-17 school year.

# Belvidere CUSD 100 - Boone (SD 35/HD 69) / Expiration: 2016-17 school year

**WM100-6070-1 (renewal)** – **Waiver of School Code** (Section 18-8.05(F)(2)(d)(2)) request to allow the district to hold three full-day school improvement in-service sessions instead of six half days, and to count the days among the 176 days of actual pupil attendance required by Section 10-19. The district will accumulate sufficient time beyond the five-clock-hour requirement to apply towards these days.

# Casey-Westfield CUSD 4C - Clark (SD 55/HD 110) / Expiration: 2019-20 school year

**WM100-6073** – **Waiver of School Code** (Section 18-8.05(F)(2)(d)(2)) request to allow the district to hold four full-day school improvement in-service sessions instead of eight to nine partial days, and to count the days among the 176 days of actual pupil attendance required by Section 10-19. The district will accumulate sufficient time beyond the five-clock-hour requirement to apply towards these days.

# Sullivan CUSD 300 - Moultrie (SD 51/HD 102) / Expiration: 2020-21 school year

**WM100-6075** – Waiver of School Code (Section 18-8.05(F)(2)(d)(2)) request to allow the district to hold three full-day school improvement in-service sessions instead of six half days, and to count the days among the 176 days of actual pupil attendance required by Section 10-19. The district will accumulate sufficient time beyond the five-clock-hour requirement to apply towards these days. If granted, this waiver would take effect in the 2016-17 school year.

# Cook County SD 130 - Cook (SD 14/HD 27) / Expiration: 2020-21 school year

**WM100-6077 (renewal)** – **Waiver of School Code** (Section 18-8.05(F)(2)(d)(2)) request to allow the district to hold three full-day school improvement in-service sessions instead of six half days, and to count the days among the 176 days of actual pupil attendance required by Section 10-19. The district will accumulate sufficient time beyond the five-clock-hour requirement to apply towards these days. If granted, this waiver would take effect in the 2016-17 school year.

# Indian Prairie CUSD 204 – DuPage, Will (SD 42/HD 84) / Expiration: 2020-21 school year

**WM100-6088-2** (renewal) – Waiver of School Code (Section 18-8.05(F)(2)(d)(2)) request to allow the district to hold two full-day school improvement in-service sessions instead of four half days, and to count the days among the 176 days of actual pupil attendance required by Section 10-19. The district will accumulate sufficient time beyond the five-clock-hour requirement to apply towards these days. If granted, this waiver would take effect in the 2016-17 school year.

#### County of Winnebago SD 320 - Winnebago (SD 35/HD 69) / Expiration: 2019-20 school year

**WM100-6092-1** (renewal) – Waiver of School Code (Section 18-8.05(F)(2)(d)(2)) request to allow the district to hold two full-day school improvement in-service sessions instead of four half days, and to count the days among the 176 days of actual pupil attendance required by Section 10-19. The district will accumulate sufficient time beyond the five-clock-hour requirement to apply towards these days.

# Ball-Chatham CUSD 5 - Sangamon (SD 50/HD 99) / Expiration: 2020-21 school year

**WM100-6102** – **Waiver of School Code** (Section 18-8.05(F)(2)(d)(2)) request to allow the district to hold four full-day school improvement in-service sessions instead of seven half days, and to count the days among the 176 days of actual pupil attendance required by Section 10-19. The district will accumulate sufficient time beyond the five-clock-hour requirement to apply towards these days. If granted, this waiver would take effect in the 2016-17 school year.

# Macomb CUSD 185 – McDonough (SD 47/HD 93) / Expiration: 2019-20 school year

**WM100-6111 (renewal)** – **Waiver of School Code** (Section 18-8.05(F)(2)(d)(2)) request to allow the district to hold two full-day school improvement in-service sessions instead of four half days, and to count the days among the 176 days of actual pupil attendance required by Section 10-19. The district will accumulate sufficient time beyond the five-clock-hour requirement to apply towards these days.

# Queen Bee SD 16 - DuPage (SD 23/HD 46) / Expiration: 2020-21 school year

**WM100-6119 (renewal)** – **Waiver of School Code** (Section 18-8.05(F)(2)(d)(2)) request to allow the district to hold two full-day school improvement in-service sessions instead of four half days, and to count the days among the 176 days of actual pupil attendance required by Section 10-19. The district will accumulate sufficient time beyond the five-clock-hour requirement to apply towards these days. If granted, this waiver would take effect in the 2016-17 school year.

# Bloomington SD 87 - McLean (SD 44/HD 88) / Expiration: 2020-21 school year

**WM100-6120 (renewal)** – **Waiver of School Code** (Section 18-8.05(F)(2)(d)(2)) request to allow the district to hold two full-day school improvement in-service sessions instead of four half days, and to count the days among the 176 days of actual pupil attendance required by Section 10-19. The district will accumulate sufficient time beyond the five-clock-hour requirement to apply towards these days. If granted, this waiver would take effect in the 2016-17 school year.

Community Unit School District 300 - Kane (SD 33/HD 65) / Expiration: 2019-20 school year WM100-6126-2 (renewal) – Waiver of School Code (Section 18-8.05(F)(2)(d)(2)) request to allow the district to hold two full-day school improvement in-service sessions instead of four half days, and to count the days among the 176 days of actual pupil attendance required by Section 10-19. The district will accumulate sufficient time beyond the five-clock-hour requirement to apply towards these days.

# SECTION II

#### Appeals of Applications Denied by the Illinois State Board of Education

#### Transitional Bilingual Education

Marquardt SD 15 – DuPage (SD 23/HD 46) / Expiration: 2018-19 school year

WM300-6029-A (appeal) – Modification of School Code (105 ILCS 5/14C-2) and Modification of Administrative Rule (23 Ill. Adm. Code 228.30). The district is appealing the State Board's denial of its petition requesting to modify the language in Section 14C-2 of the School Code (and the accompanying rules of the State Board of Education for Transitional Bilingual Education [TBE]) that describes a program in transitional bilingual education as one that provides English learners with instruction in English (as well as in the students' native language) and that provides instruction "... in the reading and writing of the native language" of the students enrolled in the program. The district proposed a process to accelerate student achievement of English learners and their integration into the regular curriculum, requesting the following modifications to the School Code (105 ILCS 5/14C-2) and the accompanying rules of the State Board of Education:

(f) "Program in transitional bilingual education" means a full-time program of instruction (1) in all those courses or subjects which a child is required by law to receive and which are required by the child's school district, which shall be given <u>with support</u> in the native language of the children of limited English-speaking ability who are enrolled in the program, <u>within an English-language instructional model</u> and also in English, (2) in the reading and writing of the native language of the children of limited English-speaking ability who are enrolled in the program and in the oral language (listening and speaking), reading, and writing of English, and (3) in the history and culture of the country, territory, or geographic area which is the native land of the parents of children of limited English-speaking ability who are enrolled in the elucational needs of those children of limited English speaking ability who are on the educational needs of those children of limited English speaking ability who are and in the history and culture of the United States; or a part-time program of instruction based on the educational needs of those children of limited English speaking ability who do not need a full-time program of instruction.

Marquardt's request proposed using bilingual education teachers to support TBE development by providing a model of instructional assistance targeting the use of native language as needed for

academic support and English as a Second Language (ESL) instruction to promote academic growth and achievement toward Common Core State Standards.

The district states that its appeal should be granted on the grounds that the State Board's denial did not accurately portray the nature of Marquardt's request on the following key points:

- The sound educational practices on which the proposed program was founded;
- Student achievement data submitted by the Marquardt district in support of its request; and
- The district's proposed modifications and program being consistent with applicable civil rights laws.

The State Board denied the request from Marquardt SD 15 because it was not based on sound educational practices and did not have improved student performance as a primary goal. The language in the waiver request proposes serving students based on certain tests, teacher recommendations, and student performance, which are narrower measures than those currently employed to determine who is entitled to receive English Language Learning Services, thus potentially compromising equal opportunities for learning. Second, the modifications requested do not seem likely to improve student performance based on sound educational practices. Marquard's waiver request would eliminate instruction in the reading and writing of the students' native languages. This request is inconsistent with its proposed program model. In a transitional model with push-in/pull-out services, instruction in reading and writing of the native language will be necessary for some full-time students who display a low level of English proficiency, but are already fluent in their native language. Again, research demonstrates the academic benefit for students who develop literacy in their native language, which will ultimately support their development in English literacy. Native language development and instruction allows students to access rigorous and challenging academic content, while also acquiring academic English content, leading to long-term, higher achievement.

# Illinois Kindergarten Individual Development Survey (KIDS)

Four districts have submitted appeals of the State Board's denials of their five-year requests not to administer the Illinois Kindergarten Individual Development Survey (KIDS) (Section 1.420(h)(3) of the State Board's rules for Public Schools Evaluation, Recognition and Supervision (23 Ill. Adm. Code 1.420(h)(3)). The appeals are from:

- Barrington CUSD 200, Lake County (WM200-6027-A);
- Glencoe SD 35, Cook County (WM200-6034-A);
- Wilmette SD 39, Cook County (WM200-6058-A); and
- Wauconda CUSD 118, Lake County (WM200-6061-A).

In each case, the district requested that it not be required to administer the assessment for five years, beginning in the 2015-2016 school year and concluding with the 2019-2020 school year. The State Board's response to each district noted that the waiver was not needed for the first year (2015-2016), since the assessment would not be required by the state that year, but was disapproved for the remaining years (2016-2017 through 2019-2020).

The KIDS initiative is a statewide initiative that provides school readiness information for kindergarteners across multiple development domains through the use of observational assessment. The four districts noted in their requests that they had comprehensive systems of assessment already in place and that the addition of another test could have the effect of taking away from instructional time without connections to the existing kindergarten curriculum. Concerns were raised over the amount of time that would be required for collection of evidence used to evaluate the status of student progress in the domains of the KIDS assessment, and the number of days teachers would need to be away from their classes in order to attend mandatory training. Costs to the districts, and added workloads for teachers, were also noted as reasons not to be required to administer KIDS. The four districts cited their current approaches to assessment as being more effective and efficient.

In denying the waivers the agency considered the importance of collecting school readiness data and new flexibility available to all districts implementing the assessment. School readiness data provide

baseline information for tracking student progress and promoting student success early in a child's academic career. Section 10-17a(2)(D) of the School Code requires that the annual State School Report Card include "...a measure of students entering kindergarten ready to learn." The KIDS assessment will provide these data. Furthermore, at the time the waiver requests were submitted, the State Board was in the process of revising its rules to modify the KIDS requirements for all districts. Based on feedback from districts throughout the pilot implementation of KIDS, the three-year timeline is expected to promote practices for the effective administration of KIDS; reduce the burden on teachers as they learn to use the assessment instrument; and provide additional support from the state. If districts are granted waivers from the assessment instrument, they will not benefit from these additional support components.
