#### **SENATE RESOLUTION NO. 1473**

WHEREAS, Heart disease is the number one killer of women, yet 80% of cardiac events can be prevented; and

WHEREAS, Cardiovascular diseases cause one in three women's deaths each year, killing approximately one woman every minute; and

WHEREAS, An estimated 44 million women in the United States are affected by cardiovascular diseases; and

WHEREAS, Ninety percent of women have one or more risk factors for developing heart disease, yet only one in five American women believe that heart disease is her greatest health threat; and

WHEREAS, Since 1984, more women than men have died each year from heart disease; and

WHEREAS, Women comprise only 24% of participants in all heart-related studies; and

WHEREAS, Women are less likely to call 911 for themselves when experiencing symptoms of a heart attack than they are if someone else was having a heart attack; and

WHEREAS, Only 43% of African American women and 44% of Hispanic women know that heart disease is their greatest health risk, compared with 60% of Caucasian women; and

WHEREAS, Women involved with the American Heart Association's Go Red For Women movement live healthier lives and nearly 90% have made at least one healthy behavior change; and

WHEREAS, Go Red For Women is asking all Americans to Go Red by wearing red and speaking red; the objects of this initiative include: Get Your Numbers by asking your doctor to check your blood pressure and cholesterol; Own Your Lifestyle by quitting smoking, losing weight, exercising, and eating healthy; Raise Your Voice by advocating for more women-related research and education; Educate Your Family by teaching your kids the importance of staying active and making healthy food choices for you and your family; and Don't Be Silent by telling every woman you know that heart disease is her number one killer and by raising your voice at GoRedForWomen.org; and

WHEREAS, By increasing awareness, speaking up about heart disease, and empowering women to reduce their risk for cardiovascular disease, we can save thousands of lives each year; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the importance of the ongoing fight against heart disease and stroke by designating February 5, 2016 as "Wear Red Day" in the State of Illinois and urging all citizens to show their support for women and the fight against heart disease by commemorating this day through the wearing of the color red.

# **SENATE JOINT RESOLUTION NO. 38**

WHEREAS, Horseback riding is a recreational pastime that is enjoyed by many citizens in Illinois and the United States and it should be widely available to as many members of the public who wish to participate; and

WHEREAS, The expansion of bridle paths in Illinois is necessary to further promote this recreational pastime; and

WHEREAS, Open space and land areas can be utilized to create bridle paths; and

WHEREAS, This expansion will also aid in the economic development of Illinois; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there is hereby created the Recreational Bridle Path Task Force to study, assess, and make recommendations on the existing bridle paths in Illinois and the feasibility of creating additional paths, specifically in State parks; in addition, the Task Force shall recommend any necessary legislation for the creation of new bridle paths; and be it further

RESOLVED, That within 90 days after the adoption of this resolution, members of the Task Force shall be appointed by the Governor and shall consist of one member from each of the following agencies or interest groups:

1) member of the Department of Natural Resources;

2) member of the Department of Transportation;

- 3) member of the Department of Agriculture; and
- 4) member from an entity or association which has vested interests in areas where paths

exist or may exist, including, but not limited to, bridle paths, bicycle paths, and ATV paths; and be it further

RESOLVED, That within 90 days after the adoption of this resolution, the President of the Senate, the Minority Leader of the Senate, the Speaker of the House of Representatives, and the Minority Leader of the House of Representatives shall each appoint one member from an entity or association which has vested interests in areas where paths exist or may exist, including, but not limited to, bridle paths, bicycle paths, and ATV paths; and be it further

RESOLVED, That the term of the appointment shall be until submission of the report of comprehensive recommendations; the member from the Department of Natural Resources shall chair the Task Force and serve as a liaison to the Governor and General Assembly; meetings of the Task Force shall be held as necessary to complete the duties of the Task Force; meetings of the Task Force shall be held in the central part of the State; and be it further

RESOLVED, That the Department of Natural Resources shall provide administrative support, technical assistance, and meeting space to the Task Force; and be it further

RESOLVED, That the members of the Task Force shall receive no compensation for serving; and be it further

RESOLVED, That the Task Force shall submit a report with comprehensive recommendations to the Governor and General Assembly no later than December 31, 2016.

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that if the voters adopt the Independent Redistricting Commission constitutional amendment, we urge the General

AMENDMENT NO. 1. Amend Senate Bill 2043 by replacing everything after the enacting clause with the following:

"Section 5. The amount of \$2, or so much of that amount as may be necessary, is appropriated from the General Revenue Fund to the Illinois Student Assistance Commission for its FY16 ordinary and contingent expenses.

AMENDMENT NO. 2. Amend Senate Bill 2043, by replacing everything after the enacting clause and inserting the following:

# "ARTICLE 1

Section 5. The sum of \$397,073,100, or so much thereof as may be necessary, is appropriated to the Illinois Student Assistance Commission from the General Revenue Fund for grant awards to students eligible for the Monetary Award Program, as provided by law, and for agency administrative and operational costs not to exceed 2 percent of the total appropriation in this Section.

Section 10. The sum of \$274,601,000, or so much thereof as may be necessary, is appropriated from the Education Assistance Fund to the Illinois Community College Board for distribution of base operating and equalization grants to qualifying public community colleges and the City Colleges of Chicago for educational related expenses.

Section 15. The following named amounts, or so much thereof as may be necessary, are appropriated to the Illinois Community College Board for all costs associated with career and technical education activities:

From the General Revenue Fund ...... 17,569,400

Section 20. The following named amounts, or so much of those amounts as may be necessary, for the objects and purposes named, are appropriated to the Illinois Community College Board for adult education and literacy activities: From the General Revenue Fund:

For payment of costs associated

with education and educational-related

services to local eligible providers

for adult education and

literacy21,572,400

For payment of costs associated with education and educational-related services to local eligible providers

# ARTICLE 998

Section 998. The appropriation authority granted in this Act shall be valid only for costs incurred July 1, 2015 to June 30, 2016.

ARTICLE 999

Section 999. Effective date. This Act takes effect upon becoming law.".
