waivers and modifications acted on by the State Superintendent of Education in accordance with Section 1A-4 of the School Code (105 ILCS 5/1A-4) and applications that have been returned to school districts or other eligible applicants.

#### **Executive Summary**

The following report outlines waivers of School Code mandates that school districts, regional offices of education, or special education or vocational education cooperatives have requested since the last report, which was transmitted in September 2015. Pursuant to Section 2-3.25g of the School Code (105 ILCS 5/2-3.25g), these requests must be sent to the General Assembly for its consideration before March 1, 2016.

The report is organized by subject area and by school district, regional office of education, or special education or vocational education cooperative. The General Assembly may disapprove the report in whole or in part within 60 calendar days after each chamber next convenes once the report is filed. This is done by a joint resolution. If either chamber fails to reject a waiver request, then that request is deemed granted.

Section I summarizes the 83 requests received for waivers of School Code mandates for consideration by the General Assembly, which are presented alphabetically by topic area. The largest number of applications received (32 requests) seeks waivers from the requirements for non-resident tuition. There are 15 requests related to administrative cost cap limitations; ten requests for daily physical education; eight requests for school improvement/inservice training; six requests to raise the fee to be charged for driver's education; and three requests for the use of other practice driving methods in lieu of one or more of the required six hours of behind-thewheel instruction in a dual control car on public roadways. There are two requests each for parent-teacher conferences and statement of affairs. There is one request each for the following topics: alternative public schools; areas of education; contracts; school building code provisions; and interim superintendent.

Section 2-3.25g of the School Code (105 ILCS 5/2-3.25g) limits the number of waivers of daily physical education that may be requested by school districts and other eligible applicants to an initial, 2-year request, with the possibility of no more than two additional, 2-year renewal requests. Of the ten waiver requests for physical education contained in this report, seven districts are requesting their second and final renewal.

This document contains an additional section beyond what is required under Section 2-3.25g of the School Code. Section II is a database with listings of modifications or waivers of State Board of Education rules and modifications of School Code mandates upon which the State Superintendent of Education has acted in accordance with Section 1A-4 of the School Code (105 ILCS 5/1A-4). The database also includes listings of requests that have been returned to or withdrawn by the petitioning entities. In addition, the database includes the 83 waiver requests for the General Assembly's consideration and is organized by Senate and House districts.

Complete copies of the waiver requests for the General Assembly's consideration have been made available to legislative staff.

This is the forty-second report submitted pursuant to Section 2-3.25g of the School Code, which requires that the State Board of Education through agency staff compile and submit requests for

waivers of School Code mandates to the General Assembly before March 1 and October 1 of each year.

#### **Applications Transmitted to the General Assembly**

#### **Alternative Public Schools**

Regional Office of Education #50 – St. Clair (SD 57/HD 113) / Expiration: 2020-2021 school

**WM100-6193 – Waiver of School Code** (Section 13A-2.5) request to allow the Regional Safe School Program to lower the eligible grade level for disruptive students from 6<sup>th</sup> grade to 5<sup>th</sup>

grade. The Regional Office states that this waiver would allow additional students at risk of dropping out to be served and provide another chance for them to complete high school graduation requirements on time. A self-contained classroom would be created for students in grades 5 and 6. Students in the middle grades attending the safe school (grades 5-8) would be totally separate from high school students in the facility at all times of the day. Curriculum will be aligned with the student's home school and Differentiated Instruction (DI) will be part of the pedagogy of the safe school.

#### Areas of Education

Steeleville CUSD 138 – Randolph (SD 58/HD 116) / Expiration: 2020-2021 school year WM100-6196 – Waiver of School Code (Section 27-1, 23 III. Adm. Code 1.430(a)(5), 1.440(a)(6)) request to allow the district to eliminate music from the curriculum for grades 5 - 12 in order to ensure maintenance of core academic programs. The district states that its fine arts program includes art, technical education, and foreign language. The difficult decision to eliminate music as an offering was based, in part, on the fact that student interest in the music program had deteriorated to the point that it was no longer possible to have a vocal or instrumental music component.

#### Contracts

City of Chicago SD 299 – Cook (SD 3/HD 5) / Expiration: 2020-2021 school year WM100-6165-2 (renewal) – Waiver of School Code (Section 34-21.3) request to allow the district to use a request for proposals process rather than a fixed bidding process in order to procure food service management contracts and vended meal contracts.

#### Driver Education

#### Fee Limits

Maine THSD 207 – Cook (SD 28/HD 55) / Expiration: 2020-21 school year WM100-6164 (renewal) – Waiver of School Code (Section 27-24.2) request to allow the district to charge a fee not to exceed \$500 of students who participate in driver education courses.

Zion-Benton THSD 126 – Lake (SD 31/HD 61) / Expiration: 2020-21 school year WM100-6173 (renewal) – Waiver of School Code (Section 27-24.2) request to allow the district to charge a fee not to exceed \$300 of students who participate in driver education courses.

McLean County USD 5 – McLean (SD 53/HD 105) / Expiration: 2020-21 school year WM100-6181 (renewal) – Waiver of School Code (Section 27-24.2) request to allow the district to charge a fee not to exceed \$450 of students who participate in driver education courses.

Plainfield SD 202 – Will (SD 49/HD 97) / Expiration: 2020-21 school year WM100-6191-2 (renewal) – Waiver of School Code (Section 27-24.2) request to allow the district to charge a fee not to exceed \$400 of students who participate in driver education courses.

Barrington CUSD 220 – Lake (SD 26/HD 51) / Expiration: 2020-21 school year WM100-6201 (renewal) – Waiver of School Code (Section 27-24.2) request to allow the district to charge a fee not to exceed \$350 of students who participate in driver education courses.

Amboy CUSD 272 – Lee (SD 45/HD 90) / Expiration: 2020-21 school year WM100-6221 (renewal) – Waiver of School Code (Section 27-24.2) request to allow the district to charge a fee not to exceed \$350 of students who participate in driver education courses.

#### Behind-the-Wheel Instruction

district to use four hours of range driving in lieu of two hours of behind-the-wheel instruction required to be conducted in a car with dual operating controls operated on public roadways. The district states that this format offers the best opportunity for improved student performance and the training of safe drivers.

Triad CUSD 2 - Madison (SD 54/HD 108) / Expiration: 2020-21 school year

**WM100-6200 (renewal) – Waiver of School Code** (Section 27-24.3) request to allow the district to use computerized simulators for five hours of practice driving in lieu of one and one-quarter hours of behind-the-wheel instruction required to be conducted in a car with dual operating controls operated on public roadways. The district states that this method will further students' preparation for driving because of the range of experiences provided by the simulator curriculum.

Thornton THSD 205 - Cook (SD 15/HD 29) / Expiration: 2020-21 school year

**WM100-6218 (renewal) – Waiver of School Code** (Section 27-24.3) request to allow the district to use computerized simulators for up to 20 hours of practice driving in lieu of three hours of behind-the-wheel instruction required to be conducted in a car with dual operating controls operated on public roadways. The district states that this format offers students more effective instruction by providing direct behind-the-wheel supervision and guided simulation practices.

#### Limitation of Administrative Costs

Morrisonville CUSD 1 - Christian (SD 48/HD 95) / Expiration: 2015-16 school year

**WM100-6133 – Waiver of School Code** (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The district hired a full-time superintendent for the 2014-15 school year, but she passed away suddenly in the middle of the year. An interim superintendent was hired for the remainder of the year. The administrative costs for the year were lower than expected. The hiring of a full-time superintendent for the 2015-16 school year caused the district's budgeted administrative costs for FY 2016 to exceed those for FY 2015 by more than the 5 percent limitation.

Montmorency CCSD 145 – Whiteside (SD 36/HD 71) / Expiration: 2015-16 school year WM100-6136 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The district employed an interim superintendent working for 100 days in the 2013-14 and 2014-15 school years. Starting with the 2015-16 school year, the district employs a full-time superintendent. The move from an interim superintendent to a full-time administrator caused the district's budgeted administrative costs for FY 2016 to exceed those for FY 2015 by more than the 5 percent limitation.

Carterville CUSD 5 – Williamson (SD 59/HD 117) / Expiration: 2014-15 school year WM100-6146 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The district promoted the high school principal to an associate superintendent, allowing him to train with the retiring superintendent preparatory to taking over the position at the end of FY 2015. In addition, the district employed a business manager in FY 2015, following several years of hiring a certified public accountant on a contractual basis. The combined effects of the one-time associate superintendent expense and the business manager salary caused the district's budgeted administrative costs for FY 2015 to exceed those for FY 2014 by more than the 5 percent limitation.

Wayne City CUSD 100 – Wayne (SD 55/HD 109) / Expiration: 2015-16 school year WM100-6152 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The district's superintendent also served as building principal during the 2013-14 and 2014-15 school years, and a portion of his salary would not have appeared on the district's limitation of administrative costs worksheet. Beginning in the 2015-16 school year, a building principal was hired and the superintendent may now devote time solely to administrative duties. The change in cost allocation for the superintendent's salary and benefits caused the district's budgeted administrative costs for FY 2016 to exceed those for FY 2015 by more than the 5 percent

limitation.

River Ridge CUSD 210 – Jo Daviess (SD 45/HD 89) / Expiration: 2015-16 school year WM100-6153 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The superintendent's salary was increased in his final contract year after serving 43 years in the district and exhibiting a record of meeting benchmarks and providing leadership consistency. In addition, the district increased technology costs in order to provide advanced technology in district classrooms. Middle- and high-school students were given access to one-on-one computers, and computers were introduced in the elementary grades. The combined effect of these changes caused the district's budgeted administrative costs for FY 2016 to exceed those for FY 2015 by more than the 5 percent limitation.

Rooks Creek CCSD 425 – Livingston (SD 53/HD 106) / Expiration: 2015-16 school year WM100-6157 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The unexpected illness of the superintendent caused him to retire in the fall of 2015. An interim superintendent was hired for the remainder of the school year. The extra expenses for the interim position, added to the district's contractual obligations to the retired superintendent, caused the district's budgeted administrative costs for FY 2016 to exceed those for FY 2015 by more than the 5 percent limitation.

Maine Township HSD 207 – Cook (SD 28/HD 55) / Expiration: 2015-16 school year WM100-6158 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. During FY 2011, the district reduced its expenditures, in part by requiring departmental chairs to teach an extra class. Since that time the district has implemented the required teacher evaluation program, which increases the oversight and the complexity of evaluations performed by chairs of departments. For the 2015-16 school year, the district has reduced the number of department chairs and has also reduced chairs' class load in order to provide a rigorous evaluation program. These changes caused the district's budgeted administrative costs for FY 2016 to exceed those for FY 2015 by more than the 5 percent limitation.

Rantoul City SD 137 – Champaign (SD 52/HD 104) / Expiration: 2015-16 school year WM100-6159 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. In previous years the salary and costs for the assistant superintendent were divided among several functions, including special education. The district withdrew from membership in the Rural Champaign County Special Education Cooperative (RCCSEC) and, as a result, must hire a director of special education. The need to engage an additional administrator caused the district's budgeted administrative costs for FY 2016 to exceed those for FY 2015 by more than the 5 percent limitation.

Gallatin CUSD 7 – Gallatin (SD 59/HD 118) / Expiration: 2014-15 school year WM100-6171 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. Two errors were made in the district's FY 2015 budget development that caused the district to exceed the cost cap limitation. Insurance costs for the superintendent were entered incorrectly and there was no allocation of a percentage of the superintendent's salary to transportation costs, as had been done in past years. These errors caused the district's budgeted administrative costs for FY 2015 to exceed those for FY 2014 by more than the 5 percent limitation.

Woodland CUSD 5 – Livingston, LaSalle (SD 53/HD 106) / Expiration: 2015-16 school year WM100-6174 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The district employed an interim superintendent for the 2014-15 school year. For the 2015-16 school year the district hired a full-time superintendent. The need to have a full-time administrator in the district caused the district's budgeted administrative costs for FY 2016 to exceed those for FY 2015 by more than the 5 percent limitation.

Palos Heights SD 128 - Cook (SD 14/HD 27) / Expiration: 2015-16 school year

**WM100-6177 – Waiver of School Code** (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The district employed an interim superintendent for the 2014-15 school year. For the 2015-16 school year the district hired a full-time superintendent. The need to have a full-time administrator in the district caused the district's budgeted administrative costs for FY 2016 to exceed those for FY 2015 by more than the 5 percent limitation.

Proviso THSD 209 - Cook (SD 04/HD 07) / Expiration: 2014-15 school year

WM100-6198 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The district computed its estimated FY 2015 administrative costs using FY 2014 actual costs, which were on a cash basis. This computation showed an increase within the statutory limitation of 5 percent. However, the district's Annual Financial Report as of June 30, 2014, was presented on the modified accrual basis, resulting in a decrease in actual administrative costs for FY 2014 from the original cash basis estimates. Because of this finding, the district's official FY 2015 administrative costs worksheet exceeded the statutory limitation. The district's amended budget again used the original estimate, with the result that the amended budget did not correct the district's problem. Proviso has reported this situation as a single-year issue, noting that administrators are working to properly code and track administrative expenses.

Bartonville SD 66 – Peoria (SD 46/HD 92) / Expiration: 2015-16 school year

**WM100-6199 – Waiver of School Code** (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The district's superintendent is employed in a dual role as superintendent and principal. The district intends to hire a full-time principal beginning in the 2016-17 school year, using a separate account for each administrator. The district expects the move to separate superintendent and principal positions will benefit the district by allowing the superintendent to concentrate on budgeting, professional development and overall student academic success, while the principal concentrates on student behavior, interventions and instruction. The need to have a full-time principal in the district caused the district's budgeted administrative costs for FY 2016 to exceed those for FY 2015 by more than the 5 percent limitation.

Brookwood SD 167 - Cook (SD 15/HD 29) / Expiration: 2015-16 school year

**WM100-6205 – Waiver of School Code** (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The district employed a full-time curriculum director beginning in the 2015-16 school year. This new position provides a needed curriculum framework and educational leadership for the district. The need to establish this administrative position caused the district's budgeted administrative costs for FY 2016 to exceed those for FY 2015 by more than the 5 percent limitation.

Lindop SD 92 - Cook (SD 04/HD 07) / Expiration: 2015-16 school year

**WM100-6206 – Waiver of School Code** (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. Three circumstances caused the need for the waiver: the change from a retired superintendent to a full-time superintendent with benefits starting in the 2015-16 school year; the need to provide additional health insurance for the district's director of business operations following his marriage; and the inclusion of copy lease payments within a cost function on the administrative limitation worksheet. The need to make the necessary personnel and insurance coverage changes in the district caused the district's budgeted administrative costs for FY 2016 to exceed those for FY 2015 by more than the 5 percent limitation.

#### Non-resident Tuition

Kansas CUSD 3 - Edgar (SD 55/HD 110) / Expiration: 2020-21 school year

**WM100-6139 – Waiver of School Code** (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge.

Tremont CUSD 702 – Tazewell (SD 44/HD 87) / Expiration: 2020-21 school year WM100-6144 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time licensed employees of the district to attend its schools free of charge.

Thompsonville CUSD 174 – Franklin (SD 59/HD 117) / Expiration: 2020-21 school year WM100-6145 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge.

Marissa CUSD 40-St. Clair (SD 58/HD 116) / Expiration: 2020-21 school year WM100-6148 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are employees of the district to attend its schools free of charge.

AlWood CUSD 225 – Henry (SD 37/HD 74) / Expiration: 2020-21 school year WM100-6150 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are employees of the district to attend its schools free of charge.

Robein SD 85 – Tazewell (SD 44/HD 88) / Expiration: 2020-21 school year WM100-6151 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students to attend its schools at a reduced tuition cost of \$2,600.

River Ridge CUSD 210 – Jo Daviess (SD 45/HD 89) / Expiration: 2020-21 school year WM100-6156 (renewal) – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge.

Herscher CUSD 2 – Kankakee (SD 40/HD 79) / Expiration: 2020-21 school year WM100-6161 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are employees of the district to attend its schools free of charge.

Bement CUSD 5 – Piatt (SD 51/HD 101) / Expiration: 2020-21 school year WM100-6163 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are employees of the district to attend its schools free of charge.

Monmouth – Roseville CUSD 238 – Warren (SD 47/HD 94) / Expiration: 2020-21 school year WM100-6167 (renewal) – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are employees of the district to attend its schools free of charge.

Red Hill CUSD 10 – Lawrence (SD 55/HD 109) / Expiration: 2020-21 school year WM100-6168 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge.

Chadwick - Milledgeville CUSD 399 - Carroll (SD 45/HD 89) / Expiration: 2020-21 school year

WM100-6169 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge.

Cumberland CUSD 77 – Cumberland (SD 55/HD 110) / Expiration: 2020-21 school year WM100-6170 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge.

Elverado CUSD 196 – Jackson (SD 58/HD 115) / Expiration: 2020-21 school year WM100-6175 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge.

Chester CUSD 139 – Randolph (SD 58/HD 116) / Expiration: 2020-21 school year WM100-6178 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are employees of the district to attend its schools free of charge.

To the Honorable Members of The Illinois Senate, 99th General Assembly:

Today I veto Senate Bill 2043 from the 99th General Assembly, which would explode the State's budget deficit, exacerbate the State's cash flow crisis, and place further strain on social service providers and recipients who are already suffering from the State's deficit spending.

#### SB 2043 Would Exacerbate Our Budget and Cash Flow Deficits

Senate Bill 2043 would appropriate \$721 million for the Monetary Award Program (MAP) and community colleges programs. Senate Bill 2043 proposes the same funding levels for these programs as were included in the unconstitutional, unbalanced budget passed by the General Assembly last year, which was opposed by many legislators, including Democrats, and which I vetoed.

Despite its constitutional obligation to balance the budget, the General Assembly has not put forward a plan to pay for these programs, whether through spending reductions, revenue, or cost-saving reforms.

The Governor's Office of Management and Budget concluded that Senate Bill 2043 would add \$721 million to the State's budget deficit.

Today, the Comptroller reports 48,000 vendor vouchers waiting to be paid, a \$7.2 billion backlog of bills, and a grand total balance of \$145 million in the general funds. This bill would spend money the State does not have.

Moreover, Senate Bill 2043's unfunded spending would significantly exacerbate the State's current cash flow challenges. To protect and prioritize General State Aid payments, the Comptroller would be forced to further delay payments for other goods and services across State government, putting social services further at risk. We have already seen that the State's deficit spending is harshest to social service providers and our State's most vulnerable residents. Senate Bill 2043 would further delay those payments at a time when those recipients are already under fiscal stress.

#### A Better, Constitutional Way to Fund Higher Education

The Constitution and our obligation to taxpayers require a balanced budget. Recognizing this, legislators in both the House of Representatives and the Senate put forward a plan to pay for higher education spending – not just those programs included in Senate Bill 2043, but also funding for our public universities. I thank them for their leadership.

House Bill 4539 and Senate Bill 2349 would appropriate \$1.6 billion for higher education programs, while Senate Bill 2789 would authorize the Governor, Comptroller, and Treasurer to identify and implement funding by reallocating funds and reducing spending in other areas. Together these bills would fund MAP, community college programs, and our public universities, without exploding the deficit or exacerbating the State's cash flow crisis. This is a far more fiscally responsible – and constitutional – plan for funding higher education.

Therefore, pursuant to Section 9(b) of Article IV of the Illinois Constitution of 1970, I hereby return Senate Bill 2043, entitled "AN ACT concerning appropriations", with the foregoing objections, vetoed in its entirety.
