WHEREAS, Positive attitudes towards African Americans, Latinos, Arabs, American Sikhs, American Muslims, and other communities of color, has declined; and

WHEREAS, There has been an increase of hate crimes and violence towards African Americans, Latinos, Arabs, American Sikhs, American Muslims, and other communities of color, creating fearful and unstable communities: and

WHEREAS, The national "Take on Hate" campaign calls upon all Americans to address the current climate of fear, hate, and prejudice towards African Americans, Latinos, Arabs, American Sikhs, American Muslims, and other communities of color by elevating the voice of peace, unity, and love; and

WHEREAS, Public servants have an even greater responsibility to speak out against discrimination, xenophobia, and hatred because when the unacceptable becomes the norm in our society, human rights for all are threatened; and

WHEREAS, April 19, 2016 is a day to "Take on Hate" to inspire a movement to restore our American values that all Americans deserve to live free of bigotry, hate, and violence, in order to build an even better United States of America: and

WHEREAS, The national "Take on Hate" campaign is a movement that promotes positive images of African Americans, Latinos, Arabs, American Sikhs, American Muslims, and other communities of color; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we endorse the mission of "Day to Take on Hate" on April 19, 2016 to protect all of Illinois' residents, families, and communities no matter their faith, nationality, or ethnicity, and that we are proud to stand with all Americans, regardless of their ethnicity or faith against those who preach hate and incite violence; and be it further

- (a) Recognizing the need to review performance standards governing the professionalism of law enforcement agencies and officers in the 21st century, the General Assembly hereby creates the Commission on Police Professionalism.
- (b) The Commission on <u>Police</u> Policing Standards and Professionalism shall be composed of the following members:
 - (1) one member of the Senate appointed by the President of the Senate;
 - (2) one member of the Senate appointed by the Senate Minority Leader;
 - (3) one member of the House of Representatives appointed by the Speaker of the House of Representatives;
 - (4) one member of the House of Representatives appointed by the House Minority Leader;
 - (5) one active duty law enforcement officer who is a member of a certified collective bargaining unit appointed by the Governor;
 - (6) one active duty law enforcement officer who is a member of a certified collective bargaining unit appointed by the President of the Senate;
 - (7) one active duty law enforcement officer who is a member of a certified collective bargaining unit appointed by the Senate Minority Leader;
 - (8) one active duty law enforcement officer who is a member of a certified collective bargaining unit appointed by the Speaker of the House of Representatives;
 - (9) one active duty law enforcement officer who is a member of a certified collective bargaining unit appointed by the House Minority Leader;
 - (10) the Director of State Police, or his or her designee;
 - (11) the Executive Director of the Law Enforcement Training Standards Board, or his or her designee;
 - (12) the Director of a statewide organization representing Illinois sheriffs;
 - (13) the Director of a statewide organization representing Illinois chiefs of police:
 - (14) the Director of a statewide fraternal organization representing sworn law enforcement officers in this State;
 - (15) the Director of a benevolent association representing sworn police officers in this State:
 - (16) the Director of a fraternal organization representing sworn law enforcement

officers within the City of Chicago; and

(17) the Director of a fraternal organization exclusively representing sworn Illinois State Police officers.

- (c) The President of the Senate and the Speaker of the House of Representatives shall each appoint a joint chairperson to the Commission. The Law Enforcement Training Standards Board shall provide administrative support to the Commission.
- (d) The Commission shall meet regularly to review the current training and certification process for law enforcement officers, review the duties of the various types of law enforcement officers, including auxiliary officers, review the standards for the issuance of badges, shields, and other police and agency identification, and examine whether law enforcement officers should be licensed. For the purposes of this subsection (d), "badge" means an officer's department issued identification number associated with his or her position as a police officer with that Department.
- (e) The Commission shall submit a report of its findings and legislative recommendations to the General Assembly and Governor on or before September 30 March 31, 2016.
 - (f) This Section is repealed on October April 1, 2016.
 - (g) The General Assembly finds and declares that:
- (1) this amendatory Act of the 99th General Assembly manifests the intention of the General Assembly to extend the repeal of this Section and have this Section continue in effect until October 1, 2016; and
- (2) any construction of this Section that results in the repeal of this Section on March 31, 2016 would be inconsistent with the manifest intent of the General Assembly.

It is hereby declared to be the intent of the General Assembly that this Section not be subject to repeal on March 31, 2016.

This Section shall be deemed to have been in continuous effect since August 12, 2015 (the effective date of Public Act 99-352), and it shall continue to be in effect henceforward until it is otherwise lawfully repealed. All previously enacted amendments to this Section taking effect on or after March 31, 2016 are hereby validated. All actions taken in reliance on or pursuant to this Section by the Commission or any other person or entity are hereby validated.

In order to ensure the continuing effectiveness of this Section, it is set forth in full and reenacted by this amendatory Act of the 99th General Assembly. This reenactment is intended as a continuation of this Section. It is not intended to supersede any amendment to this Section that is enacted by the 99th General Assembly.

This Section applies to all actions made on or before the effective date of this amendatory Act of the 99th General Assembly.

WHEREAS, Heterotaxy syndrome is a disorder that results in certain organs forming on the opposite side of the body; Heterotaxy has been known to affect the development of the heart, liver, lungs, intestines, and spleen; and

WHEREAS, Babies with Heterotaxy syndrome are usually first identified because they have structural problems with their hearts or livers; 4 out of every 1,000,000 babies born will have Heterotaxy syndrome; and

WHEREAS, Babies with Heterotaxy can have symptoms that start shortly after birth, including a blue color to the skin (cyanosis), poor feeding habits, fast breathing, increased sweating when they eat, or poor weight gain; all of these symptoms can indicate heart failure in the baby; other symptoms include heart murmurs, biliary atresia, intestinal blockage, no spleen (asplenia), and many little spleens (polysplenia); and

WHEREAS, The exact cause of Heterotaxy is not known, but the symptoms result from the way that the internal organs turn into position during fetal development; this rotation can be affected by many different factors, including infection, genetics, or exposure to certain chemicals; and

WHEREAS, The use of echocardiograms, electrocardiograms, and x-rays, among other medical diagnostic tools, can ensure a timely and accurate diagnosis of Heterotaxy syndrome; the use of medication and surgical procedures can then be used to help treat the syndrome; and

WHEREAS, Without corrective surgery, most children with Heterotaxy syndrome and significant heart problems will not survive beyond the first year of life; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate May 4, 2016 as Heterotaxy Awareness Day in the State of Illinois in order to bring attention to this disorder and the efforts of many to treat this serious problem.
