Mr. President -- I am directed to inform the Senate that the House of Representatives has adopted the following joint resolution, in the adoption of which I am instructed to ask the concurrence of the Senate, to-wit:

HOUSE JOINT RESOLUTION NO. 127

WHEREAS, English Learners make up 10.3% of Illinois' student population; and

WHEREAS, Over the past two decades, the number of children in the United States living with immigrant parents grew 60% and accounted for 25% of children under the age of 18; and

WHEREAS, Immigrant families who speak a home language other than English should be considered to be powerful assets in their children's education and partners with a shared responsibility for student learning and achievement; and

WHEREAS, Research consistently demonstrates that family engagement is one of the most significant factors in supporting student academic success; and

WHEREAS, The State should help ensure that each school district is able to meet its obligations to provide equitable access for students and families of all linguistic backgrounds; and

WHEREAS, There are currently no professional certification standards for foreign language interpreters in public schools; and

WHEREAS, Developing a training and certification program and establishing minimum standards for individuals providing foreign language interpretation services in schools will help students reach their full academic potential; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the Bilingual Advisory Task Force, created by House Joint Resolution 36 of the 99th General Assembly, shall also study the feasibility of professional certification standards for foreign language educational interpreters in public schools; and be it further

RESOLVED, That should the Task Force deem certification standards feasible, those certification standards shall help ensure that interpreters serving school districts have demonstrated the core competencies of fluency, methodology, and ethics of interpretation and translation; and be it further

RESOLVED, That if the Task Force determines that certification standards are needed, it shall recommend procedures for school districts pertaining to when and how to access a language interpreter; and be it further

RESOLVED, That the Task Force may examine the process for certifying educational interpreters for students and parents who are deaf and may recommend a similar process for foreign language interpreters; and be it further

RESOLVED, That two additional members shall be added to the Task Force, to be appointed by the State Superintendent of Education, one of whom shall be the president of a community college, and one of whom shall be an assistant principal in the Chicago public schools; and be it further

RESOLVED, That the Task Force's deadline for submitting its findings and recommendations to the Governor and General Assembly is changed from December 15, 2015 to December 15, 2016, in order to give the Task Force adequate time to complete its work; and be it further

RESOLVED, That a copy of this resolution shall be transmitted to the State Superintendent of Education.

WHEREAS, There are a significant number of non-citizen veterans of foreign wars, including World War II, the Korean War, the Vietnam War, the Gulf War, the Iraq War, and the Afghanistan War, who have been removed from the United States; and

WHEREAS, When these veterans returned to civilian life without appropriate support in reintegration, both psychologically and economically, they fell into addictions and criminal activities, were arrested and, due to their non-citizen resident status, were deported; and

WHEREAS, Many of these veterans live in terrible and abject conditions after having served in the Armed Forces of the United States; and

WHEREAS, Several of these veterans have asked for support in obtaining reentry into the United States to be with their families and United States citizen children; and

WHEREAS, Non-citizens compose a significant portion of the Armed Forces, enlisting more than 8,000 persons annually; and

WHEREAS, According to the Department of Defense, more than 65,000 non-citizen immigrants were serving in the United States Armed Forces as of 2008, accounting for at least 5% of the total active-duty personnel; and

WHEREAS, The Immigration Reform Act of 1996 broadened the criteria for removable offenses to include shoplifting, misdemeanor drug offenses, and other minor offenses, allowing the Department of Homeland Security to quietly deport veterans who have fallen on hard times; and

WHEREAS, According to Banished Veterans, a support group for deported veterans, there are currently 3,000 veterans in immigration detention centers or in removal proceedings at any given time; and

WHEREAS, Veterans that have been deported do not have access to Veterans Affairs benefits or other benefits designed for veterans; and

WHEREAS, The nation owes these veterans adequate support and rehabilitation equal to that of veterans with full citizenship; and

WHEREAS, After having served time for their crimes in the criminal justice system, non-citizen veterans are almost immediately dropped at the doorsteps of their country of birth with no resources, no contacts and, at times, no knowledge of the language, resulting in compounded punishment; and

WHEREAS, These valiant veterans are solely allowed reentry into the United States posthumously for their burial in a United States military cemetery; and

WHEREAS, Members of the United States Congress are calling for an end to the deportation of noncitizen military veterans and United States Representative Ruben Gallego has introduced H.R. 5012, the Restoring Respect for Immigrant Service in Uniform Act; and

WHEREAS, The Restoring Respect for Immigrant Service in Uniform Act urges the Department of Homeland Security to readmit veterans who have been deported and have not committed a serious crime, therefore reuniting deported veterans with their families; and

WHEREAS, The Restoring Respect for Immigrant Service in Uniform Act prevents the deportation of veterans who have served in the military at least six months and have not committed a felony or significant misdemeanor; and

WHEREAS, The State of Illinois recognizes the importance and need for equitable treatment of veterans; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we support the Restoring Respect for Immigrant Service in Uniform Act and urge the members of the United States Congress to pass H.R. 5012; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the members of the Illinois congressional delegation.

"Seed library" means a nonprofit, governmental, or cooperative organization, association, or activity for the purpose of facilitating the donation, exchange, preservation, and dissemination of seeds of open pollinated, public domain plant varieties by or among its members or members of the public when the use, exchange, transfer, or possession of seeds acquired by or from the seed library is free of charge or consideration.

(505 ILCS 110/2.133-5 new)

Sec. 2.133-5. Seed swap event. "Seed swap event" means an organized and publicly promoted event at which non-commercial seed sharing takes place.

(505 ILCS 110/7) (from Ch. 5, par. 407)

Sec. 7. Exemptions.

(a) The provisions of Sections 4 through 4.5 and Sections 5 and 5.1 do not apply:

- (1) To seed or grain not intended for sowing purposes.
- (2) To seed in storage in, or being transported or consigned to a cleaning or conditioning establishment for cleaning or conditioning, provided, that the invoice or labeling accompanying any shipment of said seed bears the statement "seed for conditioning": and provided that

accompanying any shipment of said seed bears the statement "seed for conditioning"; and provided that any labeling or other representation which may be made with respect to the uncleaned or unconditioned seed shall be subject to this Act.

- (3) To any carrier in respect to any seed transported or delivered for transportation in
- the ordinary course of its business as a carrier; provided, that such carrier is not engaged in producing, processing, or marketing agricultural, vegetable or other seeds designated by the Department of Agriculture subject to the provisions of this Act.
- (b) The provisions of Sections 4, 4.4, 4.5, 6, and 10, and of paragraphs (1), (2), (3), (4), (5), (8), and (11) of Section 5, do not apply to unpatented, untreated seed that is free of noxious and exotic weed seeds and that is distributed within this State by means of interpersonal non-commercial seed sharing activities, including, but not limited to, seed libraries and seed swap events. A seed library or seed swap event organizer shall adopt labeling or record-keeping standards to identify the year, species or common name, and source of any non-commercially packaged seed received by the seed library or offered at a seed swap event, and shall make this information available to the Department upon request in the course of an investigation of an alleged violation of the provisions in this Act. Information maintained by seed libraries shall be provided to the Department to the extent permissible under the Library Records Confidentiality Act.
