What that means is that over a forty-year career, African American women lose over four hundred thousand dollars of potential income. For Latino women, that is nearly a million dollars that they lose over the course of their working lives. There are a lot of different things that move into this, including gender discrimination and outright sexism and moving in and out of the workplace to take care of family and children and all the things that are unique to happen -- women across certain sectors.
