This bill provides that a petitioner in a foreclosure proceeding is required to inform the alderman where the property is located and to file an affidavit attesting to the fact that notice was provided or risk having the foreclosure action stayed until the petitioner complies. If the alderman is not notified, the proceeding is stayed. The petitioner must comply with the notice requirement and submit proof of -- of delivery to the court before the court lifts the stay. I know of no opposition at this time. I'd ask for your Yes votes.
